The Nebraska Department of Transportation says a Johnston, Iowa construction company has been selected to build a new bridge over the Little Blue Riveralong Nebraska Highway 8 and 15. United Contractors Inc. will be removing the old bridge, building a new structure, doing grading and concrete paving, installing guardrail and seeding the area. Traffic will be maintained with one-lane closures handled in phases, and temporary traffic signals will be used during the construction of the new bridge. A 12-foot width restriction will be in effect. NDOT expects the project to be completed in December of 2024.

The state of Nebraska issued a health alert Friday for Kirkman's Cove Lake in Richardson County. Samples taken earlier last week at the lake measured above the threshold of 8 parts per billion (ppb) of total microcystina toxin released by certain strains of blue-green algae. Caution signs are posted and designated swimming beaches are closed during such alerts.

Before the meeting began, commissioner Mark Schoenrock explained the commissioners' devotion to quality ambulance services as members of the department filled the room to attend the meeting. The meeting included a briefing from Ryan Hamburger, CEO of South Central EMS, from Fillmore County. One of the points of emphasis for Hamburger was the importance of reimbursement.

On Tuesday afternoon, a man walked into Heartland Bank in Geneva and presented a note to the teller asking for money and said "this is for real, give me your money." The man then fled the bank with a "significant amount" of cash. The man then left in a dark colored Chevy Traverse, last seen at 8th and G streets in Geneva heading west. He is described as having a stocky build, about 5'8" tall, partial round chin with a beard and mustache. He was wearing a black shirt, glasses, and a tannish/orange baseball hat. The incident is under investigation by the FBI and the Fillmore County Sheriff's department. Anyone with information on the identity of the suspect is asked to contact the Lincoln, Nebraska FBI, the Fillmore County Sheriff, Nebraska State Patrol, or your local law enforcement agency.

District Court Judge Rick Schreiner says the work includes a new sound system, TV monitors for the gallery, counsel tables and the judge's bench along with a control module the judge has access to.

The suspect allegedly uses the name of an on duty officer and may have background information on those they call. The sheriff's office warns to not make any payments for any reason and to hang up and call Southeast Communications to be connected to an on duty officer.

The online applications will be processed in the order they are received during normal business hours beginning Monday, July 31, 2023. Persons must have a permit to harvest hay on State Right of Way. Hay harvesting permits may be purchased online from July 30th through September 15th on a first-come, first-served basis. Each permit covers up to five miles of roadside hay for private use only and only one permit is allowed per person.

The 100% fiber-optic network will have a groundbreaking ceremony with Crete's mayor and city officials. This will be held at 9:30 a.m. at Crete City Hall. This project starts after working closely with the city to complete the necessary agreements, and ALLO has partnered with local contractors to build the fiber-optic network. The press release said that teams will starting constructing ALLO's fiber infrastructure throughout Crete. Residents and businesses will get an advanced notice of necessary work in yards and easements through the mail. ALLO teams may also knock on doors to explain the process and answer any guestions.

When the permit for the Milligan 1 project was approved in Saline County in October of 2016, there was no wind turbine noise limit that applied to utility-grade projects in the countynot until July, of 2021. Attorneys for the wind farm contend the Saline County Board of Adjustment used a "meritless citizen complaint to invent and enforce a sound limit that was not a part of its original conditional permit". They say the county's zoning administrator said the wind farm received its permit before there was any sound limitand that the wind farm has continued to operate legally.
