A man has been charged with violating the state's "Safer at Home" order after being arrested for allegedly meeting who he believed to be a minor for sex, but was actually a police officer.

Matthew Wieting, 34, of Brillion, was charged with using a computer to facilitate a sex crime, soliciting an intimate representation from a minor, and violating a health order. Wieting made his initial appearance Wednesday in Outagamie County Court, where a \$10,000 cash bond was set.

An officer was online undercover as a 15-year-old girl and had contact with Wieting for about a month. A meeting was arranged in Kimberly, and he was arrested Tuesday afternoon, Stahmann said. Charges were filed Wednesday.

According to the criminal complaint, Wieting planned to meet the girl at her house Tuesday morning for sex. He admitted to police why he was there.

If convicted of violating the public health order, Wieting faces up to 30 days in jail and a \$500 fine.

He returns to court April 15 for a status conference.

BRIEF OUTLINE OF NEWS STORY: INVESTIGATIONS OPENED ON COVID-19 HOTSPOTS IN WISCONSIN.

EXHIBIT, IF AVAILABLE: The number of positive COVID-19 cases in Brown County and Oneida Nation jumped to 856 Monday as more results came in from outbreaks linked to food plants in the area.

The countywide total increased by about 230 positive cases from Friday to Monday. Brown County Public Health says 255 JBS employees have tested positive for COVID-19. On Friday, that number was 189.

JBS announced Sunday that it had temporarily closed the plant on Lime Kiln Road due to the outbreak. It was a decision made by the company, according to health officials.

"We will not operate a facility if we do not believe it is safe or if absenteeism levels result in our inability to safely operate. The health and safety of our team members remains our number one priority. The Green Bay facility is open and operational, though production capacity has been reduced," reads a statement from JBS.

In other outbreaks, American Foods Group in Green Bay has 130 employees who have tested positive for COVID-19.

Sausage maker Salm Partners in Demark has 17 employees with positive tests.

BRIEF OUTLINE OF NEWS STORY: EPA AWARDS GRANTS TO BRILLION AND GREEN BAY TO CLEAN UP 'BROWNFIELDS'.

EXHIBIT, IF AVAILABLE: Two Northeast Wisconsin cities will receive Brownfield Grants from the Environmental Protection Agency.

According to the EPA, Brownfield sites are contaminated sites that could be redeveloped.

The City of Green Bay has received \$800,000 for nine sites that include a power plant, salvage yard, and metal plating facility – all located within federally designated floodplains.

"With EPA's support, the City of Green Bay is now better equipped to facilitate the remediation and redevelopment of brownfields across our city," said Mayor Eric Genrich, City of Green Bay.

The City of Brillion was awarded \$500,000 for the Brillion Iron Works site that has been apart of the community since 1890. Brillion Iron Works closed in 2016 after serving as a foundry and manufacturer of farm implements. According to the EPA, the area is contaminated with hazardous substances, including polycyclic aromatic hydrocarbons, volatile organic compounds, and metals.

EXHIBIT, IF AVAILABLE: A Kewaunee woman is facing charges after she allegedly stole from her employer and filed fraudulent tax returns.

Karen Schwind worked as the bookkeeper for a Kiel area business.

Schwind was charged with two counts of fraud

According to the criminal complaint, Schwind altered QuickBooks records to make it appear as though a legitimate vendor had been paid when, in fact, the check was made payable to Schwind.

The complaint also states that Schwind failed to report the income she embezzled from her employer during 2018 and 2019 on her income tax returns. Schwind embezzled over \$62,000 during 2018 and 2019 and evaded \$3,297 in taxes.

Charges were filed on April 28, 2020 by the Kewaunee County District Attorney's Office after an investigation by the City of Kiel Police Department and the Wisconsin Department of Revenue's Office of Criminal Investigation.

If convicted of all charges, Schwind could face up to 12 years in prison, \$20,000 in fines, or both.

EXHIBIT, IF AVAILABLE: A cheese plant in Chilton is closing due to "significant challenges" at the facility.

Foremost Farms USA informed the Wisconsin Department of Workforce Development that it planned to permanently close the Chilton Facility, W3286 County Road F. The decision impacts 50 employees.

Layoffs are scheduled for July 17.

"We regret to inform you that Foremost Farms USA's business operations have been facing significant challenges from a plant layout, infrastructure, and building and equipment age perspective at its Chilton facility. In addition, work order volumes from clients have significantly decreased in a short period due to COVID-19, creating overcapacity of product and a significant and sudden drop in demand for production," reads a letter provided to DWD.

The letter says Foremost Farms "will ensure that all employees be paid all earned wages and agreed upon benefits at the time of their termination."

"This is not a reflection on our employees in Chilton. This is a business decision that has nothing to do with their performance, which has been excellent. We are committed to treating our employees with respect and dignity and will be working with them through this transition," said Greg Schlafer, President & CEO.
