WVAZ provides its listeners with programming and public service announcements that address issues of concern to our local community. Among the issues determined to be of most concern to the community during the preceding calendar quarter were:

- **Careers/ Health :** Herb Kent- Reflected on his 68 years in radio and TV. He offered career advice to persons hoping to become broadcasters. Dr. Lamar Hasbrouke- Explained what his office is doing to fight Ebola. He defined what Ebola is and detailed the most practical way to combat it.
- **Civil Rights, Crime, Health Employment:** Jonathan Jackson- National spokesman for the Rainbow Push coalition gave the organizations position on the fatal police shooting of Michael Brown in Ferguson, Missouri. Marc Morial- National Director of the National Urban League detailed a \$2 Million endowment to the Chicago Chapter for job creation programs. Jamilliah Ali-Joyce- of the IL. Secretary of State's office and daughter of Muhammad Ali. She gave insight on her Father's battle against Parkinsons disease. We also discussed her father's historic image as a world-wide role model.
