Dear Lew,

On behalf of CC Licenses, LLC, licensee of WVON(AM), Berwyn, IL (Fac ID 87178) and the six other commonly-owned stations in the Chicago, IL station employment unit (the "SEU"), I am writing to request an exemption from the requirements outlined in your February 6, 2015 Audit Letter based on the fact that the SEU is currently subject to reporting conditions ordered in the Commission's Notice of Apparent Liability for Forfeiture for violation of the FCC's EEO rules. *See In the Matter of AMFM Broadcasting Licenses, LLC, Licensee of Stations WNUA(FM), Chicago, IL, WGCI-FM, Chicago, IL, WKSC-FM, Chicago, IL, WGRB(AM), Chicago, IL, WLIT-FM, Chicago, IL, WVAZ(FM), Oak Park, IL, Notice of Apparent Liability for Forfeiture, 28 FCC Rcd. 16457 (MB 2013).* The Commission reviewed the SEU's 2014 EEO Public File Report and supporting documentation and found it satisfactory. *See Letter from Lewis Pulley, Assistant Chief, Policy Division to Elizabeth E. Goldin, Esquire* (dated Nov. 3, 2014). The SEU is due to submit its 2015 EEO Public File Report and associated records this September 1 as well.
