Appeals court upholds decision that keeps marker

FARGO, N.D. (AP) - An appeals court has upheld a federal judge's decision allowing a Ten Commandments monument to remain on city property in downtown Fargo.

The Red River Freethinkers group filed a lawsuit alleging that the city gave the monument a religious purpose in voting more than five years ago to keep it. A judge dismissed the suit after the city argued that the complaint had no merit.

A three-judge panel of the 8th U.S. Circuit Court of Appeals upheld the ruling in a decision released Monday.

The monument was donated to the city in 1958, to commemorate an urban renewal project. It was installed on its current site near the Fargo Civic Auditorium in 1961.

City commissioners originally voted to relocate the marker but decided to keep it after complaints from citizens.

## **Signs Work Session**

8-19-14

The work session on signs for Fergus Falls City Council resulted in one small change in policy. The words "per sign" were taken out so it now reads "The annual temporary sign permit \$50 will be required by the sign owner/operator."

The change was given a first reading at the council meeting following the work session.

The city also plans to do a better job in communicating that signs cannot be placed in the boulevard. They have been confiscating rummage sale signs that were improperly placed, prompting many phone calls to city hall. Per state statute, signs cannot be placed in the right of way of all roads including city streets. They also cannot be placed on trees or utility poles.

### **Third City Deer Hunt to be Held in Fergus Falls**

There will be another city deer hunt in Fergus Falls this Fall. Hunters are selected by a lottery and must pass a proficiency test. The hunt is conducted only on certain city owned property. Hunters pay a city permit fee of \$20 in addition to the DNR license requirements. They must obey all state hunting regulations plus the city rules. This is the third year the city has offered the special hunt. The hunt was started after a council member noted an increasing number of vehicles hitting deer within the city limits. Applications are available on the Fergus Falls City website; they can also be picked up at the police department. A bow hunt map is also on the website. Applications need to be turned in by August 15<sup>th</sup>.

## **Property taxes decline in Minnesota**

7-22-14

Property Taxes will be going down and homeowners will see the biggest decrease in Minnesota. Overall, homeowner property taxes are going down by \$171 million this year, a 5.2 percent drop from 2013. For the last 12 years, Minnesotans saw an average annual increase of 5.7 percent in the property taxes after refunds each year. Property tax levies, excluding refunds, have increased by \$124 million, but \$75 million of that increase comes from new construction/property for homestead and businesses, a release from the Minnesota House DFL Caucus states.

For 2014, homeowners, renters and farmers will see \$45 million in additional direct tax relief. More than half a million homeowners will see an average 3 percent increase in their homestead property tax refunds, and about 350,000 renters will see an average 6 percent increase in renter property tax credit.

## **Sign Fee Not Waived for Classic Car Club**

In NW Minnesota, plucky challenger for Peterson

FERGUS FALLS, Minn. (AP) - The man Republicans hope will give longtime Representative Collin Peterson a legitimate challenge in Minnesota's massive 7th District can't see his constituents from across the room, but they can sure see him.

State Senator Torrey Westrom lost his sight at age 14 in a car accident on his family's western Minnesota dairy farm. But Westrom is a big man with a commanding presence when he works a room, and he hasn't lost an election in nearly 20 years as a politician.

Westrom says 24 years for Peterson is long enough. And national Republicans are pouring substantial money into the race for the first time in memory.

Peterson's not sweating it for now. He says most of the people he talks to thank him for advancing the last farm bill.

### **Deputy Protected by Vest near Crookston**

CROOKSTON, Minn. (AP) - Authorities say a northwestern Minnesota sheriff's deputy was saved by his bullet-resistant vest when he was shot by a suspect who was then wounded by police. The state Bureau of Criminal Apprehension says officers answered a 911 call about shots fired inside a home near Crookston just after 1 p.m. yesterday. As deputies spoke with family members outside the home, the suspect began firing at them from inside. A Polk County deputy was struck in the back of his bullet-resistant vest. Shots were exchanged, and the suspect was injured and taken into custody.

### **Absentee Ballots Now Available**

ST. PAUL, Minn. (AP) - Minnesota's early voting window officially opens today. The state expanded its absentee process so people can vote early in-person or by mail without needing a valid excuse for doing so. Officials expect to see an uptick in ballots submitted well in advance of November 4th.

## MNsure

(ALEXANDRIA, Minn.) - Today, Torrey Westrom released the following statement in response to the news that PreferredOne, MNsure's insurer with the most enrollees and the lowest premiums, will not be participating in the Exchange this year:

"This is the latest unfortunate example of why ObamaCare isn't working for Minnesotans, but it certainly will not be the last. Western Minnesotans who lost their health insurance plans last year are bracing for higher premiums, while struggling with fewer and fewer options for health coverage on the table. To make matters worse, 24-year incumbent Collin Peterson quite literally said he won't work to repeal ObamaCare, ~~even though our district and Minnesotans are being negatively impacted~~. We need to repeal this unworkable law, and start over with common sense solutions that increase options for families, not limit them."

PreferredOne, the Golden Valley-based insurer, offered nearly 59 percent of the health insurance plans of the plans available on MNsure, including plans with the lowest premiums. According to KSTP, their move to pull out of the exchange "could signal big rate increases to be unveiled in early October, and that could have a significant impact on the elections."

Foreign policy, tax debate stoke Senate race

 ST. PAUL, Minn. (AP) - The race between Senator Al Franken and Republican challenger Mike McFadden is moving past introductions and into attacks.


McFadden and fellow Republicans this week increased their efforts to tie Franken to President Barack Obama. They're now highlighting the unrest in the Middle East and the president's comments that his administration doesn't yet have a strategy for combating Islamic State extremists. A group of Republicans and veterans criticized Franken's approach to foreign policy at a press conference Friday.

McFadden says Franken has supported foreign policy blunders by Obama at the expense of America's national security.

Meanwhile, Franken's campaign debuted a new ad Friday suggesting McFadden's investment bank moved offshore to pay lower taxes. McFadden's team says the charge isn't accurate.

MINNESOTA GOVERNOR-BUSINESS

Minnesota chamber backs Republican Johnson

 ST. PAUL, Minn. (AP) - Minnesota's Chamber of Commerce on Friday backed Republican Jeff Johnson over Democratic Governor Mark Dayton as the business community at large weighs how big of a role to play in the governor's race.

The decision Friday came after both Johnson and Dayton went before a chamber political committee. Four years ago, Dayton didn't even vie for the nod.

It remains unclear how active a role the chamber and other prominent business groups will have in the governor campaign. In 2010, business entities put more than \$1.3 million into a television campaign aimed at stopping Dayton.

Johnson emerges to take GOP governor primary

 MINNEAPOLIS (AP) - Hennepin County commissioner Jeff Johnson has captured the Republican nomination for Minnesota governor over three major rivals.


Tuesday's victory means Johnson advances to a fall showdown with Democratic Gov. Mark Dayton. It's also a validation for the Republican Party, which endorsed Johnson this spring before what turned into the party's first competitive primary for governor in 20 years.

Johnson beat former House Speaker Kurt Zellers, business executive Scott Honour and former House Minority Leader Marty Seifert (SY'-furt). Johnson benefited from the phone calls, canvassing and other outreach that came with party support and helped make up for better fundraising by some of his rivals.

It is Johnson's second bid for statewide office. He lost in a 2006 campaign for attorney general. He has previously served in the Legislature.

MINNESOTA PRIMARY-SENATE-GOP

McFadden wins Minnesota GOP Senate primary

 MINNESOTA (AP) - Businessman Mike McFadden has won Minnesota's Republican Senate primary and will take on Sen. Al Franken in November.

McFadden defeated retiring state Rep. Jim Abeler and several lesser-known candidates in Tuesday's primary.

A political newcomer, McFadden was the front-runner after he was endorsed at the party convention in April. He argued he was the only candidate who could raise enough money to beat Franken. He criticized the first-term senator as being too close to Obama and for his support of the president's health care overhaul.

Outside political groups are starting to look at the Minnesota race as Republicans hope to win back control of the U.S. Senate. The U.S. Chamber of Commerce promised aggressive spending on behalf of McFadden even before Tuesday's primary. Democrat-aligned groups have not yet poured much money into Minnesota.

MINNEAPOLIS (AP) - Jeff Johnson's primary opponents say they're lining up behind the GOP's nominee for governor in hopes of unseating Democratic Gov. Mark Dayton this fall.

Johnson beat former House Speaker Kurt Zellers, former House Majority Leader Marty Seifert and businessman Scott Honour Tuesday to capture the GOP nomination, starting a 12-week sprint to the general election. The four candidates held a joint press conference Wednesday.

Johnson says he'll wrap pieces of his primary challengers' campaigns into his own pitch against Dayton - Zellers' firm stance against tax increases, Honour's "cut no corners" approach and Seifert's rural Minnesota roots.

Democrats immediately struck out against Johnson, branding him as an extremist and friend of the Tea Party who will drag Minnesota backward if elected.

Dalrymple says Wall was an "outstanding legislator" and a "kind and thoughtful person."

Judge likely to release CT results in Kolstad case

MANKATO, Minn. (AP) - A judge likely will allow the attorney for former Minnesota Gophers quarterback Philip Nelson to have access to brain scans of the former football player Nelson is accused of assaulting.

A motion hearing was held Monday for Nelson. The 20-year-old is charged with first-degree assault after a confrontation with former Minnesota State, Mankato, football player Isaac Kolstad in downtown Mankato May 11. Nelson is accused of kicking Kolstad after Kolstad was punched during an altercation.

Nelson's attorney, Jim Fleming, wants 11 CT scans that were taken at Mayo Clinic Health Systems in Mankato between May 11 and May 20. Fleming says he needs the medical records to prepare Nelson's defense.

★ ST. PAUL, Minn. (AP) - A Republican candidate for Minnesota governor is recovering after emergency surgery to repair a small perforation in his stomach.

Hennepin County Commissioner Jeff Johnson was resting after a successful procedure on Monday afternoon at Maple Grove Hospital. Johnson checked himself into the hospital earlier Monday.

Scot Crockett, his campaign manager, says Johnson will remain hospitalized "for a short period of time." Crockett could not elaborate on

Accelerants fuel duplex fire, 2 rescued

ST. PAUL, Minn. (AP) - Two brothers were rescued from the upper floor of a St. Paul duplex in a fire that was fueled by cylinders of gas, oxygen and other accelerants.

Authorities say the two were taken to Regions Hospital where one man is in critical condition and the other in serious condition.

Fire officials tell the St. Paul Pioneer Press (<http://bit.ly/1o0Wfr6>) that back of the duplex and a nearby garage were engulfed in flames when firefighters arrived early Monday. Flammables in the garage set off small explosions as the fire burned. Firefighters found an exploded gas cylinder across the street from the duplex.

Early snapshot of 2015 MNSure premiums coming up



MINNEAPOLIS (AP) - The state Commerce Department is preparing to release an early snapshot of 2015 premiums for policies sold on Minnesota's health insurance exchange, MNSure.

Spokeswoman Anne O'Connor says the department will most likely release the data this week.

It should give Minnesota consumers an idea of how much their insurance will cost next year, how the state's rates will stack up against the rest of the country, and whether any new health plans will offer policies through MNSure.

Many individuals who bought policies from private insurers on the exchange likely will pay more next year given that the largest and cheapest carrier, PreferredOne, abruptly pulled out of MNSure this month. But competition among other carriers could help limit any increases.

Open enrollment begins November 15th.

## ISLAMIC STATE-AMERICANS-MINNESOTA

Minnesota Somalis condemn Islamic State recruiting

MINNEAPOLIS (AP) - Members of Minnesota's large Somali community are condemning the recruitment of youth by terrorist groups and urging collaboration to address the problem.

About 100 people attended a town hall meeting Sunday to denounce groups such as the Islamic State and al-Shabab, which together have recruited more than two dozen fighters from Minnesota.

The Minneapolis-St. Paul area is part of a pilot program to combat terror recruiting in the U.S.

U.S. Attorney Andy Luger said Boston and Los Angeles are part of the national pilot program. He told Sunday's crowd of people his ideas to Washington to find ways to address the root causes of terrorism.

Meeting organizers have long-advocated for a federal law to ban recruitment of U.S. citizens to fight in foreign conflicts.

MNsurre CEO: help coming for PreferredOne customers

ST. PAUL, Minn. (AP) - The chief executive of Minnesota's health insurance exchange says help will be available for consumers as its largest carrier pulls out.

MNsurre CEO Scott Leitz told the exchange board Wednesday he's disappointed PreferredOne won't offer new coverage when open enrollment begins Nov. 15, but four other Minnesota-based carriers will continue to do so.

He says MNsurre plans to conduct targeted outreach efforts for current PreferredOne enrollees to help them pick new plans for 2015.

While PreferredOne customers can keep their current plans, their premiums could be higher next year. And those customers who now get tax credits to defray the costs will need to switch carriers to keep them.

PreferredOne grabbed 59 percent of all private-plan enrollees in MNsurre's inaugural year by offering low premiums, but now says that's unsustainable.

Dayton apologizes for troubled MNSure rollout

ALEXANDRIA, Minn. (AP) - Governor Mark Dayton is apologizing for the troubled rollout of Minnesota's online health insurance exchange.

Dayton on Wednesday called the initial glitches with MNSure the single biggest disappointment of his first term.

But the Star Tribune reports the Democratic governor also defended the federal Affordable Care Act.

Dayton appeared at a general session of the Association of Minnesota Counties held in Alexandria. He thanked county leaders for their help with MNSure.

Dayton's Republican opponent, Hennepin County Commissioner Jeff Johnson, also spoke to the group but did not bring up MNSure.

A spokesman said Johnson would prefer to obtain a federal waiver from the Obama administration that would let Minnesota run its own health care system, but short of that, he would seek major changes to the way MNSure operates.

#### DAYTON-DIVERSION

Dayton: Diversion plan needs better communication

MOOHREAD, Minn. (AP) - Minnesota Governor Mark Dayton says the notion that Minnesota and North Dakota residents upstream from a proposed Red River diversion project are being sacrificed particularly for commercial development in Fargo has some merit.

Dayton has been in the southern Red River Valley talking mainly with upstream opponents who are unhappy the flood control proposal includes a massive holding area that would flood farmland and buildings in times of serious flooding.

Dayton said after Wednesday's meeting in Moorhead that Fargo authorities "pretty much acknowledged" they have rejected the small-town complaints in favor of expanding Fargo, and that has hurt working relationships.

Fargo-Moorhead Diversion Authority Chairman Darrell Vanyo told Dayton during the meeting that the proposal was advanced by the Army Corps of Engineers to protect 200,000 residents, not to spur development.

#### GAS STATION SHOOTING

Still no sign of Minnesota homicide fugitive

PRIOR LAKE, Minn. (AP) - A Minneapolis man accused of fatally shooting his former boyfriend at a gas station last month remains at large after the third day of an intensive manhunt.

The search for 44-year-old Lyle Hoffman shifted from the Anoka County airport in Blaine to Prior Lake Wednesday after a man resembling Hoffman was spotted in and around Mystic Lake Casino.

But the Star Tribune reports authorities say a Chevy TrailBlazer is no longer believed to be connected to Hoffman. Earlier, authorities had said someone in the SUV might have picked Hoffman up.

Hoffman is accused of fatally shooting a business and romantic partner, Kelly Phillips, on August 11th at an Arden Hills gas station. Police say a suspect who held up the TCF Bank in Blaine Sunday closely resembles Hoffman.

MNsure trying to fix 'life event' changes backlog

ST. PAUL, Minn. (AP) - Minnesota's new health insurance exchange is struggling with a backlog of people making changes to coverage through the online marketplace.

State, county and health exchange officials <sup>say</sup> ~~tell the~~ St. Paul Pioneer Press (<http://bit.ly/Z5Rrrc>) the MNsure system has made recording of "life events," including births, marriages and address changes, a slow and difficult process. In Dakota County, it took months for nearly 80 new moms to get their infants added to their insurance.

MNsure plans to hire 15 additional employees to help address a backlog of thousands of changes.

Officials said only a few of those backlog cases are thought to involve babies, and they say exchange and state officials have been getting life events into the system in emergency situations. But they say the system isn't where they want it.

8,000 get false notice of health care cancellation

ST. PAUL, Minn. (AP) - More than 8,000 low-income Minnesotans have received erroneous notices that their health coverage would be temporarily canceled if they don't pay up.

A July 17 notice warned MinnesotaCare subscribers that they faced a four-month coverage lockout if they failed to renew their policy through the state's new health insurance exchange by month's end. The Department of Human Services says their automated reminders drew on part of an old law that locked out subscribers whose coverage lapsed.

That penalty no longer exists, and the department announced the error on Monday.

MinnesotaCare is a state-subsidized health care plan for adults who make too much to enroll in Medicaid but can't afford insurance on their own.

The department says it is sending revised notices to the 8,765 affected subscribers.

This year, five firefighters are being honored. They include Rice Lake Fire Chief Matthew Frantz, who died of an apparent heart attack within 24 hours of responding to a call last December.

The four others being honored are those whose line-of-duty deaths were newly discovered. Their deaths date back as far as 1913.
