CITIZENS CONCERNED ABOUT A COUNCIL RULING TO ALLOW PRIVATE BUSINESSES OPERATE FOR PROFIT PAY EVENTS IN 11 CITY PARKS FOUND OUT ABOUT A LITTLE PUBLICIZED PARKS TASK FORCE BOARD MEETING TODAY AND DECIDED TO GET IN ON THE PROCESS...

(SUOER: JOE HALPERN/CONCERNED CITIZEN) (2385 120730) we think that senior management of the parks department have their own agenda and that they are bound and determined to have a policy adopted that would essentially privatize our parks by making them available to private commercial business on a rental basis for paid admission only events... WHICH HALPERN SAYS WOULD LIMIT ACCESS PEOPLE HAVE IN THEIR FAVORITE PARKS... BUT PARKS STAFF INDICATES THERE HAVE BEEN TEN PUBLIC MEETINGS THAT LED TO OPEN AIR CINEMA LANDING A CONTRACT TO SHOW MOVIES FOR 30 DAYS IN CIVIC CENTER PARK... WHILE THAT CONTRACT HAS ALREADY BEEN AGREED TO... MANY WANT TO AMEND CITY RULES WHICH ALLOW FOR PAY EVENTS... these are desires that people have to use their parks in a new way and although there is a handful of people opposed to this there are more that are in favor and would like to see something like this come about so we are trying to find a balance...

ABOUT 325 COMPLAINTS CAME IN ABOUT CABLE, SATELLITE TV, AND PHONE COMPANIES.

John Suthers/Colorado Attorney General-"Given the volume of business that satellite television does, utilities do things like telephone companies do they're always going to be there. ")

NUTRITIONAL SUPPLEMENT COMPANIES, MAINLY "GNS INC.", GOT 145 COMPLAINTS.

TEETH WHITENING OFFERS FROM "DAZZLE SMILE" DREW 103 COMPLAINTS.

ROUNDING OUT THE TOP TEN; COMPLAINTS ABOUT VACATION HOME RESALES.

John Suthers/Colorado Attorney General-"We keep very close track of complaints and if certain companies are getting an inordinate number of complaints that's where we direct our enforcement priorities.

1. Fire Water Folo - Aired/KWGN - 2/22/10.

ENVIRONMENTAL HAZARDS INVESTIGATOR ADRIENNE ANDERSON SAYS AIR TESTING OVER ONE OF THE BIGGEST NATURAL GAS FIELDS IN TEXAS....REVEALED HIGH LEVELS OF BENZENE.....

"having benzene in the air or water is just a recipe for a public health disaster."

NOW SOME TEXAS FAMILIES WANT TO KNOW IF THE GAS AND OIL DRILLING--IS TO BLAME FOR THEIR ILLNESSES.

Children coming down with leukemia, people coming down with kidney cancers and adrenal cancers."

*UNDERCOVER INVESTIGATIONS BY MEDICAL PROFESSIONALS DISGUISED AS PATIENTS TO COMBAT INSURANCE FRAUD AND WASTE
*AN EXTRA \$50 MILLION DOLLARS IN GRANTS FOR STATES TO FIND WAYS TO RESOLVE MEDICAL MALPRACTICE SUITS
* INCREASING MEDICAID REIMBURSEMENTS FOR DOCTORS
* AND INCLUDING LANGUAGE TO PROVIDE FOR HEALTH SAVINGS ACCOUNTS
TOP DEMOCRATS SAY THEY'RE CONFIDENT LEGISLATION CAN BE PASSED.

THE REPUBLICAN FROM OKLAHOMA SAYS IT'S NOT ENOUGH.
COBURN says: "It's not gonna significantly lower costs and the costs are the problem."

2. DC Health Care Bill Signing - Aired 4-15-2010

THIS IS GOING TO BE A DAY-LONG CELEBRATION FOR THE WHITE HOUSE, BUT NOT ALL OF THE DETAILS ARE HAMMERED OUT YET, AND REPUBLICANS ARE ALREADY TALKING ABOUT A REPEAL.
HOUSE SPEAKER NANCY PELOSI MOVED THE GIANT HEALTH CARE BILL TO ONE SIDE OF THE DESK, SAT DOWN AND THEN SIGNED ON THE DOTTED LINE. LATER THIS MORNING, THE PRESIDENT WILL ADD HIS SIGNATURE....

AND RIGHT AFTER THAT, THE REPUBLICAN ATTORNEYS GENERAL FROM SEVERAL STATES ARE GOING FILE SUIT IN FEDERAL COURT, SAYING CONGRESS OVERSTEPPED ITS BOUNDS.

CUCCINELLI: "The individual mandate on Americans that they must buy health insurance or face penalties overreaches the authority of the Congress under the commerce clause."

THAT COULD BRING HEALTH CARE REFORM TO THE FEET OF THE SUPREME COURT, ALTHOUGH THE WHITE HOUSE DISMISSED THE ENTIRE EFFORT.

GIBBS: my advice from counsel is that we'll win this.

BUT THERE'S ANOTHER FRONT FOR REPUBLICANS.... IN CONGRESS.

AS DEMOCRATS TRY TO START PUSHING THROUGH A SERIES OF HEALTH CARE FIXES TODAY, REPUBLICANS WILL OBJECT, SAYING THAT CUTS IN SOCIAL SECURITY VIOLATE SENATE PROCEDURAL RULES.

BARRASSO: "If you take a look at how it really ought to play out, they should have rejected the reconciliation bill based on this, because it does rob social security money."

REPUBLICANS ALREADY LOST ROUND ONE OF THAT BATTLE. THE SENATE PARLIAMENTARIAN JUST RULED AGAINST THEIR CHALLENGE.

BUT WITH MUCH OF THE PUBLIC STILL STEAMED OVER HEALTH CARE, THE FIGHT WON'T STOP THERE.
