TELEVISION BROADCASTERS. - A candidate meets the requirements of this subparagraph if, in the case of television broadcast, the broadcast includes a personal audio statement by the candidate that identifies the candidate, the office the candidate is seeking, and indicates that the candidate has approved the broadcast.

While there is not a local requirement for this personal audio statement in Guam Code Annotated, it is a Federal requirement to be in all campaign commercials airing on television. This requirement is for all Federal and Local elections. This memorandum is to inform the appropriate campaign official which authorizes the television broadcast of the requirement for the personal audio statement by the candidate.

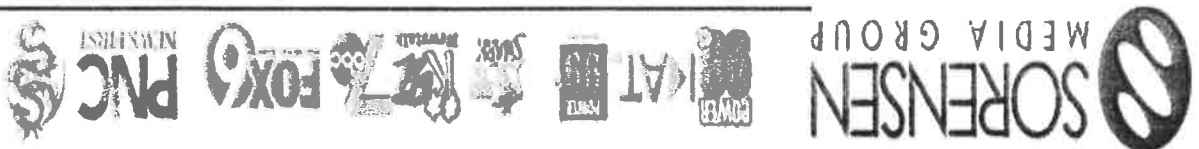
