Television Station WCCU(TV) is licensed to Urbana, Illinois, which is located within the Champaign & Springfield-Decatur DMA. WCCU(TV) therefore will be entitled to elect mandatory carriage on your cable system serving Warren County, Indiana, when the DMA reassignment takes effect in October 2008.

Pursuant to Section 614 of the Communications Act of 1934, as amended, and Section 76.64(f) of the rules of the Federal Communications Commission, this will inform you that, effective October 1, 2008, and for the period from January 1, 2009, to December 31, 2011, Television Station WCCU(TV), Urbana, Illinois, elects mandatory carriage of its television signal pursuant to Section 76.56(b) on your cable system serving Warren County, Indiana, in the Champaign & Springfield-Decatur DMA.
