SMOKERS & CIGARETTES: The sale of cigarettes and other tobacco products at drug stores would be illegal in San Francisco if an ordinance introduced this week by Mayor Gavin Newsom wins approval. The proposed law is designed to curb tobacco sales at stores where pharmacists work, but would not apply to big box businesses such as Costco or to grocery stores. The ordinance is just one of a series of measures supported by the mayor intended to promote healthy living among San Francisco residents, said Newsom spokeswoman Giselle Barry. "The spirit of this is that pharmacies are places people go to get better," she said. "They shouldn't be selling products that cause cancer." The legislation, introduced, would take effect on Oct. 1 if the Board of Supervisors approves it. The Department of Public Health, which already regulates tobacco sales in San Francisco, would enforce the law. Violators would face fines of \$100 to \$1,000.

### AUTISM AND VACCINES

AUTISMO & VACCINES: For the second time this year, families claiming that vaccinations triggered autism in their young children will head to a federal court to determine whether they are eligible to collect damages from the government. A federal court has begun hearing the case of two boys who their families say developed autism after receiving vaccines containing thimerosal.(ABC News Photo Illustration) The case, which begins today, offers two 10-year-old boys from Portland, Ore. - William Mead and Jordan King - as test cases for the theory that thimerosal-containing vaccines, on their own, cause autism. Lawyers for these families maintain that the boys were developing normally until they were exposed to vaccines containing thimerosal, preservative containing mercury. After receiving these vaccinations, the attorneys say, the boys began to show symptoms of autism - a developmental disability characterized by difficulty in communicating and interacting with others.

Uninsured Rates: The number of uninsured young adults in the United States rose to 13.7 million in 2006--an increase from 13.3 million in 2005--making the 19-to-29 age group one of the largest and fastest-growing segments of the population without health insurance. According to a newly updated report from The Commonwealth Fund, 38 percent of high school graduates who do not attend college and 34 percent of college graduates will spend some time uninsured in the year after graduation.

### **BUDGET CRISIS**

Budget Crisis: Health and welfare programs were among the hardest hit. The governor has proposed cuts in health care for the poor, recent immigrants and disabled residents. But his budget is centered on borrowing money against future revenue from the state lottery, which voters approved in 1984 to help fund education. While other states have enacted or considered leasing, selling or creating a quasi-public entity to operate their lotteries, this would be the first time that a state would sell bonds against future lottery revenue. Schwarzenegger wants the state to sell up to \$15 billion in bonds over three years. The new debt would be repaid with interest using profits generated by the state lottery, said Mike Genest, director of Department of Finance. In addition, lottery money spent on public education in the state would be capped at the current level of \$1.2 billion, even if lottery revenue increases.

DELEGATE DISPUTE: The Democratic Party backed a compromise to seat half of the disputed Michigan and Florida delegations Saturday, sparking anger from Hillary Clinton's presidential campaign and a threat to press the issue all theway to the August nominating convention. At a raucous meeting of the party's rules committee, frequently interrupted by cheers and jeers from Clinton's backers, the panel agreed to seat the delegations from both states but cut their voting power in half. The decision was a victory for rival Barack Obama, removing one of the last stumbling blocks on his march to the party's presidential nomination. Obama signaled he supported thecompromise on both state delegations.

Mortgage Fraud Arrest: IN THE HIGHEST-PROFILE CASE YET BROUGHT IN THE COLLAPSE OF THE SUBPRIME LENDING INDUSTRY, AUTHORITIES IN NEW YORK ARRESTED THE TWO FORMER HEDGE FUND MANAGERS ON CHARGES THEY DEFRAUDED INVESTORS BY CONCEALING PROBLEMS THAT LED TO THE \$1.4 BILLION COLLAPSE OF FUNDS EXPOSED TO LOANS. THE DISINTEGRATION OF THEIR TWO FUNDS LAST YEAR HELPED KICK OFF THE CREDIT CRISIS BY STOKING WIDESPREAD FEARS ABOUT INVESTMENTS LINKED TO RISKY SUBPRIME MORTGAGE LOANS. THE U.S. JUSTICE DEPARTMENT SAID THAT THE MORE THAN 400 PEOPLE CHARGED IN A NATIONALLY COORDINATED INVESTIGATION WERE INVOLVED IN MORTGAGE FRAUD THAT LED TO AN ESTIMATED \$1 BILLION IN LOSSES. THE INVESTIGATION LED TO 60 ARRESTS IN TWO DAYS.

The Federal Reserve and other regulators are planning tighter rules to stop credit card companies from unfairly raising interest rates and to make sure they give people enough time to pay their bills. In news releases, the agencies said the proposed rules also would require federal credit unions to give consumers a chance to opt out of an overdraft protection program. And they would prohibit those institutions from charging a fee for an overdraft caused by a hold placed on consumer's funds when a person uses a debit card. The Fed, which is expected to vote Friday afternoon on its approval of the proposed rules, is acting in conjunction with the National Credit Union Administration and the Office of Thrift

Sleeping with your baby in an adult bed is unsafe and can result in accidental smothering of an infant. About 65 deaths per year. These deaths were not classified as Sudden Infant Death Syndrome (SIDS), where the cause of death is undetermined. There were actual causes that were verified upon review of the scene and autopsy. Such causes included accidental smothering by an adult, getting trapped between the mattress and headboard or other furniture, and suffocation on a soft waterbed mattress.

## STRESS AND BABIES

Stress Babies: If an expectant mother is exposed to high levels of stress, her baby may be more likely to develop asthma or allergies later in life, new research suggests. Babies born to mothers experiencing high levels of stress had more IgE in their blood at birth than did babies born to less-stressed moms. IgE is an antibody involved in allergic and asthmatic reactions. "Moms who had elevated levels of stress had children who seemed to be more reactive to allergens, even when exposed to low levels of allergens," said study co-author Dr. Rosalind Wright, an assistant professor of medicine at Brigham and Women's Hospital and Harvard Medical School in Boston.
