Ground system consists of 120 equally spaced buried copper radials 47.3 meters in length about the base of each tower. Intersecting radials shortened and bonded to a transverse copper strap midway between towers. A 7.32 meter X 7.32 meter copper ground screen is bonded to the base of each tower.
