I am writing with respect to the retransmission consent agreement between WPSD-TV, LLC ("WPSD") and DIRECTV, Inc. ("DIRECTV") set forth in the letter agreement between the parties, dated August 18, 2003 (the "Agreement"), which Agreement governs retransmission of the signals of full-power commercial television station WPSD-TV/DT, Paducah, Kentucky (the "Station"), by DIRECTV to subscribers located in the boundaries of the Paducah-Cape Girardeau-Harrisburg television market (the "DMA"), as defined by Nielsen Media Services and in adjacent areas to the DMA as authorized by federal laws and rules.


