#### Quarterly Ascertainment Summary – 1st Quarter 2024

Attached is a report concerning KDRV-TV news stories, local programming, network programming and public service announcements aired during 1st Quarter 2024 pertaining to key issues, as determined by the KDRV-TV Community Relations Department.
