Re: Official Notice of Informal Complaint FCC Ticket No. 3368333

Dear Ms. Kennedy:

This firm is counsel to WPTA License, LLC, licensee of Television Station WPTA, Fort Wayne, Indiana ("WPTA" or the "Station").

This letter responds to the informal complaint submitted to the Federal Communications Commission ("FCC") by Mr. Bob Wilson, pursuant to Sections 713 and 4(i) of the Communications Act, 47 U.S.C. §§ 613, 154(i), and Section 79.1 of the FCC's Rules, 47 C.F.R. § 79.1. This complaint has been assigned Ticket Number 33683333 by your office (the "Complaint").

First, WPTA appreciates when its viewers share their concerns about closed captioning; it is important to WPTA that the Station's programming be accessible to *all* of its viewers.

Second, WPTA values this opportunity to reply to Mr. Wilson's concerns. Mr. Wilson's Complaint appears to specifically address the closed captioning provided in NBC network programming that airs in the overnight period (the Complaint references 11:35p.m. – 5:30a.m. More specifically, the Complaint indicates that

During the overnight hours from roughly 11:35pm until 5am, there has not been any closed captioning for weeks now. Many emails have been sent to the station but the problem has yet to be corrected.

The issue that Mr. Wilson flagged in his Complaint is a technical one that originated from the station's network feed. In brief, the issue was a 708 captioning "glitch" that interfered with the presentation of captioning during certain network programming, and the short-term solution

has been for WPTA to upconvert 608 captions to 708 format, which it has been doing now for a few weeks. WPTA believes that this upconversion (which is a temporary solution and not a permanent one) has resolved the issue for now and that a permanent solution will be implemented soon.

This letter is being emailed to Mr. Wilson at the same time it is being emailed to the Commission's Disability Rights Office. This Response is supported by the attached Declaration and Certification of the licensee's General Manager, which indicates that she has read this letter and that to the best of her knowledge the information is true and correct.
