Dear Sir:

In accordance with Federal Communications Commission ("FCC") Rule 76.64(f) and in accordance with section 614 of the Cable Television Consumer Protection Act of 1992, the referenced television stations listed on Exhibit A (the "Stations") hereby elect must carry status on your Telco systems service for the corresponding designated market areas listed on Exhibit A for the upcoming election period, which begins on January 1, 2018 and ends on December 31, 2020.

The Stations operate on commercial television channels licensed to communities located within the same Designated Market Area as the community (ies) served by your Telco systems service. The Stations do provide a signal of good quality (47 CFR ' 76.55(c) (3)), or are willing to provide equipment for delivery of the necessary signal quality to your system(s) and is not a distant signal under the compulsory copyright license specified in the Copyright Act (17 USC ' 111).

Please note that during this term, the Stations listed on Exhibit A with an asterisk will also be delivering a high-definition signal to your system(s) and shall require carriage of that signal as well, pursuant to the rules set forth above. Please note that Stations, WTBY-TV ((Poughkeepsie, NY, changing to Jersey City, NJ) in the New York City DMA)), WWTO-TV ((La Salle, IL, changing to Naperville, IL) in the Chicago DMA)) and WGTW-TV ((Burlington, NJ, changing to Millville, NJ) in the Philadelphia, PA DMA)) will be capable of delivering an HD signal to your local facilities no later than January 1, 2018.

Unless mutually agreed to otherwise, carriage of the Stations should be on their referenced broadcast channels (47 CFR ' 76.57(d)).
