Section I. Issues

The station has identified the following issues as significant issues facing our community in this quarter:

- A. HEALTHY FAMILIES County program designed to aid parents in raising families
- B. HOUSING AVAILABILITY The lack of available housing in our area for low and median income
- C. BIOP Environmental land use regulations and the effect on our community
- D. LOCAL FUNDRAISERS CARE'S Bowl-a-thon which raises money for local homeless and senior programs, Chili Cookoff for the Upstairs which raises money for hospice.
- E. LOCAL/STATE GOVERNMENT Senator Betsy Johnson shares about the State Senate and issues important to Tillamook county and the state as a whole.

Section II. Responsive Programs

The station has broadcast programming dealing with each of the above-referenced issues. Programming dealing with each issue is set out below.

A. HEALTHY FAMILIES

"**ISSUES AND ANSWERS**" – Broadcast on January 6, 13, 20, 21, 27; February 3, 10, 17; March 10, March 31, 2018. Duration 3.5 minutes. A discussion with Erin Skaar of Care about a new program offered by Care called Healthy Families. Aimed at providing services and support for new parents or parents who are struggling to raise their children in a healthy and productive manner.

B. HOUSING AVAILABILITY

"ISSUES AND ANSWERS" – Broadcast on February 24, March 17; Duration 3.5 minutes. A discussion with Erin Skaar of the Tillamook county housing task force about the lack of available housing in our county. Not just low income housing but the lack of median income housing which would attract qualified workers to businesses in the community.

C. BIOP - BIOLOGICAL OPINION

"ISSUES AND ANSWERS" – Broadcast on March 3 & March 24 2018; Duration 3.5 minutes. Commissioner David Yamamoto explains the NOAA Fisheries' biological opinion in consultation with FEMA flood insurance program. There is a lawsuit proposed by environmental groups that says that the flood insurance program isn't doing enough to protect endangered salmon and river habitat. The rules and regulations within this biological opinion would devastate Tillamook county and the effects felt in our county would be worse than anywhere else in Oregon.

D. LOCAL FUNDRAISERS

Local organization CARE is having a fundraiser to raise funds for social services such as homeless shelters and various low income programs available to the public as assistance in times of crisis. KTIL AM ran an ROS schedule of spots 3/12 - 3/31 for the annual Bowl A Thon event.

The Upstairs, a local tavern/eatery had a fundraiser for Hospice and KTIL AM ran an ROS schedule of spots for that 2/16-2/23.

E. STATE GOVERNMENT – Senator Betsy Johnson has a 60 minute program every Saturday morning at 9:00am in which she discusses current issues facing the State Senate, most specifically issues facing her senate district.
