**Issues and Programs List for the Second Quarter 2021**

**WLOH aired the following programming to address these issues:**

**1- Senior Health and Nutrition**

**WLOH aired a series of interviews ten minutes in duration with Anna Tobin – Executive Director of Meals on Wheels- Older Alternatives of Fairfield County. These segments aired on Wednesdays in the Noon Hour as part of our Noon DJ Show.**

**During this period, listeners were kept advised of modified operations, the reopening of congregate dining halls and other Covid-19 related news and information.**

**2- Veterans Issues with the VA.**

**On the first Monday in each month, WLOH aired an interview with personnel from the Chillicothe VA Medical Center regarding veteran's health issues. The show was 10 minutes total each in duration. Topics covered included the Lancaster Satellite Clinic, Covid 19 restrictions on clinic hours and Veterans Appreciation Events.**

**3- Upcoming Community Events.**

**Each Sunday Morning from 8AM to 8:15 AM (15 Minutes duration), WLOH News Director Anne Darling hosted 'Focus on Fairfield County' which highlighted local events in Fairfield County. Topics included the Lancaster Festival- Concert Schedule, the Lancaster Old Car Club Show, The Rockbridge Lilly Festival, The Lancaster Farmers Market and other activities getting back to normal after the pandemic.**

#### **4-Tax Law Questions.**

**In response to the tax law changes, temporary measures due to the pandemic and filing extensions that had consequences to our listeners, WLOH aired “Tax Time Tuesdays” – 10 minute interviews with CPA Timothy Oatney of Oatney and Associates in Lancaster. These features aired Tuesdays between Noon and 1PM between April 1<sup>st</sup> and May 18<sup>th</sup> 2021. Topics included the May 17<sup>th</sup> Extended Filing Deadline, how the stimulus checks would affect tax returns, changes in the child care tax credits, frauds and scams, electronic filing and more.**

#### **5- Covid -19 Vaccine Information**

**It was during the second quarter of 2021 that the Covid-19 vaccine clinics went into high gear. As a public service, WLOH aired a combination of 30-second, 60-second and live read announcements directing listeners to vaccination clinics and discussing the differences in the Pfizer, Moderna and Johnson & Johnson vaccines. More than 250 such announcements were aired during the period.**
