SUBJECT MATTER, ISSUES DISCUSSED:

We talked to political analyst Frank Torres about top legislative issues in Tallahassee. The House and Senate passed 74 billion dollar budgets with large spending increases, a boost for education, but minimal incentives for businesses. We talked about the resignation of Lt. Governor Jennifer Carol. We talked about bills giving parents more say over failing schools and increased funds for charter school operators. We talked about a bill to arm teachers at school, a bill to reform medical insurance resulting from car accidents, and we talked about a bill forcing sports teams to compete for state funds for new stadiums. We talked to Latino Leadership about their 6th Latino Open, which benefits Hispanic families that are new to our area and need help with social services, education, housing and jobs. They can use sponsors and golfers. We talked to MADD about their 2nd annual Walk Like MADD 5k. The funds are used to educate people about the dangers of drinking and driving and to help victims.

SUBJECT MATTER, ISSUES DISCUSSED:

We talked to the League of Women Voters of FL about reforms that came out of this legislative session. Lawmakers passed ethics reforms that say lawmakers cannot become lobbyists immediately after leaving the legislature. They raised donation limits but put in place more transparency. They also allowed for more early voting days and limits on how long ballot amendments can be. They also passed rules that say citizens must be allowed to speak at public meetings before local governments and school boards. We talked to Clean the World about their effort to get used soap from hotels to poor nations, so children can wash their hands and not get diseases. They recently traveled to Dominican Republic with Mayor Buddy Dyer. We also talked to HOPE Helps and the Oviedo- Winter Springs Chamber of Commerce about a big BBQ fundraising event coming the last weekend of May. It features many bbq companies and country music. Proceeds will be used to help people stay in their homes when they are at risk of foreclosure.

Money raised goes to help ten thousand local families affected by Autism in our area.

We talked to Orlando Mayor Jeff Triplett and Police Chief Cecil Smith. We talked about preparations for the trial and added patrols in Sanford, at the shooting scene and at the courthouse. We talked about how the chief is meeting with residents to hear their concerns and how the Mayor urges people to visit Sanford businesses and to express their opinions peacefully. We also talked to Complete the Pair, a group that helps people arrange meetings while sending shoes to poor people in 130 countries. The model matches a pair of shoes with two people who need to meet and then they send them back and the shoes are sent to families in need. We also talked to the Wells Built Museum in downtown Orlando about an upcoming Juneteenth event. They will have a series of displays and programs to help people learn about Juneteenth and the history of segregation in Orlando.

We talked about jury selection in the George Zimmerman trial. It has gone on for a full week and the process continues next week. We talked about qualities prosecutors and defense attorneys are looking for in jurors, how honest are their answers, how long the process might go on, the fact that the jury will be sequestered, and looked ahead to opening statements, and strategies for the actual trial and the most important evidence involved. We also talked to the Orange Co. Property Appraiser. He says property values in Orange Co are up almost four percent in most cities and towns. That is good news for the economy and for consumer psyche. He says the real estate market is growing now. He explained that his office makes sure real estate transactions are fair, that they are using social media and have a user friendly website, and he explained how you can appeal your assessed property value.

She also talked about the importance of physical evidence not yet discussed in court, which will be important. We also talked to State Rep. Joe Saunders, a Democrat from East Orlando, who is a gay rights advocate. He talked about the impact of the U.S. Supreme Court ruling on the Defense of Marriage Act. He also talked about how in 13 states, gay couples can get married. He talked about how there are dozens of benefits under the Federal Govt. that gay couple might now receive. He also talked about the fight in Florida over the future of gay marriage.
