

Post-Filing Renewal Announcements

[FCC Rule 73.3580]

On October 8, 2021, begin broadcasting your post-filing renewal announcements. A total of six announcements must be made over the next four week period. Stations must broadcast at least one per week, with no more than two announcements in the same week and none on the same day. The announcements must be made at any time between 7 a.m. and 11 p.m. local time Monday through Friday.

FM translator stations must provide online notice. Online notice requires posting a conspicuous link or tab labeled “FCC Applications” on the homepage of the station website that links to a separate Notice page containing the same text as the on-air announcement. The online notice should be posted on October 8, 2021 and remain on the website for at least 30 continuous days. The Notice page must also include the date the page was last updated.

When there are no pending applications, the Notice page should remain active and read: “There are no pending applications subject to the online posting requirement.”

Certification of Post-Filing Renewal Announcements

The attached Certification of the broadcast of the post-filing renewal announcements should be completed within 7 days of the last date the announcement is aired. The Certification should be uploaded to each station’s FCC-hosted online public inspection file. The Certification belongs in the folder titled “Local Public Notice Announcements” in the station’s online public file. Please also send a copy of the completed Certification to Foster Garvey.

For FM translators, which do not have FCC public files, the FCC recommends that licensees retain a record of the dates and times of the online public notice to demonstrate compliance.


