In October 2016, KUTV reported, “‘Another day, another piece of mail from Richard Silva’s congresswoman, Mia Love. ‘I received three of them in three weeks,’ Silva told Get Gephardt last July. Silva reached out to Get Gephardt because, he says, language in the corner of each of the flyers caught his eye: ‘This mailing was prepared, published & mailed at taxpayer expense.’ ‘I don’t think it’s appropriate,’ he said. Mia Love will reimburse taxpayers for a flight she was paid for but didn't take earlier this year, her office says, making this the second time the freshman Republican has dipped into her own pocket to pay back her congressional office.

Questioned last week about two flights on consecutive days in February from Washington to Utah, Love's office had said she missed the initial flight and took the second but was charged by Delta Air Lines for both. She was reimbursed for both since she was charged by Delta, her office said. On Monday, Love's office said she would reimburse taxpayers for the \$537 she was paid for the missed flight." **National Journal: "She Waited Months" To Repay Taxpayers For The Extra Flight.**

"House records show Love was reimbursed by the government for plane tickets on February 5 and 6 after the House adjourned on February 5. When asked last week why she was reimbursed for two tickets, Piatt said Love wasn't sure which day she wanted to fly back to her district in Utah, so she bought two tickets, planning to return the cost of the extra ticket to the Treasury when she decided to take the February 6 flight. But neither of Love's quarterly office disbursement reports, which run through June 30, indicate Love
