During this same four year period the permittee/licensee may not assign or transfer the construction permit/license to another party, unless it is to the licensee of the AM station being rebroadcast. Minor modifications of this authorization are permitted, provided the translator will continue to rebroadcast the AM station for which the waiver was granted.
