
NBC Telemundo License LLC is in receipt of certain letters notifying several NBC owned and operated stations of Real Choice's intent to provide IPTV service in various markets, which we have replied to under separate cover regarding our election of retransmission consent status for those stations as well as for all other NBC owned and operated stations.

With respect to the Telemundo owned and operated stations listed in the attached Schedule 1 (collectively, the "Stations"), in the event that Real Choice is a multichannel video programming distributor as such term is defined in 47 C.F.R. §76.1000(e), pursuant to the Cable Television Consumer Protection and Competition Act of 1992 and Sections 76.64(f) and (h) of the Rules of the Federal Communications Commission, NBC Telemundo License LLC, on behalf of the Stations, which are each assigned to the Designated Market Areas ("DMA") set forth in Schedule 1, hereby elects **retransmission consent status** for carriage of its broadcast signals on the above-referenced cable system, and any and all headends served by the system, in the Stations' DMAs, in each case for the period of January 1, 2018, through December 31, 2020.

This election shall not amend, or in any way affect, any retransmission consent or other agreements that may be in place with the Stations, NBC Telemundo License LLC, or other entity under common control with NBC Telemundo License LLC (including any predecessors-in-interest), which grants rights and sets out obligations relating to retransmission of the Stations' signal by your cable systems. Further, this election is given without prejudice to any other rights NBC Telemundo License LLC has, or may have, under the Communications Act of 1934, the Rules of the Federal Communications Commission, or federal copyright laws with respect to Real Choice's operation.
