7) Supplemental Recruitment Initiatives.

(a) Initiative: Establishment of training program to enable station personnel to qualify for higher-level positions.

The General Sales Manager conducts sales training on a weekly basis for Sales Assistants and Account Executives to help them acquire and enhance the necessary skills to advance in their respective positions. The training entails the utilization of a number of assets including the viewing of sales tapes, attending sales seminars, and the use of a number of online and off line assets. A test may be given periodically covering the materials discussed.

(b) Initiative: Listing of upper-level category opening in a job bank or newsletter of media trade groups whose membership includes substantial participation of women and minorities.

Spots N' Dots is a widely read trade newsletter which includes the listing of broadcast job opportunities. This trade publication, which we believe is read by a substantial number of women and minorities in the industry, is delivered via fax and email on a daily basis. We post upper level job openings in this periodical. In particular, the vacancies for the three the Local Account Executive and the Sales Assistant positions were posted in this newsletter.
