The aforementioned consent is provided in consideration for the agreement of the Assignee to fully perform the duties, obligations, liabilities, covenants, conditions and stipulations arising under or pursuant to the Agreement relating to the Station from the Effective Date through the remainder of the Term (as defined in the Agreement).

2. As additional consideration for Assignee's agreement to perform all of the duties, obligations, liabilities, covenants, conditions and stipulations arising under or pursuant to the Agreement relating to the Station after the Effective Date, AT&T hereby releases Chang from any obligations arising under the Agreement relating to the Station occurring from and after the Effective Date; provided, however, that Chang shall not be released from any obligations that shall have accrued under or pursuant to the Agreement prior to the Effective Date.
