ACKNOWLEDGEMENT OF POLITICAL ADVERTISING DISCLOSURE

This will acknowledge receipt of "Political Broadcast Advertising Disclosure Statement" for WLIO 8.1 NBC Lima, WLIO 8.2 FOX Lima, WOHL 35.1 ABC Lima, and WOHL 35.2 CBS Lima.

I agree that all purchases of advertising time on the aforementioned Lima Stations, which I may buy or buy on behalf of legally-qualified political candidates, will be made subject to this Acknowledgement and the Political Policy.

I acknowledge that I have been fully informed concerning all classes of time which are available to advertisers, including every level of pre-emptibility; the chances of preemption for the various levels of pre-emptibility; the availability of discount packages and rotations, including the Stations' willingness to negotiate combinations of time suitable to the needs of particular candidates; the Stations' lowest unit charge and related privilege for each class of time; a description of Stations' sales practices based upon audience delivery; and the Stations' policy with respect to make-goods.

I recognize that the Federal Communications Commission ("FCC") has asserted its exclusive jurisdiction under the Communications Act of 1934, as amended (the "Act"), with respect to all disputes concerning purchases of advertising time by or on behalf of legally-qualified political candidates, specifically including all disputes concerning charges for candidates' "Uses" of Stations' facilities. I acknowledge that all such disputes will therefore be governed exclusively by the Act, and the rules and policies of the FCC, and must be resolved exclusively before the FCC, subject to such judicial review as is provided for by the Act. In order to ensure that material necessary to resolution of such disputes is maintained any such complaint should be filed with the FCC promptly.

I will comply with the Bipartisan Campaign Reform Act of 2002 and will not make any direct reference to another candidate for the same office in any broadcast unless the broadcast complies with Section 315(b)(2)(C) of the Communications Act.

(To be completed by a candidate: I certify that all advertising purchased by me on the Stations will include my recognizable voice or image and will be controlled, approved and sponsored by me, and further represent that I will immediately notify the Stations of and specifically identify any advertisement not purchased by me which I control, approve or sponsor.)

If I am an agent acting on behalf of a candidate, I certify that I have made full disclosure to the candidate of the information provided to me by the Stations concerning its political advertising policies, and, if not, that I have been specifically authorized by the candidate to purchase advertising time on the Stations on his or her behalf without the need to make such full disclosure. I further represent that all advertising which I purchase on the candidate's behalf will include the candidate's recognizable voice or image and will be controlled, approved or sponsored by the candidate. I further represent that I am authorized by all candidates on which behalf I purchase time to agree to the terms and conditions set forth herein.
