WGLC covers a wide variety of subjects and issues that concern residents of the immediate and surrounding listening area. Licensed in Mendota, WGLC-FM lends a great deal of focus on issues that concern the rural landscape as well as urban areas, in hopes that there is not an alienation of a group or groups of people and their varying lifestyles.

Issue: Agriculture/Agribusiness

Agriculture and Agribusiness is a way of life for many in this area and we do our best to keep listeners up to date on these issues.

Program: Burn Restrictions. Broadcast thirty second message informing listeners that Oglesby soon will have new burn restrictions on open burning. Aired 9/6 at 6:00am.

Issue: Arts and Culture

Promoting local shows is important, as it keeps the local entertainment industry employed. Also, it keeps the masses entertained and connected to the community.

Program: Interview with country music artist Josh Turner to promote him at the Bureau County Fair concert. Aired 8/24 at 9:06am for three minutes and twelve seconds.

Program: Granville Summer Festival. Broadcast a thirty second message informing listeners that a Summer Festival and Cruise Night will begin Friday and run through the weekend at Hopkins Park in Granville. Aired 8/4 at 7:30am.

Program: The Taste of Illinois Valley. Broadcast a fifteen second message informing listeners that the Taste of IL Valley returns to Centennial Park for a three-day festival beginning tomorrow. Aired 8/2 at 6:00am.

Program: Sweet Corn Festival. Broadcast a thirty second message informing listeners that 76th Annual Mendota Sweet Corn Festival was over the weekend of 8/11. Aired 8/14 at 6:30am. In addition, broadcast live at the event and encouraged listeners to take part in the community event. Aired 8/11 and 8/12 from 10am to 12pm.

Program: The Princeton Community Band. Will be hosting a concert on Sunday, July 23rd at Soldiers and Sailors Park at 6pm. Informed listeners about the event and where and what time to attend. Aired 7/21 at 7:00am

Issue: Charity

Issue: Community

Program: Lighted Way. Broadcast a thirty second message informing that Lighted Way will have a ribbon cutting for a new building. Aired 8/4 at 6:30am.

Program: Road Closure. Broadcast a fifteen second message informing listeners that County Highway 63 in Peru Township will be closed for a culvert replacement beginning Monday. Aired 8/4 at 6:30am.

Program: National Night Out. Broadcast a fifteen second message informing listeners of National Night Out, a time set aside for police officers and community members to meet in a casual and fun setting. Aired 8/1 at 7:00am.

Program: Cops 4 Cancer. Broadcast a thirty second message informing listeners Cops 4 Cancer held its 20th summer event and raised \$121,000 over its two-day festival in Cedar Point. Aired 8/2 at 7:30am.

Program: Matthiessen State Park. A single sunflower has bloomed and told listeners to keep an eye out for it on their way to checking out Matthiessen and Starved Rock State Park. Aired 7/10 at 7:12am for forty-two seconds.

Program: LaSalle Special Olympics. Hosting their Regional A Golf Skills Competition, Monday, July 24th at Senica's Oak Ridge Golf Course. The tournament will begin at 9am and are looking for volunteers. Aired 7/21 at 6:00am.

Issue: Environmental Issues

Issue: Government

Government is important in society to prevent anarchy and it is beneficial to the population to be informed on what the government is doing.

Program: Republican. Broadcast a fifteen second message informing listeners about the Illinois Republican State Senator, Tom Bennett, plans to retire from the General Assembly at the completion of his term representing the 53rd District. Aired 7/27 at 6:00am and 7:00am.

Program: State Senator Sue Rezin. Broadcast a thirty second message informing listeners that a flag that honors gold Star Families and filed by State Senator Sue Rezin was signed into law on Monday. Aired 8/2 at 7:00am.

Issue: Health/Wellness
