#### Section I. Issues

The stations have identified the following issues as significant issues facing our community in this quarter:

- **A. Health:** Coronavirus becomes the main health concern of the people of the Unifour area as well as throughout the country. A number of measures are enacted to help protect the population, but numbers increase in all of the counties, as other serious health issues still remain.
- **B.** Economic Impact of Coronavirus: Measures enacted to fight the spread of the coronavirus results in unemployment for a large number of the population in the Unifour area. As the shutdown continues, food, utilities, rent, house payments, insurance and other necessary living expenses become harder to come by for most families.
- C. **Drug Epidemic:** Drug usage has caused multiple problems in the Unifour area. Areas affected include increased property crimes, increase in the number of foster children, and the need for more and better treatment programs. Specifically, opioid addictions, as well as other drugs, have become a major problem in the Unifour Area.
- **D. Social Justice:** After the death of George Floyd at the hands of Minneapolis Police, many people began to question systemic racism and how it affects African Americans in everyday life. Confederate monuments and flags have become an issue as people grappled with what to do with symbols of the Civil War that have now become racist.

# Section II. Responsive Programs

#### A: Health

**"WMNC PSA's"** – Broadcast from April 1<sup>st</sup>-30<sup>th</sup>, 2020. Duration – 30 seconds. Times- Various. Frequency- 7 times per day each station. A locally produced PSA encouraging non essential workers to stay at home to avoid the spread of the coronavirus was aired.

**"WMNC PSA's"** - Broadcast on April 1<sup>st</sup>-June 30<sup>th</sup>, 2020. Duration – 30 seconds. Times- Various. Frequency – 5 times per day each station. A locally produced PSA told

- listeners what symptoms to look for if they suspected they had the coronavirus, and how to go about getting tested locally.
- **"WMNC PSA's"** Broadcast on April 1<sup>st</sup>-April 30<sup>th</sup>, 2020. Duration 30 seconds. Times Various. Frequency 3 times per day each station. A locally produced PSA informed listeners of what city, county and retail services were open and closed during the coronavirus lockdown.
- **"WMNC PSA's"** Broadcast on April 1<sup>st</sup>-April 12<sup>th</sup>, 2020. Duration 60 seconds. Times Various. Frequency 5 times per day on each station. A locally produced PSA informed listeners of how to stay safe from the coronavirus over the Easter holiday. Information about where to find church services online, on TV or on radio was also included.
- **"WMNC PSA's"** Broadcast April 1<sup>st</sup>-April 30<sup>th</sup>, 2020. Duration 30 seconds. Times- Various. Frequency 3 times per day on each station. A locally produced PSA informed listeners how to apply for the WIC program even though the Health Department was closed.
- "WMNC Special Programming" Broadcast on April 7<sup>th</sup>, 2020. Duration 1 hour. Time 3:30p.m.-4:30p.m. Frequency Once. Broadcast of Governor Roy Cooper's coronavirus press conference in which he addressed social distancing in food markets and other necessary stores, as well as lodging groups of homeless coronavirus patients in hotels.
- **"WMNC Special Programming"** Broadcast on April 14<sup>th</sup>, 2020. Duration 52 minutes. Times 3 p.m.-3:53 p.m. Frequency Once. Broadcast of Governor Roy Cooper's coronavirus press conference I which he discussed the number of coronavirus cases in the state that had just topped five thousand. He also addressed protesters in Raleigh who wanted the State to reopen business.
- "WMNC Special Programming" - Broadcast on April 20<sup>th</sup>, 2020. Duration 1 hour. Times 3:30-4:30 p.m. Frequency Once. Broadcast of Governor Roy Cooper's coronavirus press conference that told the State's residents they would be staying at home during the month of April. Governor Cooper also outlined a plan to reduce the prison population during the pandemic.
- **"WMNC Special Programming"** Broadcast on April 28<sup>th</sup>, 2020. Duration 1 hour. Times 3:p.m. 4 p.m. Frequency Once. Broadcast of Governor Roy Cooper's coronavirus press conference that highlighted assistance to those out of work during the coronavirus and the State's need for more testing and increase health care equipment.
- **"WMNC Local News"** Broadcast on April 1st, 2020. 6:30a, 7:30a, 8:30a, 12n & 5 p.m. Duration 30 seconds per newscast. Lenoir Rhyne University will be rescheduling its spring commencement due to the coronavirus. The new ceremonies are being planned for August or September.

- "WMNC Local News" Broadcast on April 1<sup>st</sup>, 2020. 6:30a, 7:30a, 8:30a, 12n & 5 p.m. Duration 30 seconds per newscast. Burke County has two additional Covid 19 cases bringing the total to 8. McDowell County also has 8 cases. No one is to leave their vehicles during the service.

Sunday. Threats had been called in to the stores. The stores plan to reopen Monday, if conditions permit.
