This public notice should be broadcast **at least four times on four unique days** during the period of October 21-27; all announcements **must air either between 7:00-9:00 am and/or 4:00-6:00 pm** local time.

Additionally the **public notice should be published** in the market's major daily newspaper twice per week during each week of October 21-27 and October 28-November 3. To save on publication costs the announcement does not have to be on a per station basis and you may combine any stations that are licensed to the same entity. You will have to list the call sign, community of license, and frequency for each station for that unique licensee. This applies **ONLY** to the newspaper publication and cannot be done for the broadcast announcement, as each station requires the notice be broadcast specifically for itself.

This is only required for Translators we own. Translators do NOT broadcast the public notice, it is only to be published. This should happen as soon as possible, in a local newspaper for the translator service area (the market's major daily newspaper will be fine).

Certification

Also attached is a certification of public notice which **should be completed by the market president** at their **earliest convenience after completion of the notice schedules**. This is to be returned to us via any of the above email addresses.

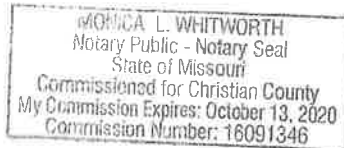
