On behalf of Quorum of Montana License, LLC ("Quorum"), the licensee of television broadcast station KSVI, Billings, Montana, transmitted herewith is a copy of the Time Brokerage Agreement between Quorum and Wolf Mountain Broadcasting, Inc., the licensee of television broadcast station KHMT, Hardin, Montana, pursuant to which Quorum provides more than 15 percent of the programming broadcast on KHMT per week.

This agreement, with certain confidential and proprietary information redacted, is filed with Commission in compliance with the requirements of *In the Matter of Review of the Commission's Regulations Governing Attribution of Broadcast and Cable/MDS Interests*, MM Docket 94-150, FCC 99-207 (released Aug. 6, 1999) at ¶¶ 92-94 and *In the Matter of Review of the Commission's Regulations Governing Television Broadcasting*, MM Docket No. 91-221, FCC 99-209 (released Aug. 6, 1999) at ¶ 149.
