FINAL COMPLIANCE REPORT

Pursuant to the Consent Decree adopted by the Commission on May 24, 2012 and released on May 25, 2012, 1 Sinclair Radio of Seattle Licensee, LLC ("Licensee"), the licensee of KVI(AM), Seattle, Washington, submits the Third Compliance Report. The Licensee is the successor to Fisher Broadcasting - Seattle Radio, L.L.C. ("Fisher Seattle Radio"). As the Commission is aware, Sinclair Television Group, Inc. ("STG") acquired Fisher Seattle Radio and several other commonly owned licensee entities in August 2013.² See FCC File No BTC-20130425AEA. STG is wholly owned by Sinclair Broadcast Group, Inc. ("SBG").

In conformance with the terms of the Consent Decree, the prior licensee, Fisher Seattle Radio, was required to designate a Compliance Officer, implement a Compliance Plan, develop and distribute a Compliance Manual, establish and implement a Compliance Training Program, report instances of noncompliance within 30 days and file a series of Compliance Reports, the first within 90 days of the release of the Consent Decree and annually thereafter.3 As such, the final report is due no later than May 25, 2015. Accordingly, this Report is timely filed.

In accordance with the terms of the Order/Consent Decree, the undersigned has been duly authorized by SBG, the Licensee's ultimate parent entity, to serve as the Compliance Officer for purposes of compliance with the Order/Consent Decree and states, to her personal knowledge, as follows:

See Consent Decree, ¶ 11 (shall file Compliance Reports with the Commission ninety (90) days after the effective Date, twelve (12) months after the Effective Date, twenty-four (24) months after the Effective Date, and thirty six (36) months after the Effective Date).

Fisher Broadcasting - Seattle Radio, L.L.C., Order/Consent Decree, 27 FCC Red 5690 (2012) ("Consent Decree"). All capitalized terms that are not defined in this Compliance Report shall have the meaning ascribed to them in the Consent Decree.

The parties to the overall transaction concurrently filed 12 applications seeking consent to the transfer of control of the Fisher licensee entities from the Shareholders of Fisher Communications, Inc. to STG, The applications were granted on August 7, 2013 and consummated on August 8, 2013. On September 25, 2013, STG filed a proforma assignment application, on FCC Form 316, seeking consent to assign the commonly owned stations KOMO(AM), KVI(AM) and KPLZ-FM, from Fisher Broadcasting - Seattle Radio, L.L.C. to Sinclair Radio of Seattle Licensee, LLC ("SRSL" or "Licensee"). The pro forma assignment was granted on November 27, 2013 and consummated on November 29, 2013. Accordingly, the current licensee of record is SRSL,

- (1) Since my timely appointment as Compliance Officer, I have continued to serve in the capacity of Compliance Officer and oversee:
 - (a) The Licensee's implementation of, and the Covered Employees' compliance with, the Compliance Plan and
 - (b) The Licensee's implementation of and the Covered Employees' compliance with, the Operating Procedures for Licensee-Conducted Contests.
- (2) Since the time of submission of the First Compliance Report, I have ensured that the Operating Procedures have been utilized at all relevant times.
- (3) I regularly communicate with Covered Employees who are involved in Licensee Conducted Contests. I am either involved in or made aware of all Licensee-Conducted Contests. I periodically discuss plans for and aspects of Licensee-Conducted Contests with legal counsel to ensure continued compliance with the Compliance Plan and Consent Decree.
- (4) All new Covered Employees are duly trained, pursuant to the Compliance Training Program, within 30 days of their hire on all relevant aspects of the Compliance Manual, including the Operating Procedures.
- (5) I conduct the Licensee's annual compliance training session, which was most recently completed on April 3, 2015.
 - (6) In preparing the instant Compliance Report, I recently reviewed (again) and evaluated the Compliance Plan, including the Compliance Manual, and I discussed them with legal counsel.
 - (7) I am not aware of any, instances of non-compliance by the Licensee of the terms and conditions of the Consent Decree, including the reporting obligations set forth therein.
