
Dear Sir or Madam:

On behalf of Google Fiber California, LLC (GF), we hereby notify you of GF's intent to provide IPTV service in a portion of Santa Clara County, California, located in the San Francisco Designated Market Area (DMA), pursuant to its California Video Franchise Certificate issued by the California Public Utilities Commission on August 26, 2011 (Franchise No. 0042). As a station located in the San Francisco DMA, we are notifying you of your right to carriage on GF's system to the extent that your station's programming does not substantially duplicate another qualified noncommercial station being carried on the system.

Dear Ms. Kiddoo:

KQED Inc., formerly known as Northern California Public Broadcasting, Inc., is excited to learn of Google's entry into the IPTV service arena.

Please accept this as KQED Inc.'s formal response on behalf of its noncommercial stations KQED, KQEH and KQET to your Notification of Intent to Provide Service which we received on December 12. All three stations request carriage.

The stations' channels are:

Station	Virtual Channel	Actual Channel
KQED	9	30
KQEH	54	50
KQET	25	25

Please note however, that KQET's signal originates in Watsonville in the Monterey/Salinas DMA. Its primary digital program stream is a duplicate of KQED's primary program stream. We would be pleased to have the bandwidth reserved for KQET used to make an alternative KQED program stream available to Google subscribers—KQED World. KQED World is one of KQED's multicast channels (broadcast on virtual channel 9.3), and features a unique lineup of news and public affairs, world events and other nonfiction programming. Descriptions of all KQED's available program streams are attached.

We believe it would benefit our viewers to have Google listings group KQED's stations together with KQED on channel 9 and KQEH on channel 10, and to have the program stream listings reflect our branding with KQED Plus being used as the on-air and online name for KQEH's primary program stream.

The listings would then appear as follows:

KQED	9
KQED Plus	10
KQED World	11

KQED and KQED Plus (KQEH) are available in high definition. Accordingly, to the extent that Google is providing HD carriage of commercial stations in the service area, we request that Google take the HD signals of these channels.

We believe the potential exists for many exciting cross-promotional opportunities with Google. At a minimum, if Google would alert us as to the date it will commence service in Santa Clara, we could utilize our program guide, email newsletters and broadcasts to announce the availability of KQED's program streams on Google's IPTV service and the channel locations to our viewers. There is also good potential for promotion on our radio station, which has the largest radio audience in the Bay Area.
