

## Quarterly Issues 2013

Jan 1 Gave a report on the disappointing impact of the low Christmas retail shopping on the economy. Experts predicted a 4% increase, but spending was back to the 2008 level. Holiday sales are an indicator of the economy's strength, and tax hikes are beginning this month.

Jan 2 Shared a study that measured brain imaging while the student ingested various forms of sugar. The conclusion is that fructose, which is added to much of our food and beverages can trigger brain changes that may lead to overeating. All sugars are not equal, for example, glucose suppresses hunger. This was shared in the interest of New Year Resolutions and weight loss.

Jan 3 Reported on a local story from Albany, GA where a young woman crashed into a patrol car last night, while texting. We discussed phones and other distractions to driver safety.

Jan 4 Interviewed Nick Eicher with World Magazine. We covered the weeks main news items, specifically the tax rate increases to social security and Obamacare and how they will impact listeners' budgets.

Jan 7 Carried the broadcast Family Talk. They discussed how to improve the marriage and family relations for the coming year.

Jan 8 In context of the recent rain, we updated our audience on the drought conditions throughout our area citing the national drought monitor. We discussed ways to improve our usage of water resources and some of the boundary and political discussions regarding water.

Jan 9 The Supreme Court announced dates it will hear two cases concerning the definition of marriage. We discussed California's Prop 8 as well as the DOMA. We also discussed how the rulings can affect the 41 states that do not recognize gay marriage.

Jan 10 We reported on the flu epidemic and this year's Influenza A H3N2 strain. We issued suggested ways by the CDC on how to fight the flu and limit its spread and impact.

Jan 11 We provided several free public service announcements that were submitted by various non-profit groups and outlined how to submit material.

Jan 14 Issued an alert from the S.C. department of consumer affairs about scams. There has been an increase; so we cautioned listeners how to be alert to them, what

information not to disclose, and who to contact if they believe they have been a victim of a scam.

Jan 15 Cited an article in the American Journal of Clinical Nutrition regarding the health benefits of olive oil. Starting a new year with people changing diets, we shared how the study reveals that those who took two tablespoons or 29 grams of olive oil a day, were 44% less likely to die from cardiac problems.

Jan 16 Interviewed Gerald from the nursery about how to use native plants to our area that resist drought and provide color during the winter months.

Jan 17 Related article from World magazine that challenged the argument that mental disorders and violence go hand in hand. This was in context of gun laws and the recent shooting in Connecticut.

Jan 18 Disclosed NBC news/Wall Street Journal poll that Americans blame mass shootings on the family unit and on the Hollywood culture more than any other cause. Interestingly, the third cause was attributed to the over the top reporting by the media.

Jan 21 Today begins the trial in Iran of an American citizen. We are covering the daily reports because of the humanitarian aspect as well as religious freedom concerns.

Jan 22 Reported on a recent study that suggests that men who go bald by the time they reach 40 may be at increased risk of prostate cancer at an early age. It is thought there is a link between the higher levels of hormones that inhibit hair growth and trigger development of cancerous cells.

Jan 23 Covered story of how a homeschooling family is accused of truancy in Nebraska. The case demonstrates the need to be very vigilant in defending homeschooling freedom.

Jan 24 Highlighted the President's inaugural speech. He outlined a bold plan that was specifically targeted to uphold a liberal agenda. One repetitive and consistent theme of the day was the intention to redefine marriage to include homosexuality.

Jan 25 We shared an NBC report on the ability for hackers to invade privacy by remotely using the computer webcam. We suggested three solutions to take to protect privacy and security.

Jan 28 Updated the audience on human rights and Religious freedom issues regarding the arrest and trial of Saeed Abanini. He was sentenced to 8 years in prison for converting to Christianity and supporting the house church movement.

Jan 29 Reported on finding from a 10 year study by the CDC about food poisoning and leafy greens and poultry. We then discussed safety measures in washing food well and cooking them thoroughly.

Jan 30 We had unusually warm weather and therefore, severe thunderstorms and tornadoes. We gave updates and live reports to help the public in emergency preparation.

Jan 31 We carried the broadcast, Money Wise. The financial experts took phone calls and answered questions regarding debt, saving, and investment.

Feb 1 Reported on the IRS estimate that the least expensive Obamacare plan will be \$20,000. This estimate is assumed for a family of four and what taxes they owe for the coming year.

Feb 4 Covered a story regarding the reallocation of the vehicle tax to go towards road repair and construction. Currently those taxes go to a general fund where they are cannibalized by various agencies, including education.

Feb 5 Promoted our free public service announcements and billboard. We advised listeners how to utilize the free airways and announced some of the soon coming events.

Feb 6 Updated audience on the human rights and religious rights issue of Pastor Saeed, sentenced to 8 years in Iran. His guards have subjected him to continued torture and psychological abuse.

Feb 7 Reported on the changes at the U.S. Postal service. They announced a discontinuance of service on Saturdays beginning in August.

Feb 8 Covered the legislation in South Carolina to outlaw using communication devices while driving and imposing penalties when the crime leads to traffic violations or accidents.

Feb 11 Interviewed Gerry Coulioutte with our Saturday show, God's Great Outdoors about an upcoming event. We discussed the details, how others could host events, and how they could utilize our airtime for free public service announcements.

Feb 12 We have had a lot of rain, and some of our areas are under flood watches. We reported on what that means and what action listeners who live in flood prone areas need to do.

Feb 13 Reported on the eight states that permit concealed weapons in church. In our coverage area, that includes South Carolina. We discussed the growing threat of security, safety issues and various approaches to provide security in a church setting.

Feb 14 Carried the broadcast, Money Wise. It is a call in show for our listeners to get their financial questions answered regarding budgets, debt and investments.

Feb 15 Made public announcement about the annual backyard bird count going on this weekend across the nation and in conjunction with the Audubon society and the Cornell Lab of Ornithology. It provides scientific data for migratory birds as well as the health of bird populations.

Feb 18 Reported on studies that connect pornography and violence and the growing number of countries' attempts to block its access. The latest is Iceland, and we discussed the implications in a nation like the United States.

Feb 19 Covered the growing concerns of the increase of health care along with how businesses are cutting hours and laying off employees in an attempt to meet the government mandates that just went into effect.

Feb 20 Discussed the reasons gas prices have not gotten below 3\$ in three years and why they have increased over the last two months. We discussed the political maneuver to make the fuel as expensive as alternative forms of energy to rationalize the increases instead of making the alternatives more competitive.

Feb 21 Emphasized our free public service announcements. We explained how to access the airwaves as well as promoting events as examples of the service.

Feb 22 Interviewed Nick Eicher from World Magazine. He offered in depth analysis of the sequestration due the first of March.

Feb 25 Shared a story of a homeschooling family from Germany that has taken refuge in the USA. The U.S. Department of Justice and Homeland Security are challenging if homeschooling is a right for families. The repercussions of this potential ruling are that families could be limited by the government in making choices of education for their children.

Feb 26 Following yesterday's threat to freedom, today we discussed the health mandate's definition that corporations cannot hold the values of the owners. We specifically discussed Hobby Lobby's suit.

Feb 27 Reported on a study that showed how sitting for long hours each day leads to poor health. We discussed how often to stand and mix up the routine for health sake.

Feb 28 Shared story on the Alabama state legislature's bill to approve a ballot initiative to permit, constitutionally, the state to display historical documents of religious nature. We discussed the freedom of religion and intent of the founding fathers.

March 1 Reported on on-the-job bullying. It is becoming the next major battleground in employment law. With high unemployment, workers don't have many places to turn.

March 4 Covered the ongoing story of the DOJ and Homeland Security attempts to deport a German family that has sought political asylum in the U.S. The language the government has adopted are great threats to religious liberty.

March 5 We have strong storms moving throughout the Southeast today. We have given extensive coverage and information about the location, power outages, and dangers.

March 6 Talked about a swarm of 30 million locusts that has descended on Egypt. We discussed how this insect could damage the economy enough to topple the fragile government and affect the political climate of the middle east.

March 7 Carried the program Probe. They discussed capitalism, freedom, and morality and how they interplay.

March 8 Reported on the Georgia legislature's move to expand the places guns can be carried. We discussed the social and safety impact.

March 11 Discussed religious freedom in context of the news report that five Christians are going on trial this week in Iran. Iran is aggressively pursuing Christians and arresting them.

March 12 Shared a report about facebook privacy settings and participation. Showed how algorithms can predict personality, finances, and preferences for targeted sales.

March 13 Reported on South Carolina's rejection to expand Medicaid. It would require \$1.9 billion extra by 2020.

March 14 Updated the audience on the human rights and religious freedom case where the Pastor Saeed is being held in Iran. His wife addressed the U.S. Congress in an effort to increase awareness and pressure.

March 15 Covered a story where a judge blocked the federal government from requiring the founder of a non-Christian business to provide mandatory contraception coverage to his employees under the health care law. Because the founder is a Christian and objects to the abortion causing drugs, the judge upheld his religious beliefs.

March 18 Shared segments of speech made by Eric Metaxes about freedom of Religion. He defined it and contrasted it to freedom of worship and showed how totalitarian regimes use it.

March 19 Discussed freedom of religion in regards to the federal court in Missouri striking down moral objectors to abortifacient drugs as well as our government's lack of response to the seizure of private property in Cyprus.

March 20 Announced the SC senate bill that would protect the credit of compromised citizens for the next 10 years. We covered the arguments pro and con and the expenses to the state in context of the quality of monitoring.

March 21 Covered the two main arguments for the two cases coming up next week at the Supreme Court hearing on marriage. Also referenced briefs that were filed as friends of the court.

March 22 Promoted local events for the weekend. Promoted our free public service announcements and how to access our airwaves.

March 25 Interviewed Dr. Irwin Lutzer about his book on Islam. We discussed how to relate to the culture and religion and how to overcome the biases and stereotypes.

March 26 Reported on a new blood monitoring implant that will help with notifying a person of an impending heart attack. Gave information about the device and how to talk with a physician about it.

March 27 Gave an update on how the United States assisted in the Arab Spring, which now has resulted in increased persecution of non-muslims in Egypt and other nations.

March 28 Delivered a PSA about the deadline for SC residents to sign up for free credit monitoring due to the security compromise.

March 29 Interviewed World Magazine about the Supreme Court Hearings this week. They offered in depth analysis on the two cases regarding marriage.

April 1 Reported on Hobby Lobby's full circuit court hearing and the challenge to the contraceptive mandate. Discussed freedom of religion.

April 2 Discussed the right to bear arms and the Nelson, Georgia city ordinance requiring every household to be armed.

April 3 Shared an article by Ravi Zaccharias about the societal influence of social media. He discussed the ethical implications and the possibilities of using it for good or evil.

April 4 Reported on today's job report. We explained how the administration uses numbers that although we added 88,000 new jobs and lost 633,000 they can report unemployment dropped. It has to do with U3 and U6 numbers and how the universe of jobs shrunk from 100 to 80%

April 5 Covered the latest installment of the national budget. Already, 700 million has been cut from social security, and the executive branch wants to cut more.

April 8 Talked about 4 nutrition myths regarding eggs, fat, carbohydrates and calories and how real research indicates how we can benefit health wise.

April 9 Updated listeners on the status of the German family that was granted asylum to the U.S. three years ago. Discussed religious freedom and parental rights.

April 10 Discussed the Obama Budget proposal to cap the charitable deduction at 28 percent and how that 20% increase is actually a charity tax.

April 11 An Associated Press story ran about the growing number of people skipping TV and using smartphones and tablets to view programming and news. We discussed how we are responding to this and the available platforms we offer.

April 12 Updated listeners on the religious freedom concerns for the U.S. citizen being held prisoner in Iran for being a Christian. The ACLJ reported today that Iranian authorities have posed an ultimatum to deny Christ or spend more time in prison.

April 15 Carried the broadcast, Money Wise. It is a call in show that people can get financial advice.

April 16 Carried Family Talk, a thirty minute show on how to strengthen and build families.

April 17 Interviewed Gerald Stephens with the nursery about planting grass seed and laying out turf.

April 18 Broadcast Family Life Today where they discussed how to strengthen marriage and build a more cohesive family.

April 19 Reported on the formal hearings over the new immigration overhaul push in congress. We connected the Immigration problems with terrorism.

April 22 Continued the discussion of immigration and terrorism in the context of the Boston Bombings.

April 23 Reported on German family whose asylum has been questioned by the Department of Justice. The hearing was today, and some of the sixth circuit questioned if parents have the right to decide a child's education.

April 24 Expanded the discussion between immigration and terrorism in light of the latest revelation that the Tsarnaev's were on welfare since immigrating from Chechnya.

April 25 Issued a warning from the South Carolina Department of Consumer Affairs that a scammer is sending out official looking letters for people to pay for a copy of their deed. The letter has an ominous tone.

April 26 Shared a study from the anthropology department of Stanford University that attending church improves health and adds to length of life.

April 29 Carried the broadcast Focus on the Family. They discussed ways to improve a marriage relationship and the positive influence that has on the children.

April 30 Promoted our event calendar and free PSA's. Gave details about upcoming events as well as how to utilize and access the calendar and airwaves.

May 1 Interviewed Gerald Stephens with Nurseries Caroliniana. We discussed Spring lawn care, fertilizers and lime.

May 2 Discussed the current drought monitor, explained the categories and how it impacted the Southeast and how it is improving.

May 3 Interviewed Nick Eicher with World Magazine about Immigration and the developing Benghazi scandal.

May 6 Reported on the Heritage Foundation Immigration report and the financial impacts of amnesty for illegal immigrants.

May 7 Gave a news analysis of the South Carolina Bill declaring Obamacare null and void, criminalizing any implementation.

May 8 Discussed the news account of the kidnapped girls who escaped after 10 years being held captive in Cleveland. All three had accepted a ride. Cautioned people about that.

May 9 Covered the special election of South Carolina district 1. Former Governor Mark Sanford defeated the challenger in a landslide. We discussed the differences, and why people voted the way they did, and the implications.

May 10 Reported on the Associated Press Story about the study that shows gun homicides are down 49 percent since 1993. With the recent school shootings and the government's attempt to confiscate guns, this report came at a critical time.

May 13 Updated the audience about the expansion and ongoing measures to protect against identity theft in South Carolina since the tax data base had been compromised.

May 14 Discussed the admission by the IRS that they targeted and harassed conservative groups since 2010.



May 15 Reported on the German Homeschooling Family's request for asylum being denied by the sixth circuit court. We talked about homeschooling, parental choice of education, and religious freedom.

May 16 Updated the listeners on the ongoing status of the American being held in an Iranian prison. He was moved from solitary confinement to the general population, but he is still having medical attention denied.

May 17 Continued coverage of the overall intimidation and abuse of power in the government. Specifically how the IRS scandal has deepened and spread. They targeted private citizens in an effort to silence opposition to the political process. Sarah Hall Ingram, who was in charge at that time was promoted to run Obamacare and given a six-figured bonus.

May 20 Discussed the ongoing Immigration policy and the upcoming vote in Senate. We talked about the issues surrounding amnesty.

May 21 Carried an interview about the future of technology and human interaction and how it can improve various aspects of society.

May 22 Shared a story from Ball State University about Education and freedom. That teachers, scientists, and students should pursue the evidence wherever it takes them, even if it challenges their worldview.

May 23 Discussed a research study that showed the connection between cohabitation and the dissolution of marriage. The study emphasized the impact on the children, that 9 out of 10 of these children would suffer from a family breakdown.

May 24 Interviewed Nick Eicher with World Magazine. We discussed this week's news, focusing on the Boy Scouts and their homosexual ruling and the IRS with their targeting conservatives.

May 27 Carried a Public service announcement from the State Troopers about safe driving and increased patrols.

May 28 Interviewed Danny Byram. We discussed his outreach and ministry to military personnel and veterans, and the need to help those who serve.

May 29 Reported on a new study in South Carolina that outlined results and presented a plan to diminish child sexual abuse.

May 30 Discussed the backlash against lawmakers who are trying to limit the right to bear arms. Citizens have targeted several Democratic legislators in Colorado for recall votes.

May 31 Updated listeners on the court case where German homeschoolers' Asylum was overturned. Concerns are about the language of the courts to limit parental rights. 27 Congress members have petitioned the Department of Justice to abandon the ruling.

June 3 Shared a story how a member of a youth group was killed in an accident over the weekend. We discussed having insurance, adult supervision, liability, and preparedness.

June 4 Covered the story about the weakness of the Keynesian recovery, the loss of American income, and the failure to recapture wealth. We offered timeless strategies for personal recovery through our program, Money Wise.

June 5 Discussed the details of the Secretary of Health and Human Services, Kathleen Sebelius, and her refusal to alter the regulations to save the life of a 10 year old girl. We covered this in context as a precursor to the death panels next year and the targeting of Christians and conservatives by the IRS now.

June 6 Gave continued coverage of the tropical storm, tornado watches, flooding, and weather advisories for Georgia and the Carolinas.

June 7 carried the broadcast Probe about pornography and its link to the sex trade that is plaguing the nation.

June 10 Reported on the major news story of the NSA and the Obama administration obtaining huge amounts of data from phone and internet. There was a whistleblower who brought this the attention of the American public, and we discussed it in terms of the Constitution and Bill of Rights.

June 11 Discussed the Obama Administration's decision to circumvent parental authority and accountability to make the abortion pill, Plan B, available on the shelf for anyone, any age. We discussed the impact of this executive order.

June 12 Interviewed Gerald Stephens about lawn care. With all the rain we have received, he discussed lawn fungus, how to identify and treat it.

June 13 Gave an update on the Tuberculosis outbreak in Greenwood county. We discussed DHEC's role, and the public's concern.

June 14 Cited the report from 1965 Department of Labor arguing that the decline of the black nuclear family would significantly impede blacks' progress toward economic and social equality. We shared how liberals scoffed at this report because it disputed their agenda for the family. We shared an updated study by the Urban Institute that not only confirmed the 50 year old study, but also warned about additional groups. The conclusion is that marriage, as defined by a man and a woman, drops the probability of child poverty by 82 percent.

June 17 Reported that the number one cause of death for children ages 1-4 is drowning. Now that it is summer, we discussed safety concerns and CPR to help the children.

June 18 Cited a report indicating the decline in marriages over the past 100 years. We discussed social issues such as cohabitation and child bearing.

June 19 Updated audience on the Freedom of Religion issue regarding the German family who was granted Asylum and then our D.O.J. reversed it. They have appealed to the full six court circuit for a hearing.

June 20 Reported on the continued assault against the Freedom of Religion by this current administration. The President, on his attendance at the G8, chastised Catholic education and said it only brought division.

June 21 Reported on the Women Deliver Conference in New York. Chelsea Clinton spoke about how she cherished her Great grandmother, who had a child out of wedlock. Abortion options were limited. We cited the overwhelming research that indicates 87% of all unwed pregnancies, when carried to full term, become cherished, wanted children. We discussed adoption as an alternative to for the 13%.

June 24 We discussed the Senate Amnesty/Immigration bill. Many of the amendments to make the bill palatable already exist as current laws. The problem is the lack of enforcement of existing laws, and the Department of Justice limiting the role border agents can fulfill.

June 25 4:07pm With the fourth of July holiday coming up, we reviewed boat safety. Last year, approximately 500 people drowned from recreational boating accidents, and 85% were not wearing life jackets. We delivered a two minute PSA.

June 26 4:10pm For 10 minutes, we parsed the Supreme Court rulings on DOMA and the Proposition 8. We broke down the meaning, and how it impacts the various states, and the people involved.

June 27 Talked about Rafael Schachter's Verdi's Requiem Mass in Terezin Concentration camp being honored in Prague. At 4:20 for five minutes, we related the story, and discussed the human resolve in the face of tyranny and the holocaust.

June 28 Interviewed Nick Eicher from World Magazine. The interview was 15 minutes beginning at 5:05, and it was about the details and ramifications of the Supreme Court Ruling.

July 1 Discussed Freedom of Religion at 4:10. We reported on the Church that requested a permit to conduct a service on the public beach early July 4<sup>th</sup> morning. The City Council turned him down due to "separation of church and state". He has acquired

legal council, will now conduct the service in prime time and change the topic to “Defiance of Tyranny”.

July 2 We began our week long Public Service Announcements about this being the deadliest week of the year for motorist. We urged driving safety and awareness, along with reminders to wear seat belts.

July 3 Conducted a 7 minute interview at 5:00 about the rise in mosquito population, due to the unusually wet weather. We discussed rise of a new type of mosquito that is around more in the day as opposed to the evening, which makes pesticides a challenge. We also covered repellents and the need for safety due to West Nile Virus.

July 4 Played continuous Public Service Announcements regarding boat safety and road safety. This is the deadliest weekend of the year for motorists, and the authorities are trying to catch DUI’s at the lake before they get on the roads.

July 5 Reported on the social implications of the President’s trip to Africa. He used the recent supreme court rulings as a context to support homosexual unions in Africa. However, he got rebuked by the Kenyan president who said they were a Christian people who believed homosexuality is a sin.

July 8 Reported on the latest unemployment numbers. Spoke for five minutes at 4:40pm about the differences in ratings, and how that system has changed over the past 5 years. Also cited the Goldman Sachs study that showed the correlation between a drop in long term unemployment with the rise in Social Security long-term disability.

July 9 Gave an update on the three girls who had been kidnapped for 10 years in Cleveland, Ohio. They made a video statement released through the internet. Coinciding with this update, we cited Michael Reagan’s book and gave 13 steps to help protect your children from kidnapping and molestation. This occurred at 4:20 for five minutes.

July 10 Discussed Immigration policy for five minutes at 4:10. Cited a recent poll that shows a majority of registered Hispanic voters believe any immigration legislation that becomes law should deal with border security and interior immigration law enforcement before legalization of America’s at least 11 million illegal aliens begins.

July 11 Highlighted Religious freedom and Religious persecution. Cited an article from Jerusalem Post about the abductions, tortures, and ransoms of the human trade traffic in Northern Africa. Many of the victims are Christians who have fled to United Nations camps. 4 minutes, 4:10pm

July 12 Interviewed World Magazine at 5:00 for 10 minutes about Religious Freedom and the work Alliance Defending Freedom is doing to help maintain that liberty.

July 15 Discussed the rule of law in context of a news story where last Friday, the Pennsylvania Attorney General, Kathleen Kane, has announced she would not defend the state's traditional marriage law in court.

July 16 Reported on the Patch article about how the South Carolina primaries work. Next January will begin the political season for the 2014 election, and we talked about the process and registering to vote.

July 17 Reported on the Department of Justice call to do away with the stand your ground laws. However, we cited a study that showed how Blacks benefited the most from the self-defense law at a rate far out of proportion to their presence in terms of population. Over 30% of the claims, at a rate nearly double the Blacks' population were successful claims of self defense.

July 18 Cited a study that showed how churches have become more dangerous than schools since 1999. Shooters often seek targets where guns aren't allowed. We discussed safety tips as well as available seminars to help safeguard congregations.

July 19 Updated the IRS scandal. The House investigators continue to hold hearings, and witnesses continue to point upline, despite the IRS and White House claims that it was done by two rogue employees. Testimony is that tea party and conservative groups would undergo additional, multi-layered scrutiny. Rather than rogue operations, it is policy to target the president's political adversaries. This is a constitutional matter that affects all Americans. 5 minutes at 4:20.

July 22 Reported on the United Kingdom's measure to crack down on internet pornography. Everyone will automatically be blocked out unless they opt in, and the government will filter all web based applications and web sites. The attempt is to protect children. They stated there is a moral duty to take this action. We also discussed freedom of speech in this context. 3 minutes at 4:10pm

July 23 Discussed religious freedom and humanitarian relief in context of the three year old civil war. We spent five minutes describing the refugee camps and requirements, who is fleeing, and what is happening to those who are trying to flee the violence.

July 24 Cited New York Times columnist's declaration that she is a creationist. The online readers left droves of comments, ranging from arguments to name-calling. One labeled her a science-phobic angel-believing climate change skeptic. Some said she could no longer be taken serious. It opened up the discussion for freedom of speech and ideas, and the caustic climate of our society for civil discussion.

July 25 Reported on the continued decline in the South Carolina High School drop out rate. We talked for five minutes at 5:35 as we covered the ability to increase work skills and clear a pathway for prosperity.

July 26 Interviewed Nick Eicher of World Magazine for 10 minutes at 5:00. We discussed the top news events and political maneuvers of the week.

July 29 At 4:20, we spoke for about seven minutes on the NYT piece about growing poverty in the United States. The article's emphasis was how to direct public programs. We discussed policies, unemployment, Keynesian economics effects against the economy and how marriage helps lift families out of poverty.

July 30 Discussed privacy and first amendment freedoms in context of the SIM catchers. Courts permit police to utilize these records without warrant. We spoke at 415 for 3 minutes on the topic.

July 31 Reported on the North Carolina legislature and governor who increased regulation on the abortion industry. They now require more stringent health procedures and inspections for clinics. We discussed the political and moral implications of this law at 405 for five minutes.

Aug 1 Covered the current plan for amnesty and immigration with an update from Senator John McCain who stated once they settle on the bill, they will strip it of law enforcement. This is a huge issue regarding elections, wages, and jobs. We talked for five minutes at 410

Aug 2 Updated listeners on the Affordable care act. According to Georgia Insurance Commissioner, Obamacare will force massive rate increases up to 198 percent. We discussed why this is happening and what few options people have.

Aug 5 Discussed Identity theft. There was an article we shared of someone who lost their wallet and it was recovered 24 years later. This weekend, we saw a customer, upon opening his wallet, revealing that he was carrying his social security card. We discussed the implications and threats to that information coming into the wrong hands.

Aug 6 Carried the broadcast Family Talk Commentary at 5:30 for 1.5 minutes. Dr. Dobson shared principles on parenting.

Aug 7 Discussed 1<sup>st</sup> amendment rights at 4:10 for 3 minutes in context of the NSA database and the Pew Research survey that found 70% of the public believes the Federal government is misusing the information.

Aug 8 Analyzed the latest unemployment numbers for July, and discussed the way the accounting and Bureau of Labor and statistics obfuscates the data so the real number is not apparent. For example the U3 number is 7.4% the U6 number is 14% but the real number of unemployment is 23.3% . This kind of information is designed for political reasons.

Aug 9 Interviewed World Magazine at 5pm for 10 minutes. We discussed the week's top headlines, and they offered analysis on the political posturing.

Aug 12 Reported on the impact of the Supreme Court ruling regarding voting rights and how that decision impacted North Carolina's new voter id legislation that went into law last week. We discussed it in terms of law and racism at 5:15 for five minutes.

Aug 13 Discussed the right to life and the Georgia state department of Community health voting to restrict employee insurance policies from paying for abortions. The governor stated that it reflects the will of the people and protects the weakest members of our society. 420pm for 4 minutes.

Aug 14 Spoke at 405 for five minutes about human rights issues and the freedom of religion. Specifically, Saeed Abedini's incarceration in Iran and the ensuing health issues as a result from the beatings and internal injuries.

Aug 15 Carried the money call in show Money Wise from 6-620pm. It gave our audience an opportunity to discuss and ask questions about finances, investing, and debt.

Aug 16 Interviewed World Magazine at 5pm for 15 minutes about Mark Levin's thesis to call for a constitutional convention. We covered the right to do so and the proposed amendments.

Aug 19 Interviewed John Gilmore about an upcoming event in Milledgeville, Georgia. We provided the public service and explained to our audience how they too can submit events. We spoke for 10 minutes during the 5pm hour.

Aug 20 Reported on the persecution and oppression in Sudan. We highlighted the effort of The Barnabas Fund to airlift 3,400 refugees to safety. We spoke for 5 minutes during the 4pm hour.

Aug 21 At 4:05, we shared 4 tips of how to promote healthy living, specifically, how to keep the mind healthy.

Aug 22 At 415 we spoke about Identity Theft for five minutes. We shared a real life story from one of our listeners and how to protect yourself and regain control of your credit and identity.

Aug 23 Promoted events coming up this weekend at 440. Talked about our free public service announcements and community calendar. Explained how to access and submit information.

Aug 26 Reported on the New Mexico supreme court decision that came down last week. We spoke at 415pm for five minutes about the far reaching implications on the freedom

of religion this ruling has as well as the precedent setting speech meted out by Justice Bosson. This ruling against the photographer is a serious threat to religious liberty.

Aug 27 Shared a nutritional study at 440pm about the benefits of water, green vegetables, fresh food, nuts and flaxseed.

Aug 28 Gave a five minute update on the human rights issue regarding Saeed Abedini being held in Iran. He lost his appeal, and suffers from the beatings.

Aug 29 Broadcast a public service from Georgia Power warning customers of scammers who impersonate Georgia Power employees over the phone demanding personal information and money for bills. We gave steps of action and provided a link for more information.

Aug 30 Interviewed World magazine at 505 for 10 minutes with analysis of this week's headlines, specifically, we discussed the escalating concerns in Syria and the President's red line ultimatum.

Sep 2 Being Labor Day, we provided a public service announcement about road and boat safety for the holiday.

Sep 3 Carried Howard Dayton's financial show, Money Wise. They discussed budgets and debt. 6pm-620pm

Sep 4 Reported on the 27 lawsuits that are being filed against state marriage amendments including South and North Carolina, which are areas we cover. Report was at 4:10 for 3minutes.

Sep 5 Shared article from The State newspaper that South Carolina governor, Nikki Haley will defend the South Carolina constitution against the pro-homosexual lawsuits. 4:10 for 3 min.

Sep 6 Interviewed World Magazine at 505 for 10 minutes with analysis of this week's headlines.

Sep 9 Aired the program Citizen Link at 420 for two minutes. They discussed a new film initiative to produce a documentary to that would help strengthen families and assist parents in their responsibilities.

Sep 10 Updated the audience about the crisis in Syria. At 405 for two minutes, we shared how rebels have taken the town of Maaloula. We contrasted their actions against the Christians with the government's protection of the various groups. We discussed how political powers can strengthen or erode religious freedom.



Sep 11 Followed up on the crisis in Syria. We interviewed a Missionary to the middle east who shared with us the various components of the conflict in Syria. There are Religious, totalitarian, and ethnic issues in the conflict. Additionally, he debunked the idea that the Rebels were moderates. Nearly half are members of AlQueda. This clarity helped us understand the complexities of U.S. Foreign policy.

Sep 12 Continued coverage over the IRS scandal. Newly released emails show that Lois Lerner specifically targeted Tea Party applications. The ramifications of a politicized IRS are a threat to our Bill of Rights.

Sep 13 Interviewed WORLD Magazine at 515 for 10 minutes explaining the misunderstanding of American Exceptionalism that Russian leader Putin talked about in the New York Times Op Ed piece.

Sep 16 Spoke at 420 for 5 minutes about the benefits of reducing cholesterol. We covered ways to adjust diet, and we listed 16 foods that help combat the accumulation of bad cholesterol.

Sep 17 Carried the Legal Alert at 520 for 2 minutes. David Gibbs discussed constitutional rights and the process necessary to guarantee them.

Sep 18 Reported on the latest findings with the abuses of the IRS and their political targeting of specific groups. Newly uncovered documents show the agency flagged political groups. This kind of harassment is unconstitutional.

Sep 19 Discussed the 40 days of prayer initiative and how pro-life groups are targeting abortion clinics with prayer. Also that a record number of abortion clinics are closing down.

Sep 20 Emphasized our free public service announcements. Highlighted several and instructed listeners how to submit them and how to promote their non-profit events.

Sep 23 Explained the various unemployment numbers and reports at 440 for five minutes. We discussed how each number is estimated and explained how the 90.5 million people who have dropped out of the labor force are not counted. Real unemployment is around 20% and it helps people understand the economy and taxes.

Sep 24 Interviewed Pat Roy at 505 for 14 minutes. He is with Vision Forum, and we carry their production, Jonathan Park on Saturday mornings. It is a drama that covers real science and paleontological issues.

Sep 25 Discussed Freedom of Religion and human rights in context of Saeed Abendini at 405 for 4 minutes. Shared Billy Graham's letter to the President of Iran, requesting the release of this political/Christian prisoner.

Sep 26 Updated folks on the fallout of the filibuster with Senator Cruz. We analyzed the political maneuverings by both parties to appear in sync with the public while undermining the very work they say they support.

Sep 27 Interviewed World Magazine. We covered had an in depth look at the impending Obamacare and how that will affect the public. 505 for 10 minutes.

Sep 30 Interviewed Dr. Ben Scripture, Zoologist and microbiologist about science and understanding our genetics and the impact of mutations on our lifespans.

Oct 1 Carried Howard Dayton's money advice show for two minutes at 510pm. He talked about how to use a spending plan to get ahead.

Oct 2 Interviewed Gerald Stephens with Nurseries Caroliniana at 505 for 10 minutes about treating dogwoods and lawns at this time of year.

Oct 3 Discussed freedom and government at 405 for 5 minutes. The White House is using the shutdown to exploit the situation to make it appear worse. There have been 17 shutdowns since 1976, never have parks and national monuments been closed. They are unnecessarily taking this action to stir up people.

Oct 4 Interviewed World Magazine about this week's current news. Today we spoke at 505 for 10 minutes about the government shutdown and how it will impact listeners.

Oct 7 Discussed the Refugee situation in Syria. We discussed the efforts to help the people who have been displaced by war, and what our listeners can do to help.

Oct 8 Announced several events and public service announcements at 420 for 4 minutes. We explained how to submit information to access the airwaves and the website.

Oct 9 Interviewed Nurseries Caroliniana at 505 for 10 minutes. He explained how to treat the yard now with pre-emergents to kill weeds for the spring.

Oct 10 Discussed the health care concerns at 410 for 5 minutes gave an update about the health exchanges and the implications for everyone.

Oct 11 Carried Attorney David Gibbs at 520 for 2 minutes. He discussed legal responsibilities we have to ensure the safety of people on our property.

Oct 14 Discussed the government shutdown, and how the White House and Parks Director have decided to close parks and memorials. The elaborate lengths they have taken to close what would have been easily left alone seem to indicate the political hostility towards the American people. Our discussion reflected how the WWII veterans responded to the riot police and how the major networks ignored it.

Oct 15 We shared the news story how the European Parliament passed a resolution calling for the release of an American pastor that has been imprisoned in Iran for the past year. We discussed freedom of religion

Oct 16 Due to the horrific economic environment and high unemployment, we detailed the rights an individual has against abusive debt collection. We referred listeners to the Federal Trade Commission for a complete list.

Oct 17 We reported on the latest research by the University of Texas at Arlington that surprised the academic community that anti-bullying programs do not work and may even make the problem worse. Students educated about bullying come away with a clearer understanding of what it is, how to do it, and how to use prescribed terms and catchphrases to get away with it.

Oct 18 Reported on a study from the American Journal of Audiology that linked low frequency loss with heart disease. Spoke for 4 minutes at 440pm about the study and the importance of hearing tests during regular check ups.

Oct 21 Shared two studies, one from the University of Texas and the other from Canada that find that children raised by parents involved in same-sex relationships do not fare as well as children from traditional homes. They are more susceptible to unemployment, poor health depression, and crime. Spoke for 5 minutes at 410pm and gave recommendations of how churches and families can strengthen marriage in a culture that is destroying it.

Oct 22 Spoke for 4 minutes at 440pm about the difference between freedom of religion and freedom of worship. We explained how the right to freedom of religion is under attack and steps people can take to strengthen this liberty.

Oct 23 Promoted National Teen Drivers Safety Week. We emphasized the law that 18 years old and younger cannot have a cell phone in hand while driving. We discussed how data shows that 75% of serious teen driver crashes are due to critical errors that include distracted driving. 410pm for four minutes.

Oct 24 Announced the new enrollment for a second year of state-funded identity and credit monitoring for South Carolina residents. For the millions whose identity was compromised a year ago, there is a new provider and we discussed how to enroll at 440pm for 5 minutes.

Oct 25 Carried the :90 broadcast, Family Talk Commentary at 545pm. They discussed parenting teenagers, and offers guidelines and resources.

Oct 28 Discussed Syrian Refugees at 410 for 5 minutes. We discussed different groups that are helping out and how listeners could be a part of the solution.

Oct 29 Provided free public service announcement at 545p for 2 minutes. Explained how to access our website and submit PSA's.

Oct 30 Discussed privacy issues regarding the NSA. We reported on the world leaders' responses to the NSA monitoring their conversations and juxtaposed that to American citizens.

Oct 31 Discussed the historical significance of Luther's 95 theses at 440 for 3 minutes. Placed it in context of freedom of speech and the important of public discussion.

Nov 1 Interviewed World Magazine about this week's news at 505 for 12 minutes. We discussed The Affordable Care Act and the rise in premiums and loss of policies.

Nov 4 Reported on the fifth circuit court of appeals overturning a lower court decision that means a tightening of the quality of the facilities at abortion clinics at 405 for 3 minutes.

Nov 5 Updated the audience of the conditions in Iraq, where Christians are being targeted and killed by Al Queda. Reported at 420 for 2 minutes about the increase in bombings and how Christians are being kidnapped and killed.

Nov 6 Covered the supreme court hearing today about public prayers at town hall meetings. We discussed the freedom of religion aspect and how congress shall make no law infringing on religious rights.

Nov 7 Promoted our event calendar at 440 for four minutes. We announced PSA's and explained the process of how to submit a free public service announcement on our radio stations.

Nov 8 Reported on a Brown University study on how more and more grandparents are raising their grandkids at 420 for four minutes. The study showed the numbers of families impacted, the various demographics and the benefits. They also concluded that divorce and the impact of finances on a single parent family was the primary cause.

Nov 11 Set aside five minutes at 440pm to explain the history of Veterans Day and to honor our veterans.

Nov 12 In regards to our foreign policy and national security, we reported on the meetings between Secretary of State John Kerry and Iran. Explained the historical position and explained why Israel, the U.S. ally is so angry at the proposal and threat to the region the United States has blundered into.

Nov 13 Updated the audience on the Super Typhoon that struck the Philippines over the weekend. We gave out information on where people could donate and how they could help in the relief efforts.

Nov 14 Reported on the continuing debacle of the health reform law. Now that it is enacted, people are discovering that there is a marriage penalty. This means it is less expensive if people are single or divorced than if they are married. Over the course of a 25 year marriage, it can cost a couple \$200,000 extra dollars.

Nov 15 We posted an article on our website and discussed alternatives to the Health Reform that can save listeners thousands of dollars a year.

Nov 18 Carried the two minute Family Talk Commentary at 430. They discussed values in child-rearing.

Nov 19 Reported on how the Census Bureau conducts unemployment numbers. Also, gave story at 520pm for 3minutes how the New York Post reported how a Census Bureau employ fabricated numbers to manipulate the report over several months, favoring the current president in the final quarter leading up to the election. We discussed assumptions that underlie our Republic.

Nov 20 Discussed Freedom of Religion at 520 for 4minutes in regards to East Point Academy, a Charter school in Columbia, SC, who was threatened by a lawsuit by the American Humanist Association. They threatened a lawsuit if the school did not cease packaging up boxes for impoverished kids in another country.

Nov 21 Updated listeners at 410 for three minutes on Saeed Abedini. We discussed his imprisonment, humanitarian violations, religious freedom, and the need to stay abreast of these issues.

Nov 22 Announced several Public Service Announcements. Explained our event calendar, and how to access our website and provide information for broadcast announcements.

Nov 25 Reported on a legal case in South Carolina, where a school was threatened by an Atheist organization to cease and desist from celebrating Christmas and collecting goods for impoverished children for 5 minutes at 5:20. We listed 7 legal precedents and rulings in favor of the schools and told where people can obtain copies of the documents. This is a constitutional, freedom issue.

Nov 26 Carried a family commentary at 430 for 2 minutes. It discussed parent child relationships and they gave resources to help parents.

Nov 27 There was incimate weather in our coverage area. We gave information, issued watches and warnings, and covered the progression of the frontal system.

Nov 28 We announced places that were providing free Thanksgiving meals to those who were in need today.

Nov 29 Discussed a Fact Sheet by Alliance Defending Freedom about what public schools can and cannot do at Christmas. We talked at 505 for 3 minutes, and made the document available on our website.

Dec 2 Discussed the holiday travel advisory. We spoke at 410pm for 4 minutes about this season, and how to take planning precautions on the road before traveling.

Dec 3 We promoted our event calendar at 440pm for 2minutes. We announced events and explained how our audience could access the free public announcements available on our network.

Dec 4 Cited a Pew Research about the shift among Jews . Belief in God is not as important to being Jewish as identifying with the ethnic or cultural identity. This is causing many Israelis to convert to Christianity. This change is having major geopolitical changes in the middle east and in the United States.

Dec 5 Addressed the Freedom of Religion issue in Bullock County Georgia school systems at 440pm for 4 minutes. It involves Christmas cards at school and how the school district handled it.

Dec 6 Interviewed World Magazine about current events. Today's topic at 505 for 10 minutes was about health care and how the changes are impacting individuals and how next year, it will impact group policies.

Dec 9 Interviewed a professor to a university overseas. He explained the need for American teachers in foreign countries, and we explained the process of applying for the jobs.

Dec 10 Resumed interview with the professor. We spoke at 505 for 8 minutes about job opportunities and careers.

Dec 11 Carried the two minute, legal alert, at 520. The attorney discussed freedom of religion and Christians' rights for carols and displays on public property.

Dec 12 Discussed freedom of religion and human rights. Gave an update on the American citizen imprisoned in Iran at 405 for 3 minutes. Covered the congressional hearing that occurred this week in regards to this situation.

Dec 13 Read several PSA's and explained the process people can use to access our free public service announcements both on the air and over the internet. 4:40 for 4 minutes.

Dec 16 Reported on a new lawsuit against Obamacare regarding the abortion mandate. It was filed Friday as a concern for religious freedom. We discussed the issue at 420 for 5 minutes and explained various points of the lawsuit challenges and constitutionality.

Dec 17 At 410pm, we reported on the court ruling that upheld polygamy's right to not be discriminated against. We discussed how they used the court ruling legalizing homosexuality to open the doors. This ruling echoes the concerns Supreme Court Justice, Antonon Scalia wrote that said that ruling would open the doors to bigamy, polygamy, incest, bestiality, and pedophilia. When marriage is elastic enough to mean anything, in due time it means nothing.

Dec 18 Followed up on a story we shared in October at 440pm. A 15 year old boy had been moved around from home to home since birth, and he asked somebody, anybody, to adopt him. Davion Only was contacted by thousands of people from around the world and is spending time this Christmas with the family that will most likely adopt him. We discussed marriage, family and children and the value of a stable home.

Dec 19 We reported on the security breach with over 40 million customers of the Target department stores. Customers had their credit and debit card information stolen over the past 19 days. We gave 11 actions people could take to ensure their financial protection.

Dec 20 Interviewed Congressman Paul Broun of Georgia. He is running for Senate, but he is also a Medical Doctor. We asked him his medical opinion about solutions to insurance and medical care. He wants to repeal Obamacare and reform the system. He has introduced a bill into the house to address his concerns.

Dec 23 Due to the holiday traffic estimates, we talked about highway safety and how to improve their safety on the roads this holiday season.

Dec 26 Carried the show Answers in Genesis at 450pm for 2minutes. They discussed the problem of suffering and addressed an overall mindset to help people cope with it.

Dec 27 We reported on the research ship that is stranded in the icy waters of Antarctica at 409 for four minutes. We discussed the book The Endurance about the ship stranded in 1914, how technology has changed but how during difficult times the importance of standing firm and not losing hope.

Dec 30 Carried the broadcast, Money minute at 510 for 1 minute. They discussed methods of helping our audience get out of debt.

Dec 31 This being New Year's Eve, we discussed the laws that limit fireworks in the various states in our coverage, we also outlined several safety tips for the usage of fireworks to help prevent injuries.
