Re: Demand for Carriage of WECN (DT), Naranjito, Puerto Rico

Dear Mr. Khoury:

This is to notify you that full-power television station WECN (DT), Naranjito, Puerto Rico, ("WECN"), licensed to Encuentro Christian Network ("Encuentro"), hereby exercises its must-carry rights on your cable television system or systems serving subscribers on the island of Puerto Rico. This is a formal demand for carriage, under the mandatory carriage provisions of Section 614(b)(1)(B) of the Communications act of 1934, as amended, 47 U.S.C. § 534(b)(1)(B), and Section 76.56(b)(2) of the Rules and Regulations of the Federal Communications Commission ("FCC").


For cable carriage purposes, the FCC treats the entire island as the equivalent of a single television market even though Puerto Rico is not listed by Nielsen as a Designated Market Area ("DMA"). WECN's community of license and Liberty Cablevision are both located in the Puerto Rico DMA-equivalent market. Therefore, the Communications Act and the FCC's Rules require your cable system to carry WECN unless the station elects retransmission status. WECN did not make such election in the most recent election cycle, and so is a must-carry station by default under Section 76.64(f)(3) of the FCC's Rules.

WECN was off the air, pursuant to a request filed with the FCC for Special Temporary Authority to Remain Silent, from September 22, 2014 through September 16, 2015. WECN resumed full-power operations on September 17, 2015, and filed the requisite notice of resumption with the FCC. Within 30 days of resumption of operations, Encuentro submitted the enclosed request, dated October 14, 2015, for must-carry status on your cable system. As discussed above, WECN is entitled to mandatory carriage on your cable system. WECN also has

the right to be carried on the cable channel which corresponds to its over-the-air channel, pursuant to Section 76.57(f) of the FCC's Rules. We therefore request carriage on cable channel 18, which corresponds to the station's over-the-air RF channel.

Encuentro has complied with several demands by you and your agents for additional information and action above and beyond what is reasonably required of a television station seeking must carry status under the FCC rules. Thus, we demand carriage of WECN to begin as soon as possible and without further delay. If carriage of WECN does not begin within 30 days of this letter, the FCC's rules consider that to be a rejection, at which time Encuentro will file a formal petition asking the FCC to order you to carry WECN on your cable system.
