## DECLARATION OF DUNCAN BROWN

## I, Duncan Brown, hereby declare as follows:

1. I am Vice-President of Operations for Venture Technologies Group, LLC ("VTG"), the licensee of WNYA(TV), which is part of a station employment unit based in Pittsfield, Massachusetts and which includes WNYA-CA licensed to Kinderhook, New York (the "SEU" or "Unit"). This Statement and relevant attachments are being submitted in response to the April 19, 2010 letter of Lewis C. Pulley, Assistant Chief of the Policy Division of the Commission's Media Bureau, concerning a random audit of the SEU's EEO compliance (the "EEO Audit Letter").
2. This SEU employs five or more full-time employees as the term is defined in the broadcast EEO rule of the Federal Communication Commission ("FCC" or the "Commission"), 47 C.F.R. § $73.2080(\mathrm{e})(1)$.
3. In response to Question 3(a) of the EEO Audit Letter, copies of the SEU's two most recent EEO public file reports, as described in 47 C.F.R. § 73.2080 (c)(6), are appended at Attachment A.

The web addresses of the stations in this SEU are as follows: www.my4albany.com. A copy of the current report is included on or linked to this website.

The date of each full-time hire listed in the SEU's two most recent EEO public file reports, as required by 47 C.F.R. $\S 73.2080$ (c)(5)(vi), is included in the internal business records appended at Attachment B.
4. In response to Question 3(b) of the EEO Audit Letter, documentation concerning the recruitment sources used to fill each full-time position during the period covered by the above EEO public file reports, is also appended at Attachment B. Those sources that have notified the SEU that they want to be alerted to job openings at the Unit, as described in §73.2080(c)(1)(ii), are indicated in the job-specific documentation.
5. In response to Question 3(c) of the EEO Audit Letter, the internal business records appended at Attachment B provide data concerning (a) the total number of interviewees for each vacancy and (b) the referral source for each interviewee for each particular full-time vacancy filled during the period covered by the above EEO public file reports.
6. In response to Question 3(d) of the EEO Audit Letter, documentation concerning the Unit's performance of recruitment initiatives described in §73.2080(c)(2) during this time period is appended at Attachment C. Station personnel involved in the recruitment initiatives are noted in the documentation. This SEU employs a total of 10 full-time employees and all of our stations are located in a market with a population of less than 250,000 . Accordingly, the SEU is required to perform at least two recruitment initiatives during a two-year period. The SEU notes that it performed at least two recruitment initiatives during the two-year period covered by this audit, however, as a general matter this SEU tracks its recruitment initiatives on a two-year cycle by
even years (e.g. 2006-2008, 2008-2010). The station, therefore, has several additional initiatives scheduled during the 2010 reporting year.
7. In response to Question 3(e) of the EEO Audit Letter, the licensee affirms that it is not aware of any discrimination complaints filed against the licensee of the stations in this SEU during the current license term.
8. In response to Question 3(f) of the EEO Audit Letter, the licensee affirms that Venture Technologies Group, LLC has created and deployed an EEO compliance plan. The EEO compliance plan has been distributed to all managers and all management personnel is required to participate in annual training to ensure adherence to the EEO compliance plan.

At the local level, this SEU recruits broadly for all full-time positions and carefully adheres to VTG's EEO compliance plan. The manager in charge of compliance at this SEU is Duncan Brown, Vice-President of Operations. This SEU's compliance efforts include posting of jobs vacancies in the workplace, posting of state employment regulations such as minimum wage and anti-discrimination policy in the workplace as well as equal employment opportunities statements in job applications.
9. In response to Question 3(g) of the EEO Audit Letter, the licensee affirms that the SEU understands that it must periodically analyze the effectiveness of its EEO recruitment program by reviewing the productivity of sources on its recruitment list and the outcome of its recruitment initiatives. The company assesses its compliance on an annual basis. The Recruitment Source List is updated every year. Each and every job vacancy was disseminated on local, regional and national basis through a variety of sources. This SEU indicates that it's an equal employment employer in all of its job ads and job applications and employment handbook.
10. In response to Question 3(h) of the EEO Audit Letter, this SEU strives to comply with all federal, state and/or local laws regarding pay, benefits, seniority practices, promotions, and selection techniques and tests to ensure that the unit provides equal opportunity and does not discriminate against employees or applicants. This SEU's employment practices are my ultimate responsibility.

RE: "EEO Basics Binder" - How to Comply with the FCC's EEO Rules and Policies

With the publication of the Federal Communications Commission's Report and Order reviving equal employment opportunity ("EEO") rules for broadcast stations, the legal "effective date" of the new mandates was set for March 10, 2003. Accordingly, we have prepared this "EEO Basics Binder" to provide step-by-step instructions on how to comply with those broadcast-specific EEO requirements.'

This binder contains brief summaries of the Commission's EEO program components as well as the forms and other record-keeping materials that a station should use to satisfy the FCC mandates. The 10-page introductory memo reviews each aspect of a licensee's EEO obligations and is followed by 13 tabbed sections that provide more detailed information concerning the specific requirements, as follows.
