Dear Les and Brad:

Good news! Yesterday afternoon, the FCC Enforcement Bureau countersigned the Tolling Agreement regarding the pending complaint asserting that WJQK violated the FCC's contest rule. A copy of the agreement is attached. Please place it in the station's Public Inspection File.

Shortly after the Enforcement Bureau signed the agreement, the Media Bureau granted the WJQK renewal application.

In a few days, you will receive the official renewal certificate (in the form of an oversized postcard) directly from the FCC. When it arrives, please post the original in the WJQK control room with the station's underlying license. A copy of the renewal certificate and the license also need to be kept in the WJQK Public Inspection File.

The FCC now has two years (i.e., until November 15, 2014) in which to issue a Notice of Apparent Liability with respect to the alleged contest rule violation. If it does not issue a NAL by that date, the matter will be closed.
