These are some issues the KSHO Staff deemed as important to our listening audience:

Local event: (65 sec)

Interview with Paul Adamus of Corvallis regarding an annual Bird Counting Exercise in the Mid-Willamette Valley. The group meets at the E.E. Wilson Wildlife Headquarters and also at the Ankeny Wildlife Refuge to the north. A contact was broadcast...541-745-7092...Adamus phone number for those new birders who might want to get involved in the counting exercise taking place January 3rd.

Aired on KSHO 1/1 in newscasts throughout the day.

Interview with Linn County Commissioner John Lindsey regarding a class action lawsuit being pursued by the county against the State of Oregon. The litigation has to do with Linn County and 14 other counties have a trust agreement with the State Department of Forestry where as the Department transferred tax foreclosures to create revenue for the counties. Lindsey says the county, believes the Department has not fulfilled contractual obligations set by Oregon Law.

Aired on KSHO 1/15-16 in newscasts throughout the day.

Interview with State Senator Sara Gelser of Corvallis, representing Corvallis and Albany in the legislature regarding a new state law, as of January 1st regarding paid sick leave in the job force. She was preparing to hold a public forum to help businesses understand and know how the law is being implemented. A representative from the State Bureau and Labor Industries (BOLI) was to attend and explain the new law.

These are some issues the KSHO Staff deemed as important to our listening audience:

Local event: (48 seconds)

Interview with Leanna Steinke, Secretary for the Philomath Frolic and Rodeo talked about a formal coronation for two queens, rather than one. The queens have already been announced but this was a formal coronation event where the two begin their official title holding position and tour around the state.

Aired on KSHO 2/1-2 in newscasts throughout those days.

Local event: (36 seconds)

Interview with Linn County Commissioner Roger Nyquist regarding his appearance before an Oregon Legislative Committee on the County's opposition to the Governor and the lawmakers proposal for an increase in the state minimum wage law. Nyquist said his county won't go along with any wage increases if the legislature doesn't dole out extra funding to cover the added costs.

Aired on KSHO 2/5-7 in newscast throughout those days.

Local event: (38 seconds)

Interview with Alan Dannen, Assistant Salem City Engineer discussing the first public hearing before the city council seeking input on the proposed new police facility. Two locations have been picked for a possible public safety building. The city hired an architectural firm: DLR Group to make a presentation at the hearing and answer questions.

These are some issues the KSHO staff deemed as important to our listening audience:

Local event: (35 seconds)

Interview with U.S. Army Corps of Engineer spokesman Scott Clemens alerting boaters and other users of Foster Reservoir near Sweet Home of some fish tests at the Reservoir this year. The testing means the reservoir will refill on a different schedule than normal and water levels will vary for local boaters. We also discussed the updated work on Green Peter Dam, in which the Corps for the last several years has been repairing the two gates at the dam.

Aired on KSHO 3/6-7 in newscasts throughout those days.

Local event: (47 seconds)

Interview with Jackie Rochefort, Park Planner for the City of Corvallis. We discussed the proposed expansion of Chintimini Senior Community Center and Chintimini Park. The issues concern parking space and square footage for the Senior Center. They are working on a model to build a second story for the structure and more amenities for park uses. Eventually the city wants to send the proposal to the voters as a bond measure request in 2018.

Aired on KSHO 3/15-17 in newscasts throughout those days.

Local event: (36 seconds)

Interview with Emily Knight, A Lebanon High School Junior ROTC Rifle Team member heading to the National Competition in Anniston, Alabama. Knight, Senior shooter on the team talked about the team recent competition in Provo, Utah where they took 1st place out of all the ARMY JROTC competing teams. The Lebanon Rifle Team placed second in Nationals last year in a 3 position air rifle match.
