Dear Sir/Madam:

Oklahoma Land Company LLC, licensee of Station KTUZ-TV, Shawnee, Oklahoma ("KTUZ"), hereby notifies DIRECTV, Inc. ("DIRECTV") of its failure to meet its obligations regarding mandatory carriage under Section 338 of the Communications Act of 1934 (*see* 47 U.S.C. § 338(f)) and Section 76.66 of the Federal Communications Commission's rules (*see* 47 C.F.R. § 76.66(m)). Contrary to DIRECTV's letter to Mr. Tyler, dated August 26, 2005, DIRECTV's own website confirms that it does provide secondary transmissions of local television broadcast stations to subscribers within the Oklahoma City, OK DMA. Accordingly, KTUZ hereby reasserts its election of mandatory carriage under Section 76.66(d) (*see* 47 C.F.R. § 76.66(d)) and encloses a copy of its original request and DIRECTV's denial of that request.
