("Shawnee"), the complainant in the above-captioned request for carriage, we hereby voluntarily withdraw the complaint filed pertaining to the Station and systems held by Cebridge Connections ("Cebridge") in Anadarko, Oklahoma, Weatherford, Oklahoma, Woodward Oklahoma and Purcell, Oklahoma.
