Notice of Failure to Meet Mandatory Carriage Obligation

Dear Mr. O'Connor:

This is in response to your letter dated January 6, 2009, in which you request an extension until January 1, 2010 to carry Station KTUZ-TV, NTSC Channel 30, DTV Channel 29, Shawnee, Oklahoma ("KTUZ") on Suddenlink Communications' ("Suddenlink") cable system in Purcell, Oklahoma. Under the rules of the Federal Communications Commission ("FCC"), KTUZ is required to treat your response as a rejection of its request for carriage as of January 1, 2009. By this letter, KTUZ notifies Suddenlink that it has failed to meet its mandatory carriage obligation under the FCC's rules.

By letter dated September 9, 2008, KTUZ elected mandatory carriage on Suddenlink for the election cycle that commenced January 1, 2009, pursuant to section 76.64(f) of the Federal Communication Commission's ("FCC") regulations, 47 C.F.R. § 76.64(f) (copy of letter attached hereto). Section 76.56(b) of the FCC's regulations, 47 C.F.R. § 76.56(b), requires Suddenlink to carry KTUZ on its system at the beginning of the election cycle and does not allow Suddenlink to unilaterally decide when such carriage will begin. As of January 1, 2009, Suddenlink had failed to carry KTUZ; Suddenlink's failure to carry KTUZ continues today. Accordingly, pursuant to section 76.61(a)(1) of the FCC's regulations, 47 C.F.R. § 76.61(a)(1), this letter serves as notice of Suddenlink's failure to meet its mandatory obligation to carry KTUZ.

KTUZ reserves its right to file a complaint with the FCC pursuant to section 76.61(a)(3), 47 C.F.R. § 76.61(a)(3), should Suddenlink continue to deny KTUZ carriage on its Purcell, Oklahoma system.
