Dear Ms. Dortch:

On behalf of the Regents of the University of Michigan (the "University"), licensee of noncommercial educational radio station WFUM-FM, Flint, Michigan, we hereby re-submit, out of an abundance of caution, the enclosed notification of the commencement of digital broadcasting using iBiquity Digital Corporation's HD Radio™ technology.

As evidenced by the enclosed date-stamped copy of WFUM-FM's digital notification filing, the University originally filed this notice with the Commission on November 14, 2005, consistent with the Commission's order on interim digital operations in *Digital Audio Broadcasting Systems and Their Impact on the Terrestrial Radio Broadcast Service*, MM Docket No. 99-325, *First Report and Order* (October 11, 2002). However, a recent review of the Commission's CDBS records indicates that receipt of this notification is not currently reflected by that database. The University therefore re-submits the attached date-stamped copy of this filing, and respectfully requests that the Commission update its records accordingly.

The University is a noncommercial educational licensee and operates Station WFUM-FM on a noncommercial educational basis. Moreover, the University qualifies as governmental entity. This station is therefore exempt from FCC filing fee requirements pursuant to Section 1.1114 of the Commission's Rules, and the facility is exempt from FCC regulatory fees, pursuant to Section 1.1162 of the Rules. 


