They discussed their perspective on the murder of unarmed jogger Ahmaud Arbery in Georgia. A sheriff deputy and his son are responsible and no one has been arrested. They believe that this was a modern day lynching. Perkins and Bennet gave their opinions on the government's actions on this situation. Moreover, they analyze the case and how they think it will play out.

Also, they discussed that they are excited about how everyone is coming together to fight for the injustices. Furthermore, he states that we need to fix the gaps in our justice system while explaining that racism is still relevant and that black people need their voices to be heard.

Mildred interviewed Larry Watson, who is an educator, singer, songwriter, and activist. As of January 2016, Watson serves as Professor of Ensemble at Berkley College of Music. He is also the owner/operator of Save Ourselves Productions, as well as a consultant for community development agencies, corporations, civic organizations, universities, and college organizations. Moreover, Professor Waston was the Lead singer in the 2000 grand opening of the Landmark Center, Art Edible fundraiser, Scullers Jazz Night Club, Medal of Honor at the Harvard School of Law, and the Boston chapter of the NAACP. They discussed how he feels broken and isolated being a black man in America. He believes that the community is still looked at as slaves. Furthermore, they went on to discuss that people think black is not needed and ended the interview with how African American is very much needed in our society.

Siggers told his story of how he was wrongly executed. In addition, he discussed how he has turned his life around since then.

In addition, they discussed the case of Malice Green, who died at the hands of Detroit police in the 1980s.
