## 1. HEALTH CARE

The topic of this category was a discussion on the vote by the United States House of Representatives to Repeal the Affordable Care Act, and the future of the bill in the United States Senate.

Topic: With no Democratic votes, the Republican-controlled United States House of Representatives voted to Repeal the Affordable Care Act (ACA) (also-known, as "Obamacare"), and replace it with their own American Healthcare Act (AHCA). What impact would the loss of the Affordable Care Act have on this country if also passed by the United States Senate, and what future does the bill have in the United States Senate? Our guests, all healthcare experts, discussed the likelihood that states and hospitals might have to pick up the tab for indigent citizens in need of healthcare services if the Affordable Care Act disappears. Sister Rosemary Donley, with special expertise on Capitol Hill as a professor of nursing, and a nurse practitioner, talked about whether there is a moral obligation for government to provide healthcare to citizens.

## 2. RUSSIAN INTERFERECNE IN THE 2016 PRESIDENTIAL ELECTION

Topics discussed in this category included a discussion on the appointment of a Special Counsel to investigate charges of alleged interference by the Russians in the 2016 American Presidential election, and a discussion on of where this investigation stands, and what might come next.

What investigative powers would the Special Counsel have, who is likely to be called as a witness in this investigation, and what might happen after the findings by the Special Counsel are released? Our guest, attorney Laurel Brandstetter, is a partner with the law firm Schnader Harrison Segal & Lewis LLP. She is a former Pennsylvania state prosecutor, former Senior Deputy Attorney General under Kathleen Kane, and personally testified against Kane, who was convicted of two felony counts of perjury and other charges of lying, and abuse of power, and who was also forced to resign from office.

Topic: There were new developments in Special Counsel Robert Mueller's (former F.B.I. Director) investigation into possible interference by the Russians in the 2016 American

Presidential Election. Special Counsel Mueller is now looking into charges of personal interference by President Donald J. Trump, through reported comments to then-F.B.I. Director James Comey to drop an investigation into former National Security Advisor Michael Flynn, when the two spoke in February. (Comey recalled that Trump told him – "I hope you can see your way clear to letting this go, to letting Flynn go. He is a good guy. I hope you can let this go.") We welcomed back former Pennsylvania Senior Deputy Attorney General, Laurel Brandstetter to this program, and we also called on former United States Attorney for the Western District of Pennsylvania, J. Alan Johnson (appointed by President Ronald Reagan), for analysis of where this investigation stands, and what might come next.

# 3. DRUG EPIDEMIC

Topics discussed in this category included a discussion regarding treatment and rehabilitation services to those who are suffering from drug addiction, in addition there was a discussion from recovering addicts who shared their story about addiction and recovery, and there was a discussion regarding the powerful synthetic opioid, Fentanyl.

Topic: This program was especially critical, to the mission of this broadcast, as it attempted to provide significant information about one of the most important developing news stories of the year, and also tried to personalize the impact of that story on our audience. New statistics show that drug addiction is at epidemic levels in Westmoreland County as well as elsewhere in our community and the nation, with that county reporting the highest number of drug and fentanyl-related overdoses in the county's history. Our guests, in the first segment of the program, provided treatment and rehabilitation services to those who are suffering from drug addiction. Our guests, in the second segment, were two people from Westmoreland County who are recovering drug addicts. They shared their story of how they became addicted to drugs, and how they are courageously attempting to recover from their addiction.

Topic: Sobering figures were released by the U.S. Drug Enforcement Administration (DEA) in June, noting that drug overdoses in America are now the main cause of death for people in America, age fifty and under. In fact, more people in this age group die from overdoses than in car accidents. Our special guest, Allegheny County Chief Medical Examiner Karl E. Williams, M.D., voiced particular concern over the increasing presence of the powerful synthetic opioid, Fentanyl, which is supposed to be prescribed carefully to treat cancer patients, but which is now being snorted directly. Williams says that illegally manufactured versions of Fentanyl, being made in places like China, are being illegally sold as counterfeit pills and as a "filler" in heroin and cocaine to boost the drug's potency.

# 4. FEDERAL AND STATE BUDGET CUTS

Topics discussed in this category included a discussion that the Trump Administration is considering sharp cuts in the Federal budget to programs that help those who are in need of food assistance, a discussion on proposed budget cuts by federal and state governments that would affect the ability of organizations like Neighborhood Legal Services Association to recruit attorneys for "free" services to those clients in need, and a discussion on education funding that is likely to be cut, on both the federal and state level.

Topic: This program was devoted to a discussion of reports that the Trump Administration is considering sharp cuts in the Federal budget to programs that help those who are facing food "insecurity". Vulnerable populations are not limited to urban areas and minorities, but also include the elderly, and some members of the middle-class, who cannot make ends meet, and who often must choose between money for food or heating. Our guests discussed the critical role that philanthropic foundations will play in helping to close the funding gap, and the key role that the Greater Pittsburgh Community Food Bank plays in helping different segments of the population. Federal funding cuts could also mean that the burden of helping the same vulnerable populations will fall upon state government and state taxpayers.

One of the topics at this conference was the growing concern over the impact of proposed budget cuts by federal and state government that would affect the ability of organizations like Neighborhood Legal Services Association to recruit attorneys, for pro bono or "free" services to those clients in need. Our guests included the Executive Director of Neighborhood Legal Services Association of Pittsburgh (NLSA), Robert V. Racunas, J.D., and Antoinette "Nette" Oliver, J.D., a Partner with the Pittsburgh law firm Meyer Unkovic Scott LLP, who helps the Association administer legal assistance to those in need.

Gorsuch, was sworn into office in April after being confirmed with the support of
Republicans and three Democrats, and a change in the Senate rules for confirmation,
requiring only a 51-vote simple majority instead of 60-votes. One of our guests, Anne Marie
Lofaso, the Arthur B. Hodges Professor of Law at West Virginia University, studied with
Gorsuch at Oxford University and talked about Gorsuch's personality and legal ability.
Andrew Simpson, Assistant Professor of History at Duquesne University's McAnulty
College and Graduate School of Liberal Arts, discussed the political ramifications of the
Gorsuch appointment, and the historical unpredictability of judicial philosophy of any
justices who are appointed to the high courts by any President.

# 6. PRESIDENT TRUMP TAX POLICY PROPOSAL

The topic of this category was a discussion on President Donald J. Trump's plans for historic, major changes in American tax policy.

Topic: Just days before marking his 100th day in office, President Donald J. Trump announced plans for historic, major changes in American tax policy. If approved, they are likely to affect most taxpayers, as well as corporations and businesses of every size. The proposed reform of the tax code did not provide any detail about how the federal budget would compensate for a drop in tax revenue that would likely result from approval of that proposal (major corporate and personal income tax cuts). Our guests talked about who would be affected by this kind of tax reform, and the likelihood that the proposal would be approved by Congress.

## 7. TERRORISM

Topics discussed in this category included a discussion on the terrorist attack in Manchester, England, and a discussion regarding the growing concern about the ability of foreign enemies like North Korea or Russia, to disrupt America's internet system and our national security.

star Ariana Grande, there was a brazen terrorism attack which killed 23-adults and children, and injured 119-others, 23-of them critically. A 22-year-old British Muslim, Salman Ramadan Abedi, detonated a homemade bomb containing shrapnel at the exit of that arena. Our program dealt with the increasing challenge of fighting terrorism at public events, and what might be done to strengthen the war on terrorism. Our guests included Alex Popichak, Point Park University Junior and Broadcast Major, who was attending a workshop with fellow Point Park students in Manchester, England, during the time of this attack, and Lawrence Likar, JD, Retired Supervisory F.B.I. Special Agent, terrorism expert, and Professor and Department Chair of Justice, Law, & Security, at La Roche College.

The latest danger is ransomware attacks, in which computer hackers from these countries are able to strike computer systems in the United States, and at least 150-countries, forcing their shutdown. Our guest, in this segment, owns a company, based in Wexford, Pennsylvania, that can help its clients overcome ransomware challenges to their computers, and protect future cyberattacks from abroad. Karen Pulchalsky is Founder and President of Innovate e-Commerce, and explained why this problem is such a security and economic threat to the country, and to businesses.

## 8. MEDICAL MARIJUANA

The topic of this category was a discussion regarding the Pennsylvania's Office of Medical Marijuana awarding of twelve licenses statewide, including three in Southwestern Pennsylvania, to produce medical marijuana.

Topic: Pennsylvania's Office of Medical Marijuana announced the awarding of twelve licenses statewide, including three in Southwestern Pennsylvania, for the manufacture of medical marijuana. One of the local facilities will be constructed in McKeesport, Pennsylvania, a Monongahela Valley city that has seen its share of job losses over recent years because of the decline of the steel industry in that area. Our guests included Mayor Michael Cherenkov of McKeesport, who discussed the potential economic impact of a medical marijuana manufacturing business in his town, Gabe Pellow, an attorney whose company Pure Penn, was granted one of the three local licenses to manufacture medical cannabis, and whose business will be located in McKeesport, and Joseph McGurk, from Beaver Falls, Pennsylvania, whose two daughters, ages twelve and fifteen, struggle with the extremely rare genetic disease Drave Syndrome. The disease causes multiple brain seizures that attack its victims, and medical cannabis, which the children have been acquiring from outside of Pennsylvania, is the only effective treatment to limit the number of these seizures.

## 9. POPULATION AND EMPLOYMENT

Topics discussed in this category included a discussion on population loss in Southwestern Pennsylvania, and a discussion regarding unemployment in the area.

Topic: The latest regional unemployment and population figures for the Southwestern Pennsylvania were not encouraging. Recent Census Bureau information showed that the Pittsburgh metropolitan area had the second-worst population loss, from the previous year, second only to Chicago, with a loss of almost 9000-people. Though jobs grew by almost one percent from last year, the figure is still below the "benchmark" average for similar-sized areas. Doug Heuck, Founder, Editor, and Publisher of *Pittsburgh Quarterly* and Director of "Pittsburgh Today", and Christopher Briem, Regional Economist for the University of Pittsburgh's Center for Social & Urban Research, where Heuck also works, appeared together to discuss what this means for our area's economic future, especially with bankruptcy for Westinghouse Electric pending.

Topic: It was another "mixed bag" for the latest economic report for the Pittsburgh region. Unemployment was down, a half-percent from one-year ago at this time of year (April figures), but the area lost more population, as the City of Pittsburgh's population dropped by 239-people – from 2015 to 2016 – and Allegheny County lost almost 4,000 people during the same period of time. Doug Heuck, from the University of Pittsburgh's Center for Social & Urban Research, and Founder, Editor, and Publisher of *Pittsburgh Quarterly Magazine*, was back with us for an update on the economic health of our area.

PNC Foundation President Sally McCrady appeared on our broadcast to talk about what their \$504,000 "flash fund" means to the 849 projects in public and charter pre-K classrooms in 22 states and Washington, D.C., where PNC Financial Services Group conducts business. Through DonorsChoose.Org, an on-line charity that connects individual donors with classrooms in need, the PNC Foundation grant is the first expansion to reach a new audience of teachers, and will boost the amount and power of individual, charitable donors too.

Michael Bartley - Executive Vice-President, Steeltown Entertainment Project Topic: Pittsburghers and the professional football and sports world said goodbye to one of the most influential giants in sports history, Pittsburgh Steelers Chairman and former United States Ambassador to Ireland, Dan Rooney, who died on April 13th at the age of 84. In our first segment, co-authors Maggie Patterson and Rod Ruck, who wrote a book about Rooney's father, Art Rooney, joined us to discuss Dan Rooney's impact on sports and Pittsburgh. In our second segment, Jim Lamb, President of the Ireland Institute of Pittsburgh (which Dan Rooney was instrumental in founding) and also Honorary Consul of Ireland in Pittsburgh and Western Pennsylvania, and Michael Bartley, local broadcast journalist and Executive Vice-President of the Steeltown Entertainment Project, talked about Dan Rooney's commitment to the people of Ireland, carried out both in Pittsburgh and as United States Ambassador to Ireland (appointed, to the post by former President Barack Obama). Our program even included a message from Ireland, from Daniel Crozier, who was brought to Pittsburgh by the Ireland Institute of Pittsburgh to study in America during the religious strife in Northern Ireland in the 1980's, and who now is a broadcasting executive in Newry, Northern Ireland, from where the Rooney family hails.

Fitzgerald, retired Bankruptcy Judge for the Western District of Pennsylvania, with five years' experience as the Court's Chief Judge. She is now a Shareholder, with the Pittsburgh law firm Tucker Arensburg, and also serves as Professor of Practice, at the University of Pittsburgh's School of Law.

Topic: Pittsburgh International Airport finally seems to be making considerable progress in its attempt to increase the number of nonstop flights to major American cities, and international flights from Pittsburgh to the rest of the world.
