## **1. CAMPAIGN 2016**

Topics discussed in this category included a discussion on the beginning of the 2016 Presidential Campaign, and a roundtable discussion on the campaign following the Republican Candidates Debate at the Reagan Presidential Library, as well as challenges front-runner Hillary Clinton faces in the campaign among Democrats.

Topic: Recent political polls, and a Republican Presidential debate widely viewed on CNN, show that the race for the Republican nomination for President in 2016 may be wide open. As we recorded this broadcast, the Quinnipiac University poll showed political novice and billionaire Donald Trump with a substantial lead over candidates like former Florida Governor Jeb Bush, and other political veterans, and the Democratic Presidential race could also be up for grabs, as Vermont's "Junior" United States Senator, Bernie Sanders (who calls himself a Democratic Socialist) is receiving surprisingly large support in early battleground states like New Hampshire and Iowa, in his race with former United States Secretary of State, New York Senator, and First Lady Hillary Clinton. Our guests, Pitt's Gerald Shuster, and KDKA-TV's Money & Politics Editor Jon Delano, provided some perspective on the beginning of Campaign 2016.

Topic: In our latest political roundtable discussion of Campaign 2016 we talked about the ever-changing and surprising American Presidential campaign. After voters watched three hours, and two political debates at the Reagan Presidential Library, featuring Republican front-runner Donald Trump, and newly-invigorated challengers, California businesswoman Carly Fiorina and retired neurosurgeon Ben Carson, M.D., we asked Robert Morris University's Dr. Philip Harold, Professor of Political Science, and Co-Director of their Honors Program, Pittsburgh attorney and at-large member of Allegheny County Council, Republican Heather Heidelbaugh, from Mount Lebanon, and Nancy Mills Patton, Chair of the Allegheny County Democratic Committee, Member of the Pennsylvania State Democratic Committee and Allegheny County Democratic Women's Caucus, and delegate to the 2008 and 2012 Democratic National Conventions, about the state of the Presidential race at this point. Some of the discussion centered around the role of Democratic candidate Hillary Clinton, her serious challenge from Vermont Senator Bernie Sanders, the potential challenge from Vice-President Joe Biden, still undecided about whether to run for President, after the death of his son Beau, and the role of women, in this campaign.

## **2. POPE FRANCIS' VISIT TO THE UNITED STATES**

The topic of this category was a discussion on Pope Francis' historic visit to the United States, including stops in Washington, D.C., New York City, and Philadelphia.

Topic: In this broadcast we previewed Pope Francis’ historic visit to the United States, including stops in Washington, D.C., New York City, and Philadelphia, at the end of September. We talked with two theology experts from Duquesne University about Pope Francis’ papacy. In our second segment, we learned, from two Carlow University students what they hope to experience, from their scheduled visit to Philadelphia, and attendance of the World Meeting of Families, the world’s largest gathering of Catholic families, which Pope Francis was scheduled to address.

### **3. SOUTH CAROLINA CHURCH SHOOTING**

Topics discussed in this category included a discussion on the tragic shootings at the Emanuele AME Church in Charleston, South Carolina, and a discussion on the symbolism of the Confederate Flag

Topic: The Church has often been called the center of African-American life and a sanctuary for peace in an often hostile world. But, on June 17<sup>th</sup>, during a bible study class at the Emanuele AME Church in Charleston, South Carolina, a man who published a website about race, including photos of himself posing with the Confederate flag, killed nine people, including the church’s beloved pastor and state senator, Rev. Clementa Pinckney, and wounded another in one of the deadliest shooting sprees in recent American history. Our guests, Rev. Rodrecus M. Johnson, Jr., Senior Pastor of St. James AME Church, East Liberty, who visited the South Carolina church after the tragedy as a sign of support for the congregation, and Todd E. Allen, Ph.D., Professor of Communications Studies at Grove City College, in Mercer County, Pennsylvania, who leads students on an annual tour of historic civil rights places in the South, appeared on this program to discuss this hate crime, and the impact of this incident on race relations in America.

Topic: The shooting spree in South Carolina this summer, and a resulting controversy surrounding the Confederate flag from the Civil War, and its use resulted in a historic reluctant vote by the state legislature in South Carolina to remove the Confederate flag from the state capitol. Our guests, experts on Civil War history, gave us special perspective on the significance of a country or party’s flag, in general and the special role of the Confederate flag in American history. So many years after the Civil War ended, serious political issues

about slavery, racism, and the Confederacy continue to divide those who live in the North and the South, symbolized by the flags of each side of the Civil War.

#### **4. U.S. SUPREME COURT RULING REGARDING SAME-SEX MARRIAGE**

The topic of this category was a discussion on the U.S. Supreme Court ruling that prevented states from banning same-sex marriage.

Topic: In June, The United States Supreme Court, in a historic, 5-4 ruling, (Obergefell Versus Hodges) changed the legal definition of marriage in America, preventing states from barring same-sex marriage, and ruled that same-sex couples should have the right to marry in all states, deciding that a ban on gay marriage violated the 14th Amendment of the United States Constitution. We discussed this ruling with co-plaintiffs in Pennsylvania's own, historic lawsuit, in Federal Court, Deb and Susan Whitewood, from Bridgeville, Pennsylvania (whose case in 2014 resulted in the striking down of a ban on same-sex marriages in Pennsylvania and allowed "already married same-sex couples" to be recognized, and eligible for certain government benefits) for reaction to the U.S. Supreme Court's decision. Also appearing on this broadcast, was their lead attorney, in the 2014 case, Vic Walczak, Legal Director of the Pennsylvania chapter of the ACLU – American Civil Liberties Union.

#### **5. U.S. AGREEMENT WITH IRAN REGARDING IRAN'S NUCLEAR WEAPONS**

The topic of this category was a discussion on the agreement between the United States and Iran regarding the development of Iranian nuclear weapons.

Topic: Pennsylvania Republican Congressman Mike Kelly, from the 3rd District (Butler), appeared on this broadcast to discuss a number of issues. He especially expressed outrage at the recent nuclear arms reduction agreement reached between U.S. negotiators, including Secretary of State John Kerry, and representatives of the Iranian government. The goal of this agreement is to stop development of Iran's nuclear program for the next ten years, and provide some right to inspect Iranian facilities to determine compliance. The deal would also lift billions of dollars in international sanctions against Iran, and Congressman Kelly announced his opposition to the deal, which was subject to approval by the U.S. House and Senate. Both houses voted to defeat the agreement, President Obama vetoed their action, and because the deal was not a formal treaty, Congress needed a two-thirds vote, from both houses, to override his veto, and failed in their attempt to do that.

## **6. ECONOMY**

Topics discussed in this category included a discussion on the economic problems in Greece, China's devaluation of the yuan, and a discussion on the wild economic swings on Wall Street during the last week of August, with record highs and lows, and plenty of uncertainty about the market's future.

Topic: Recent economic problems in Greece have had a dramatic impact on investor confidence in the stock market and investors' own savings. Our guests, Lou Stanasolovich, from Legend Financial Advisors and Emerging Wealth Management, and Robert Morris University Professor of Finance, Frank Flanegin, Ph.D., appeared on our broadcast to talk about both the causes of the financial unrest in Greece, and also whether investors should move some of their money out of foreign companies and into a more secure savings alternative.

Topic: The global markets, including Wall Street and American investors, shook when the Chinese government decided to lower the value of its currency (yuan). The intention was to make Chinese goods cheaper to export to America and to make it more difficult for countries like the United States to sell their own goods, including steel, abroad. PNC's Senior Vice-President and Senior Macroeconomist, Augustine "Gus" Faucher, Ph.D., returned to our program for perspective on the impact of this move, on our economy and investors, large and small.

Topic: Following the stock market, the week ending in August 30<sup>th</sup> was not for the faint of heart. A combination of concern over Chinese currency, uncertainty about interest rates, and lower-than-expected corporate earnings for some firms, resulted in huge swings of historic nature in the stock market. Stocks plunged by 1,000 points during the course of a trading session, yet, rebounded in another for the best rally since 2011. For some valuable perspective, we called upon Rick Applegate, Partner with Cantor Fitzgerald Wealth Partners, in Pittsburgh, financial analyst, and part of Newsradio 1020 KDKA's "Moneytalk" Report, on the KDKA Radio Morning News.

Topic: There were historic, wild economic swings on Wall Street, during the last week of August, with record highs and lows, and plenty of uncertainty about the market's future. The Dow Jones Industrials Average at one point plunged 531-points, but then several days later recovered with more than a 1,000 point gain, with much concern about the impact of China's decision lowering the value of its currency (yuan) to make its goods more competitive. Our guests, Senior Macroeconomist Augustine "Gus" Faucher, Ph.D., from PNC Financial Services Group, and Dennis Unkovic, an "International Transactional Attorney", Partner, with Pittsburgh's Meyer, Unkovic & Scott LLP, provided their valuable perspective on the factors affecting the stock market's volatility.

## **7. REGIONAL ECONOMIC DEVELOPMENT**

Topics discussed in this category included a discussion on Pittsburgh playing host to Super Bowl 57 in 2023, the importance of the film production industry to the regional economy, and a discussion on job growth in Pittsburgh.

We talked with Jason Fulvi, Executive Vice-President of VisitPittsburgh, about the decision-making and planning that would have to take place, to even make a competitive bid to bring the Super Bowl to the City of Champions.

Topic: The production of feature films in Pittsburgh, Southwestern Pennsylvania, and the Commonwealth of Pennsylvania, as a whole, has provided an increasing amount of employment for our area. The Pittsburgh Film Office commissioned a study by the Milken Institute's California Center, for specific economic data on this topic. Film Office Director Dawn M. Keezer and Kevin Klowden, Managing Economist for the Institute, appeared on our broadcast to talk about results of their study which come as the Pennsylvania legislature once again is embroiled in an impasse over funding the state budget, including the Pittsburgh Film Office and the film industry in Pennsylvania. The film industry is arguing for a five-year funding plan to boost production, and says it has lost films because of uncertainty over funding and reaching a limit on funding levels each year.

Topic: Amidst depressing economic news about the stock market, recent economic indicators are more encouraging, for the Pittsburgh employment picture. Doug Heuck, Program Director for "Pittsburgh Today", a non-profit, research organization at the University of Pittsburgh, and Editor & Publisher of "Pittsburgh Quarterly", returned to our

broadcast to discuss the details of his latest benchmark findings. Between July, 2014, and July, 2015, 32,800 jobs were added to the Pittsburgh workforce, almost a three percent increase over the average figure, and Pittsburgh's performance was better than cities like Detroit and Cleveland in the amount of economic growth.

## **8. EDUCATION**

Topics discussed in this category included a discussion on "The Pittsburgh Promise" having to scale back on funding, a discussion on how the state's budget impasse is affecting school districts, and a discussion with Pittsburgh's School Superintendent, Linda S. Lane, who announced she will not seek renewal of her contract.

Topic: Challenging economic times have forced "The Pittsburgh Promise" to scale back on the amount of dollars it can provide, for scholarships for qualified students who are residents of the City of Pittsburgh. The Executive Director of "The Pittsburgh Promise", Saleem Ghubril, returned to this broadcast for perspective on the accomplishments of the "Promise" and its graduates, and how limiting, to a certain degree, the maximum amount provided to each student, can insure the future financial solvency of the Fund. Since the "Promise" was announced, by Mayor Luke Ravenstahl and Pittsburgh Public Schools Superintendent Mark Roosevelt, with major funding from corporations like UPMC, more than 5,600 students who otherwise would never have been able to afford a college education have had their lives changed through "The Pittsburgh Promise" and have been able to attend more than 100-institutions for a college degree.

Topic: Pennsylvania's state budget impasse continues, with no end in sight, and the economic crunch is starting to affect school district in a large way. We talked with Linda Hippert, Ed.D., Executive Director of the Allegheny Intermediate Unit (AIU), about the implications of a prolonged crisis, which include the need for some school districts to borrow money, taking out loans in order to meet payroll. Dr. Hippert says that economically distressed districts will suffer the most from this problem.

Topic: On this broadcast, Pittsburgh's School Superintendent, Linda S. Lane, Ed. D., made the announcement that she will not seek renewal of her contract with the Pittsburgh school district when it expires in June. Dr. Lane discussed her decision, the state of the school district, and its finances. She also talked about a proposal, in the beginning stages, that would allow students from the financially-challenged Wilksburg School District to attend Westinghouse High School in nearby Homewood-Brushton next year, after that community's own high school closes.

## **9. DOWNTOWN PITTSBURGH RETAIL**

Topics discussed in this category included a discussion on the closing of Macy's Department Store in Downtown Pittsburgh, and a discussion with the Mayor of Pittsburgh regarding the store's closing and the future of Downtown retail.

Topic: Pittsburghers learned in July that Macys Incorporated had no "Miracle at Fifth and Smithfield", for its Downtown Pittsburgh customers when the company announced that rather than participate in a smaller department store, within a renovated Kaufmann's Department store building, soon to also house condominiums, it would leave the legendary structure, built for Macy's predecessor, Kaufmann's, and leave Downtown Pittsburgh completely. Our guests provided a wonderful perspective about this significant business and history story, including the disappearance of the last department store in Downtown Pittsburgh, which once played host to half a dozen of these establishments. There was special insight from Tom Windfelder, a man who spent 29-years as an executive with Macy's predecessor, Kaufmann's, at the Downtown store, and who compared the merchandising styles and successes and failures of Kaufmann's and Macy's, in Downtown Pittsburgh, and from Duquesne University's marketing expert, Dr. Audrey Guskey.

Topic: Pittsburgh's Mayor Bill Peduto joined Jon Delano, for his first interview on this broadcast since becoming mayor, and talked about the different elements of our local history, present, and future, that must all be respected and nurtured, for Pittsburgh to prosper. Part of the discussion centered on the future of Downtown retail, with the impending closing of the city's last Downtown department store, Macy's at Fifth & Smithfield, the former Kaufmann's. The mayor was reluctant to go into details about what kind of retail establishments could fill the void for workers and a growing number of Downtown residents who want to have a place to shop.

## **10. STATE GOVERNMENT**

The topic of this category was a discussion regarding criminal charges against Pennsylvania Attorney General Kathleen Kane.

Topic: Pennsylvania's Chief Law Enforcement Officer, (D) Attorney General Kathleen Kane, the first Democrat and first woman to be elected to that position, is fighting serious criminal charges that could land her in jail. Kane was indicted by a special state grand jury and was charged with obstruction of justice for allegedly releasing confidential information, and lying about it. Criminal charges were officially filed against Kane in August, by the Montgomery County District Attorney Risa Vetri Ferman, a Republican. We talked with



Pittsburgh defense attorney Phil DiLucente, and attorney James Burn, Junior, then-Chairman of the Pennsylvania State Democratic Committee, about the case. Burn suggested that Kane should step aside, at least temporarily from her position, while she defends herself against these charges.

## **11. DRUGS**

The topic of this category was a discussion on the growing problem of drug overdose deaths in Washington County, Pennsylvania.

Topic: Washington County, Pennsylvania became the latest community to struggle with an epidemic of drug overdose deaths. This segment included a report from KDKA-TV's Rick Dayton detailing the news of more than 200-overdose deaths since 2011. The latest weapon in the battle to save lives is training emergency responders in the use of NARCAN, also known as Naloxone, a medication used to reverse the effects of opioids, including heroin, in a drug overdose victim. Our guests, Washington County District Attorney Gene Vittone, and Janine Valko, a registered nurse, who is Director of the Emergency Department at Monongahela Valley Hospital, talked about how NARCAN is administered, can quickly reverse the effects of an overdose, and how medical and law enforcement personnel are being given instruction in using NARCAN on overdose victims.

## **12. 25<sup>th</sup> ANNIVERSARY OF THE AMERICANS WITH DISABILITIES ACT**

The topic of this category was a discussion regarding the 25<sup>th</sup> Anniversary of the Americans With Disabilities Act.

Topic: This program marked the commemoration of the 25th anniversary of the enactment of one of the most important pieces of federal civil rights legislation in American history, the Americans with Disabilities Act (ADA). Former Pennsylvania Governor Dick Thornburgh, who was United States Attorney General at the time this law was enacted, and signed by President George H. W. Bush, has special personal interest in this legislation, which, among other provisions, prohibits discrimination to those with disabilities in access to facilities, and employment opportunities. Our other guests, one in each segment, were a polio paraplegic, Judy Barricella, who recently retired as the coordinator for the Americans with Disabilities Act, in Allegheny County, and Josie Badger, Ph.D., a Duchenne Muscular Dystrophy patient, who serves as Co-Director of "RAISE", a technical assistance center that helps parents with children who have disabilities and health challenges, as well as Youth Director of the Peal Center, which helps families of children with disabilities and special health care needs.

### **13. CYBER TERRORISM**

The topic of this category was a discussion on the growing danger of cyber theft, computer hacking, and the theft of corporate secrets by foreign agents.

Topic: Western Pennsylvania's United States Attorney held a special presentation, at the end of September, about the growing danger of cyber theft, computer hacking, and the theft of corporate secrets by foreign agents, including the Chinese People's Liberation Army, as the newest form of terrorism. David J. Hickton appeared on this broadcast to describe the problem, to discuss how this kind of crime can be committed from abroad, what's being done by the U.S. government to prosecute foreign criminals, and what can be done to protect American businesses and consumers from this kind of crime. This subject sounds like it came out of a spy novel, but is a real and present danger to American national security. Pittsburgh with computer expertise at the Software Engineering Institute could be leading the battle to discover this illegal foreign activity.

Topic: This special edition of the "KD/PG Sunday Edition" paid tribute to Pittsburgh philanthropist and former Republican National Committeewoman Elsie Hillman, who died this month at the age of 89. Our guest, in the first segment was Grant Oliphant, President of the Heinz Endowments (former, high-level staff member to the late United States Senator from Pennsylvania, Republican John Heinz, whose career was nurtured and supported by Mrs. Hillman), who discussed Mrs. Hillman's critical role as a philanthropic backer of projects, from swimming pools in minority communities, to the creation of a cancer research center at the University of Pittsburgh, which bears her family's name. In our second segment, we talked with former Pennsylvania Auditor General, State Treasurer, and Allegheny County Commissioner, Barbara Hafer, who Elsie Hillman recruited (Hafer was a Democrat at the time), to change political registration, and run for political office as a Republican, and Dana M. Brown, Director of the Pennsylvania Center for Women, Politics, and Public Policy, and Associate Professor of Political Science, at Chatham University, about Elsie Hillman's support for women of all political parties, to become active, in the American political system.
