1. GOVERNOR WOLF

Topics discussed in this category included a discussion with state representative Mike Turzai about Democratic Governor Tom Wolf's recent inauguration, a discussion on a public opinion poll about the job performance of Pennsylvania Democratic Governor Tom Wolf, and a discussion on Governor Tom Wolf's state budget proposal.

Guest: Rep. Mike Turzai (R) - PA 28th Legislative District

Topic: We talked with Marshall Township's Republican state representative Mike Turzai, recently elected by the entire House membership as its Speaker, about Democratic Governor Tom Wolf's recent inauguration and what kind of relationship he is likely to have with a Republican-controlled state house and senate. Among the issues to be debated are taxes, spending, the state pension funding crisis, and the future of state-run liquor stores. Turzai believes that Wolf, at first glance, seems to have somewhat better personal skills with lawmakers than former Governor Tom Corbett, a Republican.

Our guest, Dr. Philip Harold, from Robert Morris University, discussed the results of a recent public opinion poll conducted by the university about the job performance of Pennsylvania Democratic Governor Tom Wolf, only in office since mid-January. As the governor prepared to unveil his first state budget to the General Assembly, the poll gave him a healthy 56.7% approval rating among Pennsylvanians. We talked with Dr. Harold about the results of the poll. In addition, Dr. Philip Harold was joined by Squirrel Hill State Representative Dan Frankel, from the 23rd Legislative District, who is also Chairman of the House Democratic Caucus, in Pennsylvania's General Assembly, and a member of the Rules committee. Both guests discussed expected elements of Governor Tom Wolf's budget proposal, and how they are likely to be viewed by both Republicans and Democrats. Taxes, whether to shift the emphasis from property to income, and a tax on Marcellus Shale drilling, are expected to be the center of the state budget battle.

Topic: Several weeks ago, Democratic state representative Dan Frankel, from the 23rd Legislative District (Squirrel Hill), appeared on this broadcast to talk about (D) Pennsylvania Governor Tom Wolf's state budget proposal. This week, Republican state representative John Maher, from the 40th Legislative District (Upper St. Clair), provided a different perspective about Wolf's proposal, potential changes in state taxes, and the economic future of the Commonwealth of Pennsylvania. Maher also supports the economic well-being of the gas drilling industry, which has provided additional jobs in this area.

2. INTERNATIONAL EVENTS

Topics discussed in this category included a discussion on the attack of the satirical Paris, France magazine/newspaper *Charlie Hebdo*, and a discussion on events in Russia as well as the state of American-Russian political relations.

Topic: The free world was shocked when masked gunmen stormed the offices of the satirical Paris, France magazine/newspaper *Charlie Hebdo* in January, killing twelve people, including its editor and its cartoonists. The Islamic terrorists, identifying themselves as members of Al Qaeda's branch in Yemen, were also believed to be responsible for an attack on a Paris kosher market and other locations. Our discussion centered on the appearance of signs and buttons, which said "Je suis Charlie" in support of the publication, support for the First Amendment in the United States, and freedom of speech in general, and the true importance of political cartoonists and satire as a form of free speech.

Topic: On February 27th, Boris Nemtsov, Russian Opposition Leader to Russian President Vladimir Putin, was shot multiple times and killed on his way back from a dinner engagement with his girlfriend in Moscow, within minutes of the Kremlin and Red Square. We talked about Putin's rule amidst economic challenges, perhaps a return to Cold War mentality, and the role of Russia in the war in Ukraine. We also talked about the state of American-Russian political relations.

3. INFRASTRUCTURE

Topics discussed in this category included a discussion on the deteriorating condition of many bridges in America and Pennsylvania, and a discussion on the cost of replacing aging water and waste infrastructure.

Topic: Our broadcast began with the discussion of the January 2015 partial collapse of a bridge near Cincinnati, Ohio, continued with a general discussion of the deteriorating condition of many bridges in America and Pennsylvania, including Western Pennsylvania, and plans to implode a bridge in the Greenfield neighborhood of Pittsburgh. Our guests agreed that although taxpayers will have to pay for the cost, a positive element is the creation of good-paying construction jobs to accomplish the task. Pennsylvania recently boosted its funding for transportation, and our guests talked about what areas might benefit from new money to repair or replace these aging, and increasingly dangerous structures.

Topic: Water is the sustenance of life, and Pittsburgh is blessed with three rivers. However, the future of water safety and quality is a challenge for the future because of the presence of bacteria, and crumbling infrastructure that carries water for drinking and other uses, and carries away raw sewage. Our guests talked about the cost of replacing aging infrastructure, and the cost of failing to do this work. Taxpayer rates for water and sewer services are likely to increase because of this challenge.

4. EDUCATION

Topics discussed in this category included a discussion on a grant that enables children from low-income families to participate in summer activities, and a discussion on how the City of Pittsburgh and the Pittsburgh School District, two different political and taxing entities, can work together more effectively to enhance the quality of education for Pittsburgh Public Schools' students.

Topic: Studies have shown that children's learning deteriorates during summer months when they are not in school if they don't have structured activities like summer camp. With the assistance of a \$1.5 million-dollar grant (from the Wallace Foundation, the Heinz Endowments, and the Grable Foundation (\$300,000 from Grable), the Pittsburgh Public Schools are preparing for a new session of the "Summer Dreamers" Academy in which 1,800 children from low-income families, from kindergarten through seventh grade, can combine study and fun sessions for five to six weeks. We talked with Pittsburgh Schools Superintendent Dr. Linda Lane and Gregg Behr, Executive Director of the Grable Foundation, about the necessity for such a program, and the good results for students, their families, and the community.

Topic: Pittsburgh Mayor Bill Peduto's Education Task Force recently released a list of recommendations on how the City of Pittsburgh and the Pittsburgh School District, two different political and taxing entities, can work together more effectively to enhance the quality of education for Pittsburgh Public Schools' students. Our guests, Pittsburgh School Superintendent Linda S. Lane, Ed.D., and Patrick Dowd, Inaugural Executive Director of the non-profit organization – Allies for Children, a child advocacy group, appeared on this broadcast to discuss the findings and recommendations of this task force. Both guests are also members of the task force.

5. VACINATIONS

The topic of this category was a discussion on the growing controversy over the failure, or refusal of some parents, to vaccinate their children against dangerous childhood diseases.

Topic: There is growing controversy over the failure, or refusal of some parents, to vaccinate their children against dangerous childhood diseases, including measles. Measles has seen a spike in incidence, since cases developed among children and adults who recently visited Disneyland Theme Park, in Orange County, California. Refusal sometimes stems from distrust of the government, or other political beliefs that oppose vaccination. We spoke with our medical guests, who also have great expertise in public health, about the consequences of this political stance, and whether laws should be changed in some areas to require all students to be vaccinated for admittance to public schools.

6. CYBER SECURITY

The topic of this category was a discussion on cyber security concerns, a growing area of the law that affects American citizens and national security.

Topic: United States Attorney David Hickton appeared on this broadcast to discuss cyber security concerns, a growing area of the law that affects American citizens and national security, and the subject of a recent conference at the White House. The discussion ranged from computer hacking by foreign terrorists or governments, like China and Russia, affecting major United States corporations and the personal data of citizens, to the role that the United States government plays, from the Software Engineering Institute in Pittsburgh, to the United States Justice Department, in prosecuting these cases. We also discussed precautions that citizens should take involving their computers to guard against hacking.

7. COMMUNITY DEVELOPMENT

Topics discussed in this category included discussions on development in Pittsburgh's Northside and Hazelwood neighborhoods; a discussion on a documentary film that chronicles Pittsburgh's pioneering efforts in urban renewal, a discussion on new development at Bakery Square, and a discussion on the opening of a new luxury hotel in Downtown Pittsburgh.

Our guests, attorney Mark Fatla, Executive Director of the Northside Leadership Conference, and Walt Nalducci, the organization's president, talked about a grant of \$900,000 from the Pittsburgh Steelers, Highmark, Incorporated, and Northwest Savings Bank to support community development efforts for Pittsburgh neighborhoods on the North Side. The corporations and the Northside Leadership Conference are working with Pennsylvania's Department of Community and Economic Development on projects like the restoration of the Allegheny Commons, that area's first park.

Since the mill has closed, many years ago, Hazelwood has been in a holding pattern, waiting for an economic boost. Pittsburgh City Councilman Corey O'Connor, who represents District #5, which includes Hazelwood, talked about development efforts.

Lawrence began an effort to rebuild the city of Pittsburgh, physically and symbolically, for future generations. Our guests included a representative of the Allegheny Conference on Community Development, marking its seventieth anniversary, and considered one of the driving forces behind smoke control, flood control, and urban renewal, Ken Zapinski, Filmmaker Michael Angelo DiLauro, and David Donahoe, retiring Executive Director of the Allegheny Regional Asset District, and grandson of the late Pittsburgh Mayor David L. Lawrence. This program examined Pittsburgh's past and present, and looked ahead at its future.

Inequalities remain, from educational opportunities and experience, to test scores, economic achievement, segregation, and poverty. Our guest, Dr. Larry Davis, Dean of the University of Pittsburgh's School of Social Work, appeared on this broadcast to discuss the most recent study's findings, and to talk about possible solutions.

9. ENERGY

Topics discussed in this category included a discussion on varying views about the impact of Marcellus Shale drilling in Southwestern Pennsylvania, and a discussion about a program that financially assists low-income people with paying their energy bills.

Topic: In this broadcast we attempted to present varying views about the impact of Marcellus Shale drilling in Southwestern Pennsylvania. In the first segment our guest was the president of the Marcellus Shale Coalition, David Spigelmyer, who has a long history of work in the energy industry, particularly natural gas. He discussed the economic benefits to this area, from the Marcellus Shale industry, and precautions taken to protect the public. In the second segment, our guests were Dr. Aimee Curtright, who is Senior Physical Scientist, Associate Research Department, and Director of Engineering and Applied Science, for RAND Corporation's Pittsburgh campus, who talked about the risks and advantages of Marcellus Shale Drilling, and Dr. John Stolz, the Director of the Center for Environmental Research and Education, at Duquesne University, who expressed concerns over the possible environmental impact of drilling on this area.

Our discussion included interest rates, creative financing, and what areas might be the most desired, right now for home sales and purchases.

Topic: In the first of two segments about the 2015 Pittsburgh International Show. which was held at the David L. Lawrence Convention Center, from February 13th through February 18th, we spoke with John Putzier, CEO of the Greater Pittsburgh Automobile Dealers Association, Christine Cuddy, Claims Manager for the Erie Insurance Group, and Bruce Coleman, Relationship Manager for Huntington Bank, about the state of the auto industry, which experienced lower sales, in the past few years, because of high interest rates, and the economic recession. Much of that has changed with an improvement in both the economy and interest rates, and general wear and tear on current cars owned, leading to the need for auto replacement. Our guests talked about an upswing in car sales, what was planned for the Auto Show, and what kinds of special offers might be expected, for visitors to the show. In this second segment about the Pittsburgh International Auto Show, we talked about the "Red Car-pet" Preview event, with proceeds going to the Pittsburgh Vintage Grand Prix Charities, the Autism Society of Western Pennsylvania, and the Allegheny Valley School. Both organizations are also beneficiaries of the Pittsburgh Vintage Grand Prix, and the Greater Pittsburgh Automobile Dealers Association. The Pittsburgh Vintage Grand Prix has created a corporate relationship, to help those organizations, and promote cars in this area.

Although the film tax credit was retained, failure to uncap it means that Pennsylvania is losing film production to more competitive states. Russ Streiner, best-known as producer of the legendary horror film "Night of the Living Dead" (1968) - produced in Pittsburgh, and Chairman of the Board of Directors of the Pittsburgh Film Office, joined us to discuss the film industry here, and its future.

We asked our guests about the future of a two-headquartered company, and what this merger could mean to employees, customers, and investors. Dr. Marcel Minutolo concentrated on the financial aspects of this proposed deal, while Dr. Audrey Guskey evaluated the impact on consumers and on product and marketing growth.

11. LOCAL POLITICS

The topic of this category was a discussion with Rich Fitzgerald, Allegheny County Executive, who announced his plans to seek re-election.

Fitzgerald addressed this issue (he returned the car), as well as many others.
