INSTRUCTIONS FOR PRE-FILING ANNOUNCEMENTS

Run one announcement per day on June 1, June 16, July 1, and July 16. At least two of the required announcements must be aired between the hours of 7 and 9 A.M. and/or 4 and 6 P.M. If the station does not operate between 7 and 9 A.M. and/or 4 and 6 P.M., then at least two of the required announcements must run during the first two hours of operation.

After the announcements have been run, complete the certification which immediately follows the text, and place the signed original in the station's public inspection file.

PRE-FILING ANNOUNCEMENT

On December 8, 2004, WGFA-FM was granted a license by the Federal Communications Commission to serve the public interest as a public trustee until December 1, 2012. Our license will expire on December 1, 2012. We must file an application for license renewal with the FCC on August 1, 2012. When filed, a copy of this application will be available for inspection during regular business hours. It will contain information concerning the station's performance over the last eight years.

Individuals who wish to advise the FCC of facts relating to our renewal application, and to whether this station has operated in the public interest, should file comments and petitions with the FCC by November 1, 2012.
