Judge Acts On Executive Action

The Brownsville federal judge presiding over a lawsuit filed against President Obama's immigration executive action says he will put on hold a ruling he issued last month ordering Justice Department attorneys to attend an ethics course. U.S. District Judge Andrew Hanen ordered the training for the attorneys for his belief they misled him about whether the Obama administration had begun implementing one of the proposed measures before he issued a preliminary injunction that halted them.

Supreme Court Split Upholds Judge's Injunction

The U.S. Supreme Court is upholding Brownsville federal judge Andrew Hanen's ruling that stops President Obama's immigration plan from going into effect. In a 4-4 split, the high court could not decide whether President Obama's executive actions on immigration are constitutional. Mr. Obama's action shielded millions of illegal immigrants from the threat of deportation. Texas and 25 other states argued that the President exceeded his authority and sued.
