**I, Tomás Figueroa, hereby declare under penalty of perjury that the following information is true and correct:**

1. I am the President of La Cadena Del Milagro, Inc. ("Licensee" or "La Cadena"), which is the licensee of full-power FM broadcast station WVSN(DT), Humacao, Puerto Rico (Facility ID No. 67190) (the "Station" or "WVSN"), which is a single station employment unit.
2. This Declaration is submitted in response to the April 24, 2023 letter of Elizabeth E.
