QUARTERLY ISSUES / PROGRAMS LIST 3rd QUARTER 2022

Attached are top issues of importance to our community as determined by ascertainment interviews conducted from October 1, 2021 – September 30, 2022. They all were broadcast during the period July 1 – September 30, 2022, on **Columbus Perspective** which aired on Sunday mornings from 6 am to 7 am on **WBNS-AM** (1460) and from 7 am to 8 am on **WBNS-FM** (97.1). Date, guest, segment length and brief subject matter are included.

The dates the programs aired are also listed on the logs.

Columbus Perspective for Sunday, July 3, 2022

Jill Gorz, Clinical Services Director at Star House, which helps homeless youth and young adults in Columbus. She talked about how those in need end up at Star House and the services available, which also includes affordable housing at a housing development owned by Star House on the west side of the city. She also talked about the prevalence of drug addiction among youth who are homeless and the stigmas they face, which serve as additional barriers to recovery.

Time: 22 minutes Issue: Housing/Homelessness

Shari and Cory Foltz, the parents of college student Stone Foltz, who died last year in a hazing incident at Bowling Green State University. They talked about their ongoing efforts to end the practice of hazing at fraternities and sororities. They also are suing the university as part of that effort.

Time: 4 minutes Issue: Crime/Safety

Franklin County Commissioner John O'Grady talks about how \$257 million in pandemic relief money is being used in Ohio and Franklin County, to help with housing for those behind on rent and to boost the number of people getting Covid vaccinations.

Time: 2 minutes Issue: Government

A report on whether the federal minimum wage of \$7.25 is enough to provide a livable wage and enough to pay rent for a one or two bedroom apartment. It isn't, falling more than \$500 short of the more than \$1800 average monthly rent nationally.

Time: 3 minutes Issue: Economy/Employment

Duane Casares, CEO of Directions for Youth and Families in Columbus, which provides counseling and therapy services, mostly for free, to low-income families in Columbus. He talked about a development his agency has started on the East side of Columbus to provide more focused services to an area in need. He also talked about the uptick in violence involving youth and young adults that most major cities, including Columbus, are seeing.

Columbus Perspective for Sunday, July 10, 2022

Rita Soronen, President and CEO of the Dave Thomas Foundation for Adoption, an agency that operates national and in Canada that started and is based in Columbus, which focuses on securing homes for older children in need of adoption.

Time: 22 minutes Issue: Youth/Families

A look at abortion laws in Ohio since the U.S. Supreme Court overturned Roe v Wade. Ohio has enacted the Heartbeat Law, which had been on hold until the Court's ruling - it bans abortions when a fetal heartbeat can be detected, which is often before a woman knows she is pregnant. Some city prosecutors in Ohio's major cities, including Columbus, say they will not enforce the law against women seeking abortions illegally. Christie Angel, President of the YWCA in Columbus, and Maureen Stapleton, Executive Director of CelebrateOne, discussed how they believe overturning of Roe v Wade harms

women. Mike Gonidakis, President of Ohio Right to Life, and Kellie Copeland, Executive Director of Pro Choice Ohio, also discussed the issue. Gonidakis says his organization supported expanded Medicaid in Ohio against the wishes of many Republicans, and feels it will be more necessary with abortions outlawed.

Time: 10 minutes Issue: Government

Columbus Mayor Andrew Ginther and City Prosecutor Zach Klein and Police Chief Elaine Bryant on efforts to curb gun violence in Columbus. Ginther wants more restrictive gun laws in Ohio, but instead are reducing training requirements, and passing permit less carry laws. Klein wants judges to withdraw bond for those suspected of crimes involving guns. Chief Bryant wants to put a focus on repeat gun offenders and better efforts to trace guns.

Time: 4 minutes Issue: Crime/Safety

Columbus Mayor Andrew Ginther discusses efforts to remove homeless camps in the city while promoting affordable housing. Homeless people in the city say evicting them from camps leaves them with nowhere to go. Ginther says removing them helps to promote efforts to place them in affordable, sensible housing.

Time: 3 minutes Issue: Housing/Homelessness

Kayla Griffin, the Ohio Director of All Voting is Local, discusses the August 2nd Primary Election, which is a continuation of the May Primary - delayed because of the redistricting problems Ohio is having. She says that because this is Part 2 of the May primary that will be held next month, it is confusing for people and comes at a time when voter turnout is likely to be very low.

Columbus Perspective for Sunday, July 17, 2022

Lee Anne Adams, Senior VP of National Initiatives for NeighborWorks America, discusses affordable housing and the anxiety that many Americans have about home-buying.

Time: 9 minutes Issue: Housing/Homelessness

Comments from President Joe Biden, speaking recently in Cleveland, talking about the economy and efforts to curb inflation, as well as signing legislation that bails out 200 about pension plans for millions of beneficiaries. Ohio U.S. Senator Sherrod Brown (D-Ohio) also talked about the importance of the policy.

Time: 4 minutes Issue: Economy/Employment

A look into the shooting of Jayland Walker, an Akron man who died after being shot more than 90 times by police following a car chase. Comments from Ohio Attorney General Dave Yost, Governor Mike DeWine and a member of Walker's family, as well as Congresswoman Joyce Beatty (D-Columbus).

Time: 4 minutes Issue: Crime/Safety

Lindsay Williams, Executive Director of the Ohio Children's Trust Fund, discusses efforts to reduce child abuse. She says the pandemic led to increases in the problem, as well as depression and mental health issues in general. She talked about support programs that are available through her agency, as well as the physical, emotional and behavioral signs of child abuse. This segment originally aired on 04/24/22.
Time: 19 minutes Issue: Youth/Families

Columbus Perspective for Sunday, July 24, 2022

Alicia Shoults, Assistant GM and Marketing & Public Relations Director of the Ohio State Fair, which begins Wednesday. She talked about the importance of having the fair back after a 2-year hiatus due to the pandemic and changes those visitors will see.
Time: 13 minutes Issue: Development

A look at the recent case of a 10-year-old Ohio girl who was allegedly raped, then went to Indiana to get an abortion because Ohio's 'heartbeat law' made it too restrictive to get the procedure done here. Ohio Attorney General Dave Yost, who was criticized for doubting the story which turned out to be true, defended his position, blaming the source of the original information being partisan and unreliable. He also says it is possible the girl would have been able to get the abortion in Ohio, depending on the circumstances.
Time: 3 minutes Issue: Crime/Safety

The new 988 Suicide & Crisis Hotline is operational. Dr. Craig Bryant - a clinical psychologist with Ohio State University, talked about the importance of the new hotline and how calls are handled.
Time: 3 minutes Issue: Youth/Families

A look at the case of Stephen Ayres, 39-year of Trumbull County man who was convicted of disorderly conduct for his role at the Jan. 6 insurrection at the U.S. Capitol. Ayres had testified before the Jan 6 committee and says he regrets his role and had explained to the committee how he got caught up in the rhetoric of the Presidential election having been stolen by the Democrats over Donald Trump, which he now says he no longer believes.
Time: 5 minutes Issue: Government

Donniella Winchell, Executive Director of the Ohio Wine Producers Association, which is holding its 27th Vintage Ohio Wine Festival in Kirtland (Lake County) on August 5th & 6th. She talked about the growing number of wineries in Ohio and their importance to the economy, and fears of the spotted lanternfly, which feeds on vineyards and has devastated grapes in parts of Pennsylvania.
Time: 17 minutes Issue: Economy/Employment

Columbus Perspective for Sunday, July 31, 2022

Amy Riegel, Executive Director of the Coalition on Homelessness and Housing in Ohio (COHHIO). She talked about ways her agency can help lower income people who are struggling with housing issues and discussed how the problem has grown since the pandemic, with escalating home values and rent prices.
Time: 25 minutes Issue: Housing/Homelessness

A look at testimony before the Jan 6 Congressional committee looking into the insurrection at the U.S. Capitol. Among those testifying, Sarah Matthews, former White House Deputy Press Secretary, a Northeast Ohio native (North Canton). She talked about how former President Donald Trump's inaction that day turned her against efforts to defend him.

Time: 3 minutes Issue: Government

A look at the Monkeypox outbreak in the U.S. Doctor Joseph Gastaldo, infectious disease specialist with OhioHealth, says there are a lot of misconceptions about the spread of the virus. He says it does not spread as aggressively as some viruses, such as Covid. He also talked about the supply of vaccine still not being to the amount they should be.

Time: 3 minutes Issue: Health/Healthcare

Columbus City Schools Superintendent Talisa Dixon. She talked about preparations for the new school year, about to begin. She says security has been increased, transportation policies improved for students using buses - including better training and pay for drivers - and the importance of efforts to boost math skills of students.

Pam Fischer with the Governors Highway Safety Association discusses efforts to decrease distracted driving. This segment originally aired on 04/17/22

Time: 14 minutes Issue: Transportation

Columbus Perspective for Sunday, August 7, 2022

Susan Choe, Executive Director of Ohio Legal Help (ohiolegalhelp.org). The free web site provides legal information and court forms, covering divorces, information about rental assistance / landlord issues, domestic violence / restraining orders, etc.

Time: 15 minutes Issue: Government

Ohio Lieutenant Governor Jon Husted. He discussed the Intel project to build computer chip-making factories being developed in New Albany. Husted says all the pieces are in place for intel to expand its plans beyond its Phase 1 plan. He says more incentives are likely to be offered to the company if it continues to expand.

Time: 4 minutes Issue: Development

Jeff Jevnikar. As a student, he fired two shots inside South High School in Willoughby, Ohio in 2008. He describes his thoughts and motives for that day. He has since finished high school and received counseling. He says media attention from previous school shootings incentivized him. But he also says he believes his situation was different than some of the deadly, high-profile shootings. He did not kill anyone - he hit the ceiling and a trophy case, then pointed the gun at himself until he was talked out of it. He says he hopes that sharing his perspective will discourage others from going down that direction.

Time: 7 minutes Issue: Crime/Safety

David Miran, Chief of Division of Amusement Rides & Safety, Department of Agriculture. He talked about "Tyler's Law" now being in effect as the Ohio State Fair returns, following a two-year hiatus due to the

pandemic. The Law creates more oversight for ride safety at Ohio fairs, carnivals and amusement parks - named after Tyler Jarrell, an 18-year-old killed when a ride broke apart at the Ohio State fair in 2017.

Time: 3 minutes Issue: Crime/Safety

Lisa Hamler-Fugitt, Executive Director of the Ohio Association of Foodbanks. She talked about the problems food banks are encountering with supply shortages and inflation - they are running low on food supplies while demand is increasing, and she is calling for more funding from the state and federal governments.

Time: 17 minutes Issue: Hunger

Columbus Perspective for Sunday, August 14, 2022

Stephanie Hightower, President and CEO of the Columbus Urban League. She talked about projects the Urban League is involved in - including its involvement in The Lonely Entrepreneur (TLE), a New York-based non-profit that provides individuals with entrepreneurial skills and support, which has partnered with One Columbus and other Columbus organizations to empower 10,000 Black entrepreneurs throughout the Columbus Region. The Urban League will be targeting the recipients of that support. She also talked about the recent gift of \$4 million received from the estate of former Columbus Fair Auto Auction owner Alexis Jacobs.

Time: 16 minutes Issue: Economy/Employment

Dr. Matthew Bauer, an infectious disease specialist with Equitas Health, discusses monkeypox. He talked about who is at risk, how it spreads and how college campuses should be preparing as schools resume.

Time: 7 minutes Issue: Health/Healthcare

Ohio Secretary of State Frank LaRose. He talked about the Primary election that just wrapped up - it was part 2 of the primary - delayed by a redistricting problem the state encountered with re-drawing maps. LaRose is on the committee and implied that the Ohio Supreme Court was to blame for rejecting the maps, which were approved by majority Republicans, including LaRose.

Time: 3 minutes Issue: Government

Nan Whaley, Democratic candidate for Governor, and incumbent Republican Mike DeWine, speaking separately, discuss issues important to the campaign, including abortion and gun safety.

Time: 3 minutes Issue: Government

Dr. Douglas Scharre, Director of the Center for Cognitive and Memory Disorders at Ohio State University, relays information about a clinical trial at OSU for people with mild memory loss.

Time: 12 minutes Issue: Health/Healthcare

Columbus Perspective for Sunday, August 21, 2022

Sue Woerkom, President of Columbus REALTORS, talks about the local housing market. She says home values have skyrocketed and the amount of time homes are on the market before being purchased has

grown by a few days but is still not long. Mortgage rates have nearly doubled in recent months, complicating the affordable housing problem. She offered advice for first-time home buyers and sellers.

Time: 16 minutes Issue: Housing/Homelessness

Lisa Hamilton, President and CEO of the Annie E. Casey Foundation, discusses their latest report on the health of kids in the U.S. and policies that improve it.

Time: 7 minutes Issue: Youth/Families

John Berry, President of the Central Ohio Technical College. He says he expects a flood of engineering students in the coming years - the number is up 69% over the past year - he says it is partly due to Intel's plans for a multi-billion-dollar computer chip-making operation, to be completed in New Albany in 2025.

Time: 3 minutes Issue: Economy/Employment

A look at whether the 'Inflation Reduction Act' - passed by Democrats in Washington, will increase the cost to run the Medicare program, as claimed in political ads opposing the legislation. The Congressional Budget Office disputes this, saying it will reduce spending by \$300 billion over the next 9 years. Medicare.

Time: 3 minutes Issue: Health/Healthcare

Danielle Robinson, widow of Sgt. 1st Class Heath Robinson of Pickerington, who died of cancer after being exposed to burn pits in Iraq. She talked about passage of the PACT Act - signed into law by President Biden, which opens medical care for other veterans affected similarly.

Time: 3 minutes Issue: Health/Healthcare

Dr. Albert Rizzo, Chief Medical Officer for the American Lung Association, discusses vaping and kids, and a new public service campaign to provide education on the issue.

Time: 8 minutes Issue: Substance Abuse

Columbus Perspective for Sunday, August 28, 2022

Jessica McIntyre, an Ohio State Highway Patrol trooper and recruiter. She says the Patrol needs more troopers and talked about the requirements, as well as the training academy, where recruits live and are paid while in training. She also talked about the difficulties of the job, especially in the wake of negative reputations that police have developed with some due to recent high-profile incidents in Ohio and around the country.

Time: 16 minutes Issue: Government

Whitehall Mayor Kim Maggard and Governor Mike DeWine talk about money the state is providing for police departments to improve safety - whether through hiring officers or through other means. More than 100 police departments around the state are receiving a total of \$100 million. Whitehall is receiving \$634,000 - and using much of it to upgrade equipment, including to its outdate 911 phone system, so it can respond quicker to emergencies.

Time: 3 minutes Issue: Crime/Safety

Ohio Auditor Keith Faber talks about Ohio's College Credit Plus program, which allows students to obtain college credits while in high school. Last year the program awarded more than 8,000 associate degrees to high school students. Faber wants to see the program expanded and utilized more.

Time: 3 minutes Issue: Education

Dr. Megan Schabbing, System Medical Director for OhioHealth. She talked about the role social media can play in sending kids into depression and suffering from issues of self-esteem. She applauds recent high-profile cases of celebrities publicly stepping away from social media, especially those who cite their mental health for the reason and hopes more youth see that as a positive step for themselves.

Time: 3 minutes Issue: Youth/Families

Bruce Jones, Administrative Coordinator of the Gambling Intervention Program at Maryhaven. He talked about how a gambling addiction can create havoc in the lives of people and their loved ones, and how it is often someone who has a drug addiction as well. He also talked about preparations being made for the expected increase in gambling addicts when sports gambling begins in Ohio in January. This segment originally aired on 05/15/22

Time: 17 minutes Issue: Substance Abuse

Columbus Perspective for Sunday, September 4, 2022

Dara Lieberman, Director of Government Relations at Trust for America's Health, discusses public health preparedness. She says Ohio was one of three states that has increased funding for public health since their last report. She says the state relaxed license requirements that allowed visiting nurses from out-of-state to work in Ohio during an emergency, such as the pandemic, and increased public health funding by 20%. But she says overall, public funding is underfunded around the country, leaving Americans vulnerable to another pandemic. She says politics has eroded trust in public health in unfortunate ways. This segment also aired on 06/12/22

Time: 7 minutes Issue: Health/Healthcare

A report on the continuing problem of drug overdose deaths in Franklin County. The report includes comments from the father of an Ohio State University student who died of a fentanyl overdose earlier this year, and the parents of another young person in the county who died. The segment also included information about Ohio's new Recovery in Reach program, which will help financial advisors in Ohio to spot signs of substance misuse in their clients, in hopes of getting help earlier to people who are falling into the situation.

Time: 4 minutes Issue: Substance Abuse

Comments from President Joe Biden about his student loan forgiveness program, along with comments from students on the Ohio State University campus on how it will help them. As well as information on how the program will work and how people wanting to be in it can do so.

Time: 4 minutes Issue: Education

Dr. Ameena Kemavor, Vice President, Advocacy and Engagement with the ADAMH Board of Franklin County. She talked about signs of mental health issues among youth, what parents should do to intervene, including not being judgmental and to apply any stigmas associated with substance misuse.

Time: 4 minutes Issue: Substance Abuse

Jill Gorz, Clinical Services Director at Star House, which helps homeless youth and young adults in Columbus. She talked about how those in need end up at Star House and the services available, which also includes affordable housing at a housing development owned by Star House on the west side of the city. She also talked about the prevalence of drug addiction among youth who are homeless and the stigmas they face, which serve as additional barriers to recovery. This segment originally aired on 07/03/22.

Time: 22 minutes Issue: Housing/Homelessness

Columbus Perspective for Sunday, September 11, 2022

Portions of the ceremonial groundbreaking of Intel's multi-billion-dollar semi-conductor plant being built in New Albany. The project will generate thousands of jobs, including construction jobs to build it, then to run it when it opens in 2025. Comments about the economic opportunities for Ohio and the importance of expanding the making of computer chips in America are made from Governor Mike DeWine, Ohio's U.S. Senators, Rob Portman and Sherrod Brown, Intel's CEO Patrick Gelsinger, and President Joe Biden.

Time: 13 minutes Issue: Economy/Employment

A segment about the water that will be used by Intel, once their semi-conductor operation is up and running in New Albany. Linda Quian with intel says the plants will use 5 million gallons per day - water that will be supplied by the city of Columbus. She talked about how water is recycled at other Intel operations, which will also be done here. That water will be returned to the city of Columbus and treated again, then be usable by the city, although not for drinking purposes.

Time: 4 minutes Issue: Environment

Comments from Ohio's two candidates for U.S. Senate: Republican J.D. Vance and Democrat Tim Ryan. They discussed the Intel development in Central Ohio; President Biden's plan to forgive some student loans for those in debt; and on the FBI's raiding of Mar-A-Lago and whether the agency is out of line.

Time: 4 minutes Issue: Government

Columbus Mayor Andrew Ginther talks about a \$2 million grant the city is getting through 2025 to educate 8,000 residents on keeping their homes financially secured and to help seniors age in place.

Time: 2 minutes Issue: Housing/ Homelessness

Dr. Robert Ang, President and CEO of Vor Bio, which is involved in a clinical trial in Ohio for patients suffering from Acute Myeloid Leukemia (AML). The trial is being held at University Hospitals in Cleveland. Dr. Ang explained how the drug procedure being tested works in association with bone marrow transplants. He also talked about the disease itself and who is eligible for the trial and how to enroll.

Time: 9 minutes Issue: Health/Healthcare

Comments during a news conference from Dr. Bruce Vanderhoff, Director of the Ohio Department of Health, in which he provides an update on the coronavirus in Ohio and the new boosters that are now available.

Time: 8 minutes Issue: Health/Healthcare

Columbus Perspective for Sunday, September 18, 2022

Van Pichler, National Policy Advisor for the U.S. Department of Agriculture, discusses invasive species in Ohio. This included discussions of the emerald ash borer, the Asian longhorn beetle, and spotted lanternfly. This segment originally aired on 04/24/22

Time: 9 minutes Issue: Environment

Comments from President Joe Biden made earlier this month in New Albany during Intel's groundbreaking of its \$20-billion semi-conductor plants, which includes 7,000 construction jobs to get it up and running.

Time: 3 minutes Issue: Economy/Employment

Ohio Senator Jay Hottinger (R-Newark), whose district includes the site of Intel's development. He acknowledged concerns that residents have about the changes coming to their area, with development of new highways and increases traffic. Hottinger says he has visited other intel developments in the U.S. and says he is confident that they will be 'good neighbors' - he says the industrial park where Intel is building already has a lot of high-tech industries that are blending in well with the community. T

Time: 5 minutes Issue: Environment

John Kulewicz, Upper Arlington City Councilman, discusses legislation passed in his city that protects election workers from harassment, creating a misdemeanor requiring no less than three days in jail for harassing a poll worker. The ordinance clearly defines what constitutes harassment. He says elections have become more contentious and there are likely to be some controversial (abortion-related) and generally close races in the near future.

Time: 3 minutes Issue: Government

John Scheu, superintendent of Benjamin Local Schools near Bellefontaine. The district is looking to allow staff members to be armed, now that the state has passed a law that reduces the amount of required training to do so. Scheu says he simply wants to keep students safe and that his district is rural, cannot afford a lot of on-site security, and is 15 minutes from the Sheriff's office. He says 22 staff (including teachers, custodians and others) have expressed an interest in taking training courses once they are formulated and become available.

Time: 4 minutes Issue: Crime/Safety

Rita Soronen, President and CEO of the Dave Thomas Foundation for Adoption, an agency that operates national and in Canada that started and is based in Columbus, which focuses on securing homes for older children in need of adoption. This segment originally aired on 07/10/22

Time: 22 minutes Issue: Housing/Homelessness

Columbus Perspective for Tuesday, September 25, 2022

Scott Anderson, Problem Gambling Specialist with the Ohio Department of Mental Health and Addiction Services. He says gambling addiction is among the larger factors for suicide. He talked about the symptoms and problems that such people find themselves in. He also talked about the coming legalization of sports betting in Ohio and his concerns about that.

Time: 21 minutes Issue: Health/Healthcare

Ohio's Heartbeat Law, banning abortion when a fetal heartbeat can be detected, is on hold because of a restraining order issued by a judge in Hamilton County. Comments were included from Mark Herrington, President of Created Equal, a Pro-Life organization in Columbus, Kellie Copeland, President of Pro Choice Ohio, Elizabeth Whitmarsh with Ohio Right to Life, and U.S. Senator Sherrod Brown (D-Ohio).

Time: 4 minutes Issue: Government

Worthington Police Chief Robert Ware and Gahanna Police Chief Jeff Spence. They discussed the staffing shortage they are experiencing and the difficulties in hiring new officers, as well as the strain being put on existing officers.

Time: 3 minutes Issue: Economy/Employment

Comments from Ohio Supreme Court Chief Justice Maureen O'Connor during her annual (and final, due to impending retirement) State of the Judiciary Address. She talked about the problem of gerrymandering in Ohio and the need to create a new, truly independent and non-partisan committee. O'Connor recently sided with Democrats on the High Court to declare newly drawn state and congressional maps in Ohio unconstitutional - they were drawn up by Republicans, who serve as the majority on the Ohio Redistricting Commission.

Time: 3 minutes Issue: Government

Dr. Daniel Stover, an oncologist with the James cancer Hospital at Ohio State University, discusses ways the James is working toward President Joe Biden's goal of reducing cancer deaths by half within 25 years. Stover talked about new developments in 'liquid biopsies' being developed there that can lead to earlier diagnosis and greater cure rates. Biden visited and spoke to employees at the James Cancer Hospital last year.

Time: 3 minutes Issue: Health/Healthcare

Matt MacLaren, Director of Ohio-Find it Here, discusses fall activities to take part in around Ohio. He also talked about the summer travel and tourism season in Ohio, saying it had record activity and that businesses are rebounding well from the Pandemic. He says the one area still in need of improvement is business-related conferences - its slow return is hampering businesses air travel as well as downtown hotels and convention centers and the businesses, such as restaurant around them.
