### DECLARATION OF JARED STEHNEY, Market Manager

- I, Jared Stehney, hereby declare as follows:
- 1. I am a Market Manager for Capstar TX Limited Partnership, the licensee of Station WSGF(AM), which is part of a station employment unit based in Augusta, Georgia and which includes WKSP(FM), WIBL(FM), WEKL(FM), WBBQ-FM, WPRW-FM, and WYNF(AM) (the "SEU"). The stations in this SEU are commonly owned through subsidiaries ultimately owned and controlled by Clear Channel Communications, Inc. (collectively, "Clear Channel"). This Statement and relevant attachments are being submitted in response to the August 11, 2009 letter of Lewis C. Pulley, Assistant Chief of the Policy Division of the Commission's Media Bureau, concerning a random audit of the SEU's EEO compliance (the "EEO Audit Letter").
- 2. This SEU employs more than five full-time employees as the term is defined in the Commission's broadcast EEO rule, 47 C.F.R. § 73.2080(e)(1).
- 3. In response to Question 3(a) of the EEO Audit Letter, copies of the SEU's two most recent EEO public file reports, as described in 47 C.F.R. § 73.2080(c)(6), are appended at Attachment A. The web addresses of the stations in this SEU are as follows: <a href="http://www.eagle102.com/">http://www.eagle102.com/</a>, <a href="http://www.eagle102.com/">htt
- 4. In response to Question 3(b) of the EEO Audit Letter, documentation concerning the recruitment sources used to fill each full-time position during the period covered by the above EEO public file reports is also appended at Attachment B. Those sources that have notified the SEU that they want to be alerted to job openings at the unit, as described in § 73.2080(c) (1) (ii), are indicated in the job-specific documentation.
- 5. In response to Question 3(c) of the EEO Audit Letter, the internal business records appended at Attachment B provide data concerning (a) the total number of interviewees for each vacancy and (b) the referral source for each interviewee for each particular full-time vacancy filled during the period covered by the above EEO public file reports.
- 6. In response to Question 3(d) of the EEO Audit Letter, documentation concerning the unit's performance of recruitment initiatives described in § 73.2080(c)(2) during this time period is appended at Attachment C. Station personnel involved in the recruitment initiatives are noted in the documentation. This SEU employs a total of 24 full-time employees and at least one of our stations is located in a market with a population of more than 250,000. Accordingly, the SEU is required to perform at least four recruitment initiatives during a two-year period.
- 7. In response to Question 3(e) of the EEO Audit Letter, the licensee affirms that it is not aware of any discrimination complaints filed against the licensee of the stations in this SEU during the current license term.

8. In response to Question 3(f) of the EEO Audit Letter, the licensee affirms that Clear Channel has created and deployed an EEO compliance plan, with the assistance of outside communications counsel, known as the Clear Channel Broadcast Diversity Recruitment Plan (the "Recruitment Plan"). The Recruitment Plan has been distributed to all regional managers and, through them, disseminated to each SEU in conjunction with the effective date of the current EEO regulations. The Recruitment Plan is also posted on Clear Channel's intranet, which is accessible to all Clear Channel employees, as are instructional compliance checklists. The Plan contains directives as to how Clear Channel SEUs are to engage in broad recruitment for job vacancies and undertake recruitment initiatives, includes sample forms for collecting and maintaining the necessary recruitment data, and provides a quarterly self-assessment program designed to ensure that the SEU follows the Plan's directions and regularly updates corporate headquarters as to the employment unit's progress in the area.

At the corporate level, Clear Channel assists SEUs in understanding and following the Recruitment Plan, regularly providing training via conference calls, responding to SEU requests for assistance and/or calling upon outside counsel for additional guidance when warranted. Furthermore, Clear Channel has a team of internal public inspection file auditors that routinely assesses each SEU's FCC EEO compliance, based on the most recent EEO Public File Report, as part of a quarterly review of overall public file compliance.

At the local level, after ending our use of EEO1, this SEU reached out to the community to develop and create its own recruitment source list. We continue to use these sources and are constantly adding additional sources to the list. We also offer internship opportunities through our Internship Program, reaching out to college-age students in our community and sparking their interest in careers in the radio industry. Ultimate oversight of this SEU's EEO compliance efforts are the responsibility of our Market Manager, Jared Stehney. A second layer of oversight exists through our Market Controller, Faith Bragg, and our outside EEO Compliance Specialist, Peter Fulton. Our Administrative Assistant, Cynthia Robinson, coordinates the day-to-day efforts, such as notifying recruitment sources of job openings and maintaining documentation. This SEU's compliance efforts include identifying Clear Channel's efforts to afford equal employment opportunities to employees through statements disseminated in job applications and posted in conspicuous areas within the workplace.

9. In response to Question 3(g) of the EEO Audit Letter, the licensee affirms that the SEU understands that it must periodically analyze the effectiveness of its EEO recruitment program by reviewing the productivity of sources on its recruitment list and the outcome of its recruitment initiatives. The company's Recruitment Plan, through the quarterly self-assessment mechanism, provides SEUs with a regular opportunity to consult the corporate headquarters about these issues. To boost the effectiveness of outreach efforts on an ongoing basis, the Recruitment Plan also provides language for station websites, on-air announcements and/or formal letters encouraging qualified community organizations to contact the SEU to request its job notices. This SEU consults the corporate headquarters about these issues and continually engages in self-assessment of its recruitment sources and efforts. This SEU also encourages all staff members to inform our Administrative Assistant about any groups and organizations that may refer qualified applicants to the stations for openings as they become available, especially staff in the programming, promotions, sales and news/public affairs departments who interact with the community directly. Through the SEU's outside EEO Compliance Specialist, the SEU learns of

groups and organizations utilized in other markets successfully for recruiting purposes. In addition, management consults with the community leaders who are members of the SEU's Community Advisory Board to identify referral sources. When identified, sources are contacted to secure information about where and by what means to send Employment Notices for openings at the stations. From time to time, existing sources are also asked to identify organizations that may serve as referral sources. The SEU also interacts with representatives of sources regarding the job categories at the radio stations so that our sources may more effectively refer candidates for those openings. In the past, the SEU has used the EEO1 service, which would send out our job postings to its sources to recruit for our vacancies. The SEU has since stopped using EEO1. When we ended our arrangement with EEO1, we started from scratch in building our own source and distribution list. The SEU stations sent out letters to various local sources, and those sources that responded to our letters are listed as entitled.

10. In response to Question 3(h) of the EEO Audit Letter, this SEU strives to comply with all federal, state and/or local laws regarding pay, benefits, seniority practices, promotions, and selection techniques and tests to ensure that the unit provides equal opportunity and does not discriminate against employees or applicants. This SEU's employment practices are the ultimate responsibility of the unit's Market Manger, Jared Stehney, working in conjunction with in-house counsel at Clear Channel corporate headquarters and, when applicable, outside employment and labor counsel.


