We are providing this notice in connection with the requirements codified in 47 C.F.R. 76.64(k) that any multichannel video programming distributor commencing new operations via cable system(s) in the Television Market(s) listed below provided notice of our intention to commence services, and your requirement to make an election (or confirm your election) between retransmission consent and must-carry status pursuant to 47 C.F.R. 76.64(f). All terms used herein but not defined herein shall have the meanings given to such terms by the Federal Communications Commission.

Pursuant to 47 C.F.R. 76.57(f), stations that do not timely respond are treated as must-carry stations.
