Re: Must Carry Request for WMEI-TV, Arecibo, Puerto Rico

Dear Sir/Madam:

CMCG Puerto Rico License LLC ("CMCGPR"), licensee of commercial television station WMEI (TV) ("WMEI"), Arecibo, Puerto Rico, I, hereby gives notice to DirecTV that pursuant to Section 325(b)(3)(B) of the Communications Act and Section 76.64(f)(2) of the FCC's Rules, CMCG Puerto Rico License LLC elects to assert its right to must-carry status, under Section 325(b)(1)(A) of the 1992 Act and Section 76.64(a) of the FCC's rules, to have the broadcast signal of WMEI carried on your satellite system in our defined market<sup>2</sup>. This election of must-carry is for the period January 1, 2009 through December 31, 2011.

The following information is provided in compliance with Section 76.66(d)(iii) of the FCC's rules:

<sup>&</sup>lt;sup>1</sup> WMEI initially signed on the air as a new commercial television station on September 17, 2006. The FCC, however, dismissed WMEI's license application and allowed the underlying construction permit to lapse. On October 31, 2006 the FCC reinstated WMEI's construction permit. WMEI subsequently re-initiated over-the-air broadcasting, and CMCGPR filed a new license application for WMEI on November 29, 2006. The FCC granted the license application on August 3, 2007.

<sup>&</sup>lt;sup>2</sup> Puerto Rico is considered a single television market for must-carry purposes pursuant to 47 C.F.R. § 76.55(e). WMEI, therefore, is a local commercial television station, and entitled to must-carry status, on each system operating in Puerto Rico.
